Well, it has happened again, at the last minute, they decide not to fulfill the appointment. The next in line is asked to take his place, and I feel this is very unfair to the members and the other judges. I had been looking forward very much to exhibiting at this show along with my partner R. K. Brown who has been very good and kind to me the past few years - working with my stock and driving to most of the shows with me and actually running the rabbitry. He is a hard worker, a good showman and above all a good sport. When I was asked by our president if I would be willing to judge the show, I told him I would leave it up to Mr. Brown as I knew how much he was looking forward to exhibiting our own rabbits. Knowing how I feel about the A.D.R.C., he said, go ahead and accept the appointment, my wife and I will still drive out to the show with you. This will make every show with the exception of one that I have attended since its reorganization, Detroit 1934. I feel it is a real honor to be nominated to judge either of these two shows. I urge that in the future elections that judges turn down the nomination if they feel there is the possibility they will not be able to fulfill the appointment.

There is a very interesting point about the election of our new secretary - This is the first time the Dutch Club has had the PEOPLES CHOICE as secretary, all others have been appointed to the office in their first term by the board of directors. On reorganization, our first secretary Mat Welling was appointed, after him came R. L. Souress, then Mrs. Neubauer, followed by Madeline Grables, then Mrs. Weinhardt and now Doris Leibel. This is a very hard position to fill and I hope that the membership has made a wise selection and give her their all out cooperation so that she will be a credit to our club, and always work towards its success!

I had been informed that apparently too much space was being wasted, however if you will note the over all effect, we still are only getting two and occasionally three on a page and readability has been lost. Readability was one of the "big" deals when I first took over the D.R. Many members wrote in on this topic and that is why I am so conscious of it.

I had hoped to hear from some of you "old timers" that you didn't want ribbons, but no luck...

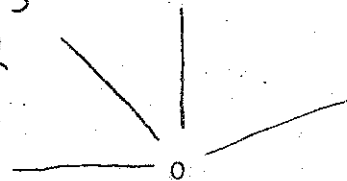
As I see it, financely speaking we are going in the hole. Mrs. Weinhardt turned over a check for \$600.00, but the earmarked funds against it totaled \$496.17. The cost of the trip to Manchester to pick up the records was \$80.00 (Gas, \$52.02. Tolls \$8.10 and trailer rental, \$19.88) went a total of 1,391 miles. Basicly a total of \$23.83 general fund was turned over. D.R. expenses have been heavy but am re-stocked now on supplies and the rate they are used depends on the size of the D.R.

I will be taking the trophies to Maryland with me and will be sending those to the West Coast winners about that time. SHAME SHAME ON ME!

'71-'72 ADRC Director

I have non-chalantly been letting the American Dutch Rabbit Club fall into a state of complete financial embarrassment. Too many years I have felt it sufficient to merely pay my membership dues or make an occasional support to advertising or pay for a sweep-stake show sanction and paying little or no attention to the financial struggles of the American Dutch Rabbit Club.

Per Doris's letter to the Directors on her return from Manchester Michigan it is very obvious that we must come up with some financial solution.

For Shame we ask Doris Leibel to be our Secretary-Treasurer without first penalizing her. To begin with, we have no money to reimburse her for the accrued expenses of this trip. She indicates actual outlay of \$79.85 but as sure as the good Lord made little green applies, she spent more than that; also there is this item of car expense and/or depreciation. I would hate to be requested to latch on to a trailer and haul across country for anything less than 15¢ per mile.

After several days of soul searching, I can only conclude that we must pay her back and the sooner the better. I think this should be done by cracking down on the membership; after all this club does not only belong to the officers, but to an excess of 550 members.

Initially on a quick money raising program we could perhaps start a buck a month booster membership system that would have some fringe benefits. The rules could be simple; it would be voluntary with members having choice to pay retroactive up to five years or initiate their boostership with the present. Five year paid boostership would have special privileges for the booster; such as one-half rate advertising benefits in the Dutch Reporter and/or the Dutch Guide book for the remainder of the boosters life. Also buck a month boosters having advance paid for a total of one year, the booster would have such recognition in the Dutch Reporter. Further a five year paid booster would be listed as a life booster. Life boosters would be listed in the guide book. Sixty dollars would be the maximum a buck a month booster would pay to gain this special recognition and added privilege. So much for what we might offer to the voluntary supporter.

On the compulsory side, we must rake the entire membership. We all realize the existing three dollar per annum dues is much to little to meet the cost of adequately operating our club. Repeatedly we must function as though we are garbage pickers, when in reality

the Dutch is a first class breed of rabbits; we that keep them should represent them in kind. It is my opinion that our dues must be raised to either \$5.00 or \$6.00 per Annum. Such membership boost would help the general fund between \$450.00 and \$600.00 per year. Naturally it would strengthen our show fund and assist our publicity and secretarial outlay. To say the least, alot of help is needed in all these departments.

In my carful consideration of both of these proposals, I tried to be mindful of the fact that this should not be a short lived undertaking. I am confident that after you will have studied them a little there won't be any doubt that we must adopt something of this sort soon.

Did you realize that less than 8% of our membership advertised in our last guide book? The last Dutch Reporter has only about 4% in support. We are approximately a 96% non-supporting membership.

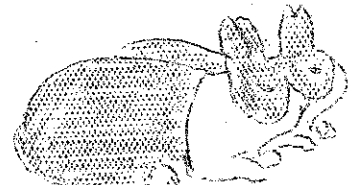
