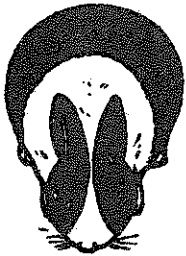
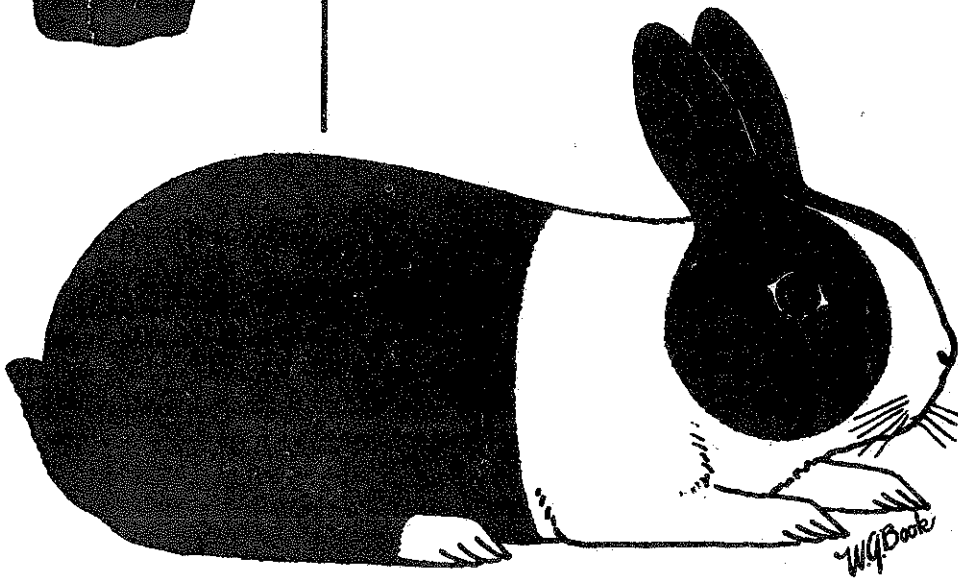

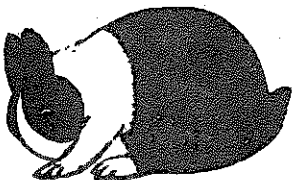

REVISED CONSTITUTION  
AMERICAN DUTCH RABBIT CLUB  
Effective March 19, 1962

ARTICLE I - NAME: The name of this Club shall be the AMERICAN DUTCH RABBIT CLUB.

ARTICLE II - OBJECT: The object of this Club shall be to promote, encourage, and improve the breeding of Dutch rabbits by maintaining an organization to study standards, encourage exhibitions, and offer service to its members.

ARTICLE III - AFFILIATION: This Club shall be affiliated with the American Rabbit Breeders Association, Inc.

ARTICLE IV - MEMBERSHIP: Any person of good character and reputation and in accord with the object may become a member of the Club upon presentation of a signed application together with membership fee for at least one year to the Secretary-Treasurer. Term of membership to be one year from date on membership application, providing application is received within five (5) days of this date. Each member shall be provided with a copy of the latest A.D.R.C. Guide Book, if available, and a one year subscription to the Dutch Reporter.

ARTICLE V - OFFICERS: SECTION 1 - The officers of this Club shall consist of a President, a Vice-President, a Secretary-Treasurer, and six (6) Directors. The three (3) Officers and six (6) Directors constitute the Executive Board. Each member of Executive Board must reside in a different state. The six (6) Directors shall constitute a Board of Directors.

SECTION 2 - The officers shall be elected from and by the membership by mail ballot. Any member to be eligible for any office must be an owner and breeder of Dutch rabbits. He/she must be 21 years of age.

SECTION 3 - The President and Vice-President shall be elected biennially on the numerically odd years for a term of two years. The Secretary-Treasurer shall be elected biennially on the numerically even years for a term of two years. The Directors shall be elected annually for a term of two years; three Directors to be elected on the numerically even years, three Directors to be elected on the numerically odd years.

SECTION 4 - Vacancies in office shall be filled by appointment by the President, subject to approval by a two-thirds majority vote of the Board of Directors.

ARTICLE VI - DISCIPLINE - SECTION 1 - The Board of Directors may, by a two-thirds majority, suspend or expel any member or reject an application for membership or renewal, providing charges have been preferred by another member. Less than a two-thirds majority shall constitute acquittal of the charges.

SECTION 2 - In the event of preferment of charges, the member against whom the charges have been made shall be fully informed by the Secretary-Treasurer and given thirty (30) days to reply before action is taken by the Board. If reply is made, it shall be considered by the Board along with the charges.

SECTION 3 - Any person expelled, suspended or otherwise rejected shall not be eligible for reinstatement for a period of at least one year and then only upon authority of the Board of Directors.

SECTION 4 - An Officer whose membership has expired shall be notified by the Secretary-Treasurer by registered mail, with signature receipt requested, and if the renewal has not been made in thirty (30) days from the date of expiration, said office shall be declared vacant and it shall be the duty of the President to fill by appointment the unexpired term of office.

SECTION 5 - An Officer who shows lack of interest in his official duties, who fails to answer correspondence of Club matters from his fellow Officers, shall be asked by the President to resign said office. In case of failure to do so, the Board of Directors by two-thirds vote shall declare the office vacant. It shall then be the duty of the President to appoint an Officer to fill the unexpired term of office.

SECTION 6 - An Officer who shall willingly or otherwise give up the breeding of Dutch Rabbits during his term of office shall automatically resign his office and it shall be the duty of the President to fill the vacancy of the unexpired term of office by appointment.

SECTION 7 - No member or candidate for membership may infringe upon the name of

the American Dutch Rabbit Club, or that of any other member or his rabbitry. This also applies to State Dutch Rabbit Clubs.

ARTICLE VII - MEETINGS - SECTION 1 - The annual membership meeting shall be held during the annual Convention of the American Rabbit Breeders Association, Inc.

SECTION 2 - A regular membership meeting shall be held during the National Dutch Rabbit Show; however this meeting shall in no way replace the annual meeting unless the two are concurrent.

SECTION 3 - The President, or in the absence of the President, any elected Officer present may call a meeting of the Board of Directors at any time during the annual Convention of the American Rabbit Breeders Association, Inc., or the National Dutch Rabbit Show. The presence of five (5) Officers at such a meeting shall constitute a quorum.

ARTICLE VIII - AMENDMENTS - SECTION 1 - This Constitution may be amended by a two-thirds majority of the votes cast. Votes to be cast by mail ballot. All members are to be notified in writing of the proposed amendment or amendments and furnished a ballot at least thirty (30) days before the closing of polls.

BY-LAWS

AMERICAN DUTCH RABBIT CLUB

ARTICLE I - DUES - The membership dues shall be \$3.00 per year payable in advance, with a combination membership being provided for husband and wife at \$5.00 per year, expiring with the same date. After membership has expired, the member may renew within a period of sixty (60) days: otherwise upon sending in membership fees, the member will be given a new membership number unless he/she specifically requests that his/her membership be dated back more than sixty (60) days to the original expiration date in order that he/she may keep his/her original membership number. Any member having been delinquent sixty (60) days or more, whether requesting old membership number or not, shall be deprived of all sweepstake points accumulated prior to expiration of dues.

ARTICLE II - DUTIES OF OFFICERS - SECTION 1 - The President shall preside at all meetings of the membership or Board of Directors, appoint all committees, fill all vacancies in office by appointment and perform such duties as pertain to the office.

SECTION 2 - The Vice-President shall perform all duties of the President in his absence or disability. In event of vacation of the office of President, the Vice-President shall automatically succeed him in office.

SECTION 3 - The Secretary-Treasurer shall be custodian of all general funds; shall maintain a bank account in the name of the Club; shall maintain a set of books and records suitable to the Board of Directors; receive and act on all membership applications received, subject to the approval of the Board of Directors; maintain Sweepstake Show records; consult and advise the Board of Directors on all unusual matters; furnish them with quarterly reports showing the general condition of the Club; furnish the Board of Directors with semi-annual audited reports, all these reports to be published in the Club's publication; keep an accurate record of all meetings; and perform such other duties as may be assigned by the President or the Board of Directors. The Secretary-Treasurer shall furnish an approved bond covering the assets of the Club. The premium for said bond to be paid for out of Club funds, with the bond to be delivered to the President within ten (10) days after assumption of office.

SECTION 4 - It shall be the duty of the Secretary to edit, or cause to be edited, THE DUTCH REPORTER. If for any reason the Secretary is unable to perform this duty it shall be the duty of the President to appoint an editor and the Secretary shall cooperate with the appointed editor by giving such news from the office as would be of interest to the membership.

SECTION 5 - The Board of Directors shall have power to transact all business of the Club between meetings; act upon charges brought before them; formulate rules; award the location of the National Dutch Rabbit Show; and decide on all questions of policy brought before them.

ARTICLE III - APPORTIONMENT OF FUNDS - SECTION 1 - The Secretary-Treasurer shall

receive 25% of all membership dues including renewals, and 25% of Sweepstake fees as full compensation for his/her services.

SECTION 2 - The dues shall further be divided with 25% to the show fund of the National Dutch Rabbit Show, and the remaining 50% to the general fund.

SECTION 3 - The President and the Secretary-Treasurer shall each receive the sum of \$25.00 for attendance at each annual, regular, or special meeting, providing the meeting is not held in the town in which either resides, or at a Show which either is judging, in which case there shall be no payment to the resident or judge. In no case shall the payment to either be in excess of the sum of \$50.00 per calendar year.

SECTION 4 - The sum of \$1.50 shall be allowed each Officer and Director, (other than the Secretary-Treasurer, and the Publicity and Promotion Director), and each Chairman of an A.D.R.O. Standing Committee for postage incurred incident to his/her office. Should any Officer or Director serve as a Chairman of any A.D.R.C. Standing Committee he/she shall receive but one (1) allowance.

ARTICLE IV - STANDING COMMITTEES - SECTION 1 - The Publicity and Promotion Committee shall consist of a Chairman and State representatives, and shall be appointed for a term of two (2) years. The Chairman of the Publicity and Promotion Committee shall be known as the Publicity and Promotion Director. and shall have charge of all publicity and promotion work for the Club except for the editorship of the Club's publication. He shall be custodian of and be responsible for the Publicity funds and give a financial report at each annual and regular meeting.

SECTION 2 - The Standard Committee shall consist of a chairman and four (4) members, at least three (3) of whom shall be licensed A.R.B.A. Judges. They shall be responsible for maintaining continuous study of standards, receiving any requests for a working standard on a new variety, and transmitting any proposed revisions or additions to the Secretary, who shall cause such proposed revisions or additions to be sent to each member in good standing with a mail ballot so that he may register his vote for or against each change, revision, or addition. If these changes, revisions or additions are approved by a three-fourths majority of the ballots cast, it shall be the duty of this Committee to submit them to the A.R.B.A. Standard Committee with recommendations that such changes be adopted.

SECTION 3 - The Election Committee shall consist of a chairman and two members, none of whom shall reside in the same county as either the President or Secretary-Treasurer. Their duty shall be to receive and certify the results to the President and the Secretary-Treasurer within ten (10) days after closing of the polls.

SECTION 4 - The Auditing Committee shall consist of a Chairman and two (2) members, no two (2) of them shall either be Officers or reside in the same county as the Secretary-Treasurer. Their duty shall be to make a semi-annual audit of the fiscal period, preceeding the National Dutch Show, and the A.R.B.A. Convention, of the Secretary-Treasurer's books and make a report there-on at these meetings. The committee may recommend, if deemed advisable after examination, that the books be audited by a certified public accountant. The above committee to be appointed from the membership present at the above mentioned meetings.

SECTION 5 - Any special committee deemed advisable by the President, or authorized by the Board of Directors or membership, may be appointed by the President and given specific assignment. At the completion of their assignment, they shall be discharged.

ARTICLE V - VOTING PROCEEDURE - SECTION 1 - a single, commercial imprinted ballot, together with a return envelope addressed to the Chairman of the Election Committee, shall be furnished by First Class Mail, to each member in good standing and to those whose dues are not in excess of thirty (30) days delinquent, by the Secretary-Treasurer on or before July 1 of each year. Ballots shall be returned in a double envelope with the member's names or numbers on the outer envelope. No name, number or identifying mark shall appear on the ballot or inner envelope. The outer envelope shall be removed and destroyed before the inner ballot envelopes are opened. The Chairman of the Election Committee shall receive these ballots until August 1, at which time the polls shall be closed. He shall then assemble his committee, open the envelopes, count the ballots and certify the results to the President and Secretary-Treasurer by August 10.

SECTION 2 - The Secretary-Treasurer shall determine the eligibility of the nominees and ascertain if they will accept the nominations. The two (2) highest who are eligible and have accepted the nomination for each office of President, Vice-President, and Secretary-Treasurer shall be listed as candidates for their respective offices on the final election ballot. There shall not be more than two (2) names on the final election ballot for the offices of President, Vice-President, or Secretary-Treasurer, except in case three (3) or more eligible nominees received the highest number of votes, and the number is identical, thus creating a tie, (or in case of a tie/ties for second place) and providing further that the three (3) or more accept nomination. There shall be six (6) names on the final election ballot for Director, providing there are six (6) eligible nominees who have accepted nomination, providing further that each of the six (6) nominees for offices of Director reside in different States. Should two (2) or more otherwise eligible nominees for Director reside in the same State and should two (2) or more accept the nomination, the one securing the highest vote shall become the eligible candidate. Should two or more otherwise eligible nominees for Director reside in the same State and receive the same number of votes, and should two (2) or more accept the nomination, then it shall be the duty of the Board of Directors to break this tie immediately following acceptances of their nominations.

A single final ballot, together with return envelope addressed to Chairman of Election Committee shall be furnished, by First Class Mail, to each member in good standing and to those whose dues are not in excess of thirty (30) days delinquent, on or before September 10 by the Secretary-Treasurer. The Chairman of the Election Committee shall receive these ballots until October 10th, at which time the polls shall be closed and the same procedure followed as on the primary ballots except the results shall be certified to the President and the Secretary-Treasurer by October 20.

SECTION 3 - The Secretary-Treasurer shall then inform the nominees and the Board of Directors of the results and shall declare the nominees having the highest number of votes elected. The officers-elect shall assume offices on the following January 1 and serve their elected terms or until their successors have been elected.

SECTION 4 - Any member, to be eligible for office, must have received at least ten (10) votes to become a candidate for office of President, Vice-President, or Secretary-Treasurer; he/she must have received at least five (5) votes to become a candidate for office of Director. Any member, to be eligible for office, must have been in continuous good standing at least two (2) years prior to certification date of election, October 20, and all candidates shall remain in good standing with membership fee paid in advance at least through date of assuming office, January 1.

ARTICLE VI - PARLIAMENTARY AUTHORITY - The rules of parliamentary procedure in Roberts Rules of Order shall govern the proceedings of the club.

ARTICLE VII - ORDER OF BUSINESS - The order of business shall be:

1. Call to order.
2. Roll call of Officers.
3. Reading of minutes.
4. Report of Officers.
5. Report of Committees.
6. Unfinished business.
7. New business.
8. Good of the Order.
9. Adjournment.

ARTICLE VIII - AMENDMENTS - SECTION 1 - These By-Laws may be amended by a two-thirds majority of votes cast. Votes to be cast by mail ballot. All members are to be notified in writing of the proposed amendment or amendments and furnished a ballot at least thirty (30) days before the closing of the polls.

YOU CAN'T BEAT THE DUTCH

STOP, LOOK, LISTEN

I believe in working democracy 100 percent, and am in accord with the proposition that the majority should rule. History, however, shows that the majority is not always correct in its decisions.

I further believe errors in judgement of a majority may be traced to one of several evident causes. The majority may vote upon an issue without ample research or facts upon which to vote.

To err is human: and it is no less human for a majority to err than it would be for an individual to err. Strong in this belief, I have always been willing to stand up and be counted even when a member of a lonely minority. At the last meeting of the ADRC in Louisville, this is exactly what I did when the motion was made and carried that our rotating trophies should not be replaced after they are retired.

I sincerely believe this motion should not have been sprung upon the club's membership for immediate vote as was done at Louisville. Members should have time to consider the consequence of their votes, to talk with both proponents and opponents, and to render sensible value judgements in the form of qualified votes.

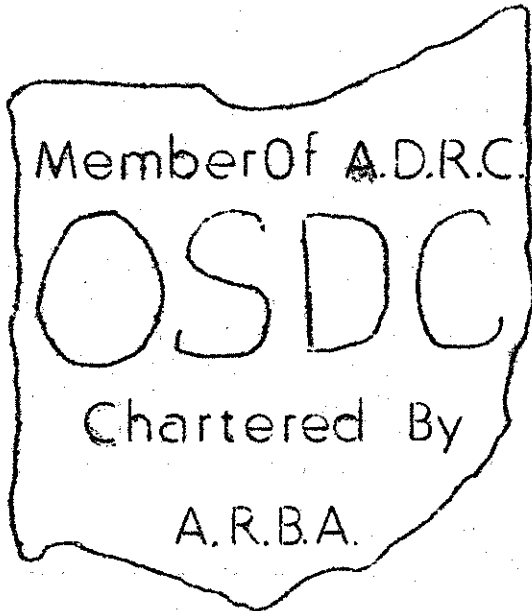
When such actions are introduced and passed without discussion or investigation the voter is often unable to look back or to look ahead for possible side effects of the action being proposed. A good motto would be, stop -- look,-- listen, and then vote.

Here is the result of that motion and its passage. 1. Purchase of annual trophy awards will place an extreme financial burden upon the club's membership. At the current rate this burden will amount to \$180.00 per year. Since we now have a hard time balancing the budget I sincerely question the club's ability to withstand this added financial burden.

2. Elimination of the rotating trophies will deprive current club members of the lasting, binding competitive spirit fostered by the rotating trophies which contributed so strongly to the success of all club efforts and cemented the membership in lasting friendship.

3. Looking back, these rotating trophies were provided a link of past - present - future. I feel it is a great honor to win such a rotating trophy, to have my name inscribed thereon, and to become a permanent part of all that trophy stands for. There is no sudden end with a single victory, but continued competition.

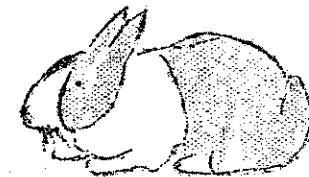

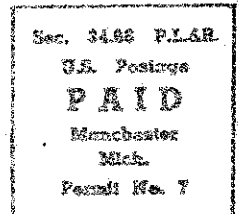
