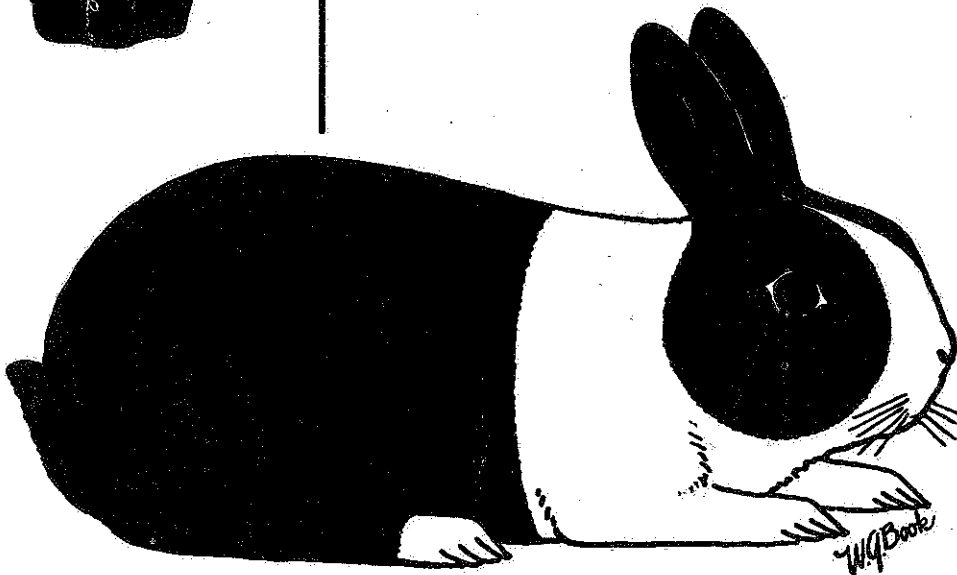

AMERICAN DUTCH RABBIT CLUB

Minutes - Board of Directors, Meeting

Pueblo, Colorado - October 7, 1968

The meeting of the Board of Directors of the American Dutch Rabbit Club was called to order by President Bill Summers at 8:45 p.m. with the following officers * Directors present: President Summers, Vice-President Al Meier, Jr., Secretary-Treasurer, Jessie Weinhardt, Directors, Don Reid, Don Lovejoy, Stan Goeglein, G. C. Sturgis, Sr., and Clyde Jones. Absent was E. R. Parks.

Minutes of the previous two Board Meetings held at Ft. Wayne, Indiana were read and approved with the addition of a thirty day time limit to be allowed President Summers in recommendation item 3. Approved on a motion by Don Reid, seconded by Stan Goeglein. Carried.

Under reports of Officers the Secretary reported that we now had 582 members (by a count of ballots mailed) and 122 shows had been sanctioned since the National Dutch Show at the end of April.

There was a discussion on the recommendations of the Board at Ft. Wayne with regard to the change in the date for applications for the National Dutch Show and it was recommended that such changes should be included in any new publications (Guide Book, etc.)/

Bill Summers turned in his resignation at 10:15. The resignation was accepted by the Board.

Al Meier assumed the chair as President in accord with the Constitution and By-Laws. Don Reid was appointed to fill the vacant office of Vice-President with the unanimous approval of the Board. Al Meier then resigned as President, also with the approval of the Board.

A recess in the meeting was then called for at 10:20 p.m. on a motion by Stan Goeglein, seconded by G. C. Sturgis, Sr., carried.

The meeting was reconvened at 10:37 with the following officers present: Don Reid, Don Lovejoy, Stanley Goeglein, G. C. Sturgis, Sr., Clyde Jones and Jessie Weinhardt.

The first order of business was the appointment by now-President (by order of succession) Don Reid of Al Meier as Vice-President. This with the unanimous approval of the Board.

It was pointed out that we now had two vacancies on the Board of Directors and a discussion of eligibility of various people to fill these vacancies was held. One vacancy had been created by the E. R. Parks' failure to renew his dues and the second by the elevation of Don Reid from Director to the Presidency. To take the place of E. R. Parks, Al Meier recommended the appointment of Doris Leibel.

With approval of the Board, Don Reid appointed Doris Leibel to fill this vacancy which has until Jan. 1970 to run.

David Paul was then appointed to fill the vacancy created by Don Reid's moving up. This term would expire the end of this year (1968) but was due for re-election in the ballot now with the election committee, so could run to Jan. 1, 1971. The Board approved.

There was a motion by Don Lovejoy, seconded by Glen Sturgis that the secretary be instructed to see if a vote had ever been taken by the membership to clarify the composition of the "Board of Directors". Carried.

That part of the By-Laws covering the Secretary's duties was read and it was discovered that the President had the power to appoint an editor for the Dutch Reporter. He agreed to try to find such an editor and thus lighten the secretary's work-load.

With the approval of the Board, Jim and Barbara Walker of Columbus, Ohio were appointed as co-chairmen of Publicity.

The Secretary was instructed to get out one big issue of the Dutch Reporter containing all of the back-log of show reports.

The re-printing of the Guide Book with corrections and new and corrected advertising was discussed and since so much detail, available only through the Secretary's office would be needed, Jessie Weinhardt was asked to chair this committee and to select those members living in her area to assist with the job. This she agreed to and the Board approved.

Meeting adjourned at 11:40 on a motion by Sturgis, seconded by Jones. Carried.

AMERICAN DUTCH RABBIT CLUB
Minutes - General Meeting - Pueblo, -Colorado
October 8, 1968

The General Meeting of the American Dutch Rabbit Club was called to order by President Don Reid at 10:30 a.m. with the following Officers and Directors present: President Reid, Vice-President, Al Meier, Jr., Secretary-Treasurer, Jessie Weinhardt, Directors, Stanley Goeglein, Don Lovejoy, G. C. Sturgis, Sr., Clyde Jones, Doris Leibel, and David Paul.

Since the Minutes of the previous meetings held at Ft. Wayne had been published in the Dutch Reporter, there was a motion by Pat Herman, seconded by Bill Summers that these minutes be accepted as published. Carried.

Roll call shows a record of all nine members of the Executive Board present.

There were no committee reports and no unfinished business.

Under new business there was a recommendation by Al Meier that certain items be clarified in the Dutch Standard in the new ARBA Standard Book. He pointed out that although it was the American Dutch Rabbit Club, it was the Dutch Rabbit which we sponsor. It was pointed out that we had been trying to get this across to the ARBA for the past several years with no success. As a member of the ARBA Standard Committee, he also requested recommendations for the clarification on the wording with regard to some of our colors.

A letter addressed to Marvin Cummings to be read to the meeting, from James Collins of Florida with regard to sponsoring donations to hire help for the secretary in getting out the Dutch Reporter was read by Tom Shufflebotham. It was explained that this had been taken care of by the Board of Directors and would come out later in the meeting. The secretary was instructed to reply to Mr. Collins letter.

On the subject of the Dutch Reporter there was a recommendation that in order to cut down the work of catching up on the back-log of show reports, only the winners be published. There was some discussion and Tom Shufflebotham read the Editorial Policy set up by this club.

There was a motion by Pat Herman that since the old show reports were such stale news we could just forget about them, publishing only the final results and go on to the new series. This was declared out of order and Al Meier stated that it was covered in the Minutes of the Board. The motion was withdrawn.

The Minutes of the Board of Directors Meeting held the previous night were read and approved on a motion by Pat Herman, seconded by Stan Goeglein. Carried.

Doris Leibel volunteered to take over the publication of the Dutch Reporter for one year.

The composition of the Editorial Committee as set up in the Editorial Policy was spelled out as being the Editor, Publicity Chairman and one Board member appointed by the President. A copy of the Editorial Policy is to be sent to Doris Leibel.

The question as to just what the duties of the Publicity Chairman consist of was raised. There was some discussion as to whether it is necessary to have a booth at National Dutch Shows. It was the consensus of opinion that a specific booth as such was not necessary but publicity items should be available for purchase by the membership. Tom Shufflebotham described a quilt made of show ribbons which had been on display at a couple of Conventions depicting a Dutch Rabbit. He thought it would be nice if the club could arrange for the purchase of one of these quilts.

There was a motion by Pat Herman that a By-Laws Committee be appointed to consider the inclusion of the Publicity Director as a member of the Board of Directors and his duties should be spelled out. Second by L. Dean Bryan. Discussion pointed out that this motion was based on a misinterpretation and it was withdrawn.

The Auditors report was read and accepted on a motion by Pat Herman, seconded by David Paul. Carried with one dissenting vote.

For the good of the order, Pat Herman recommended that we ought to give a vote of thanks to our Breed Chairmen, Clyde and Doris Jones. They were given a rising vote of thanks.

The following report of the Publicity Chairman was read into the Minutes by the Chairman, R. A. Harris.

(Editor's Note: Since there has been some questions raised as to why certain names did not appear on the final election ballot, this would be the time and place for an explanation. I refer you to page 16 of your Guide Book (By-Laws) Article V, Section 4 - "Any member, to be eligible for office, must have received at least ten (10) votes to become a candidate for office of President, Vice-President or Secretary-Treasurer; he/she must have received at least five (5) votes to become a candidate for office of Director." Under the same Article, Section 2 the By-Laws state: "There shall not be more than two (2) names on the final election ballot for the offices of President, Vice-President, or Secretary-Treasurer, except in case three (3) or more eligible nominees received the highest number of votes and the number is identical thus creating a tie" --"There shall be six (6) names on the final election ballot for Director, providing there are six (6) eligible nominees who have accepted the nominations--" As you can see by the count of the ballots we had seven members with enough nominating votes to qualify to run for Director but two of these declined to run and one lived in the same state as another (accepting) candidate with more nominating votes. It was decided at the time we chose to pick our judges by this nominating and election procedure, but the Board of Directors that the same terms of eligibility which applied to the nominating of Directors (excepting the stipulation that they not live in the same state) should apply when setting up the election ballot for Judges of our two shows. Thus four names are to appear on the final ballot to elect two judges for each show. Those having the greater number of nominating votes and willing to run for the job to have priority on the ballot. Hope this clears everything up -- if anyone still doesn't understand I will try to explain it further. JW)
