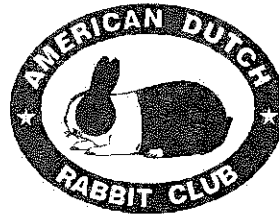

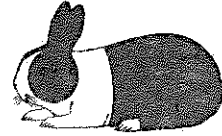

President's MESSAGE

This has been a very trying winter for most rabbit breeders. The cold spell that hit the Midwest and south made breeding and raising litters very difficult. It has not hit the Dutch in this area as hard as many breeds. I deal with several pet stores and try to get them a variety of small breeds. I know a lot of people who raise the small breeds and the story has been the same - we don't have any babies! The Dutch may be more prolific or just better mothers, but I can still find Dutch bunnies - not a lot, but some. This will have an affect on the National Dutch Show this year. I know several of our dedicated breeders who will not be there due to lack of bunnies. Compared to recent years, I will be down about 50% this year as well.

The National Dutch Show will be upon us by the time you receive this issue. The Illinois group has experience on their side and will do a good job. They also have a very nice facility. We may not have the numbers, but we will have a good show.

They are trying something a little different this year. The fur class will be held on Friday evening, with one of the open judges judging the youth fur and one of the youth judges judging the open fur. They will not be looking for Disqualifications. HOWEVER IF THE RABBIT IS DQ'ed in the show on Saturday, then it will be DQ'ed from the fur class and the placements will be adjusted accordingly. This will help to make the workload lighter on Saturday.

The membership liked the idea of starting the judging on Friday when we asked them at the NDS in '99. This is a start. The Ohio State Dutch Club will be bidding for the 2004 NDS. They will be looking at having some of the regular class judging on Friday, probably one class of blacks per judge. That would allow us not to rush on Saturday. More detail will be out on this as we get closer to the show.

The 2002 NDS is going to be held in

Indianapolis, on April 26 -28 hosted by the Hoosier Dutch Club. **DOES ANYONE HAVE AN INTEREST IN HOSTING THE NDS IN 2003? We need to know this ASAP.**

The Publicity Chairmen will be unveiling a new color Dutch poster at the NDS this year. They also will have several new clothing items in their inventory.

The guidebook is in development, but will not be out for a month or more. We will be having color pictures of the markings of the Dutch as well as varieties, hind leg structure, undercolor, ring color etc. We are trying to make this a top notch, new and educational, publication.

Speaking of publications, we will be pushing to get the next DR out to you on a timely matter. I know the issue has been running late, and my goal for the this year is to get it to you when it is supposed to be to you.

The web page may be up and running by the time you get this. The web address is going to be www.DutchRabbit.com. Angie Aisbet will be doing the upkeep to the site, so all requests and input should go to Angie.

I hope that all of you can make it to the National Dutch Show, and if so I'll see you there.

(California doesn't seem to have any steels right now!) The areas with higher numbers in a variety naturally rack up more points. The Best/Best Opp sweepstakes tends to show a breeder's consistency, and the Rabbit of the Year concentrates on a single rabbit. Breeders who win with many different rabbits won't be able to compete in this competition, unless they get one really dominant animal that not only wins locally but at a national level show as well. Each competition has a

slightly different focus, although showing quantity still outweighs quality to some extent.

I think the whole membership should give Jeff Andrews and his mom a BIG thank you for doing the sweepstakes for so long. They work quietly in the background, and boy do I mean WORK. Even with the computer program, the work is still there and it is very time consuming. As one who did some of it for three months while testing the program, I got a whole new appreciation for the process. Jeff and his mom don't get much recognition so I'd like to say THANK YOU to both of them, and I'm sure that the rest of the Board would echo the same sentiment.

I hope that everyone is considering coming to San Diego in October. It is a great vacation spot for everyone.

A motion by Todd Uran, seconded by Briony Barnes that the meeting be adjourned was passed.

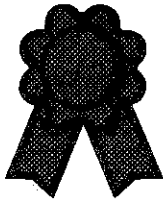

YOUTH BOB WINNER 2000 ARBA CONVENTION

This year was my fifth ARBA youth Convention. I've been raising rabbits for eight



years, Dutch for seven, Californians for six, Creme d'Argents for two, Florida Whites for two, New Zealands for one, and I just picked up some Netherland Dwarves. I guess I started out like most Dutch breeders with blacks and then expanded to blues. When my Mom and I went to the Peoria Convention she bought a steel buck, so then I got into steels and grays.

This last year I added torts. It's always been my goal to win ARBA and NDS Convention. I think it's every breeders goal to win Best of Breed at the National Convention, but without all of my friends in the Dutch Club, I wouldn't have had a shot. Scott Williamson bought and gave me my first Dutch. "Cali" was a black doe from a Kansas breeder we all know, Bob Bergene. She became my foundation doe and most of my blacks and blues can trace their line back to Cali. Cali wasn't marked extremely well, but sometimes the best

rabbits aren't the ones that are marked perfectly. I didn't have a buck and needless to say, the older Indiana breeders were a little reluctant to help me find one. I was a nine and half year old girl holding this little black doe. I had a goofy grin on my face and a mother that was just anxious for me to be happy. Bob Worden is the man who helped me start my herd. He bred my doe Cali for me and several of my does for years afterwards. In 1995 after my own grandfather died, I adopted him as "Grandpa" Bob. He has always stood beside me and helped me pick through my countless litters, putting up with my childish tantrums and tears. One of my greatest achievements was to give him a black buck that I had raised. When he said that he would keep my little buck, it was one of the happiest moments of my life. Scott also introduced me to Dick Evenburg and Kay Stearns. They were also at the Peoria Convention, and Dick had a black buck named Bart that I wanted. I think I actually begged him, on my knees, to sell me that buck. Luckily he does have a kind heart, and after several days he finally agreed to sell me Bart. Bart helped my herd tremendously, adding body type and markings that I was seriously lacking. So in one Convention I had added a black buck that kicked me into the top ranks of dutch breeders, a steel buck that would also add to that, and some grays that would eventually climb to the peak as well. Kay and my mom became good friends,

and when I wanted to get into torts I called her because I didn't know where to go or who to ask. She told me she had a tort buck that she would give me, because Dick didn't like the torts and "The Wiz" needed a good home. So "The Wizard of Oz" came to live with me and I was into torts. When my birthday rolled around that fall, Kay gave me a pair of tort does, who I promptly named Carmel and Carmen.

That brings me to ARBA Convention 2000. The tort doe who won for me and who now enjoys a life of leisure full of little ones is Carmen, a tiny tort doe who was a birthday present from my "Aunt" Kay and "Uncle" Dick.

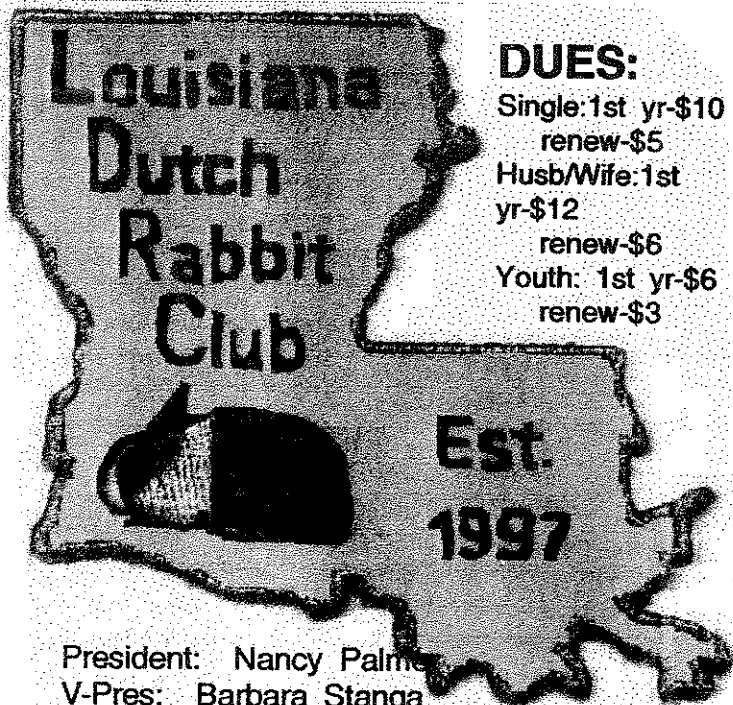

Milton Hershey School's Rabbit Club By Linda Keller

When I first came to Milton Hershey School, I felt so out of place and lonely. During New Student Orientation Week, all new students were introduced to the various animals at the AEE Animal center. I felt joining an animal club would keep me occupied, as well as, introduce me to other students. Before coming to Milton Hershey School, my only animal experience was with small pets (cats and dogs). So, I thought it would be smart to join a small animal club and rabbits were the logical choice.

Milton Hershey School is a private residential school located in Hershey, PA founded by chocolate industrialist Milton S. Hershey and his wife Catherine. Milton Hershey School provides high quality education a home in a family environment free of charge

for children in the grade kindergarten through twelfth that meet admission criteria. At Milton Hershey School, students develop skills for a meaningful life as they prepare for both work and further study. The school provides housing, education, food and clothing, free of charge for each enrolled student.

Students join the rabbit club for a variety of reasons. All the meetings are held at the animal center. In groups of 9 students, we meet once every two weeks. During the meetings we feed, water, clip nails, breed and do anything else that needs done to the rabbits. Approximately 130 students of various ages and grades interact with the rabbits in club activities. Students either elect to join the club or are sometimes referred by a school counselor.

Do you know what breed Roger rabbit is? Well here at the Milton Hershey School's Agriculture Environmental Education (AEE) Center, we have Dutch and Rex rabbits. Roger does not look anything like them. The Dutch we have are chocolate, black and blue. The Rex are Broken Black, Lilac, Chocolate, and Broken Chocolate.

Houseparents and the Milton Hershey School 4-H coordinator started the Rabbit Program. Initial club work involved a rabbit project in the backyard and more of a discovery learning approach. Today, under the direction of AEE Instructional Advisor, Todd Biddle, the rabbit program consists of three areas, including education, 4-H club activities, and animal assisted therapy.

Education

*Exposing students to responsible care and requirements of animals.

*Education in the classroom – for example Charlotte Web, Fourth Grade Fair, ABC Rabbit Book.

*New Student Orientation gives the student opportunities to have hands on experience with small animals.

*Breeding trials

4-H Clubs

*Organized youth groups dedicated to learning the responsible care, anatomy, breeding and showmanship skills for rabbit shows.

*All members of the MHS Rabbit Club are active 4-H members.

Animal Assisted therapy

*Rabbits are used to teach students about relationships, respect, care, love, and animals in general.

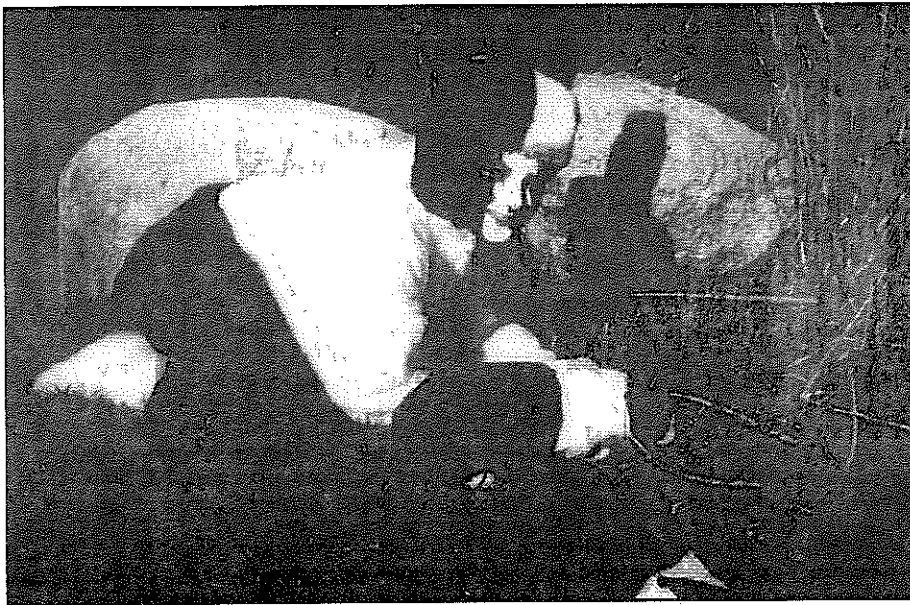
Our students have enjoyed considerable success in competitions. We show our rabbits in PA and Maryland. Last year we attended six shows. **Our school earned the PASRBA Sweepstakes High Point Award for youth Dutch Rabbits.** We have also earned a number of legs on our homebred Dutch rabbits. The rabbit club is not only a learning experience; it is also a social experience.

For example, the school hosted a Spring Skill-a-Than Lock-In. The rabbit club members participated in a number of other activities as well. Square dancing and miniature golf activities were held last year.

Rabbits are excellent animals because of their size for students to begin to learn proper nutrition, care, and breeding of an animal. Because of the rewarding experience the students have with the rabbits, they gain the confidence to encourage future participation with dairy goats, sheep, horses, and even dairy cattle.
