SECRETARY'S MESSAGE

Greetings once again. Seems like summer is a busy time of the year. The fair season has begun and these shows are a fantastic opportunity to get our Dutch in front of the public. In spite of the heat and often time poor facilities, it is something that we should attempt to work with. Both open and 4-H have potentials that we shouldn't ignore.

I especially enjoy seeing the youth, primarily 4-H, working with their animals. This is the learning grounds for these future breeders, and they need our assistance. I don't feel that we should do things for them, but rather, we should be available for guidance and help if they run into things beyond their control or experience.

Along the same line, we are still getting letters concerning a youth division of the Dutch Club. I don't know how much of a separate division we could economically enjoy, but there are ways of rewarding our youth members for their accomplishments. Come on youth members - get those cards and letters going to the officers telling them of your concern and desires.

The final election ballots will be mailed out before you receive this Dutch Reporter. Again, it will be done by 3rd CLASS PERMIT MAIL. I have to admit that I don't care for this method of mailing any more than you do, but we have to consider the relative costs and effectiveness. We only received two requests for ballots from people who did not receive their nomination ballots. Maybe this was due to indifference, but apparently most received theirs, or we would have heard about it. AGAIN, IF YOU DO NOT RECEIVE YOUR BALLOT BY THE 25th of AUGUST, send for a NEW BAILOT. Don't wait until the last day before the due date of the ballots, as you must allow a week for even the first class letters to get to us and back to you.

I guess I didn't explain a couple of things very well last issue. Darrell Bramhall was left off of the nomination ballot for judging next year because we had not heard from the convention committee that he would not be judging at the date the ballots were published. I discussed this with President Stinehelfer and we decided to place Darrell's name on the ballot this fall, as has been done in the past when the selected judges did not get to judge at the show they were elected for.

The other item that seemed to arouse some people was how I phrased the statement that Darrell was not selected to judge Dutch. Another club had offered to pay Darrell, so the convention would not have to pay their judge. Apparently the money spoke, as this is the way it was done. Apparently there is no way of insuring that we get our choice of Judges unless we hire and pay our own. We did make an offer to guarantee that there would be enough Dutch entered to cover the two judges we requested, and that if there was not enough, that we would pay the extra cost of the additional judge.

I guess I have to admit that I would not be pleased with whatever the show committee did, unless it included giving us our choice (CONT.)

of judges. At the same time I realize that it is impossible for them to satisfy everyone. I feel that I have to do my best for the Club and the members that I represent when I do these things. It was easy in York, as our staunch Dutch members in that area greased the wheels for us and got us our choices. It wasn't so easy in Milwaukee, as the committee wouldn't even consider our selections, and we were forced to pay both judges. If we have a professional mediator in the audience, would he or she please step forward and offer their assistance for this task in the future?

A REMINDER to all MEMBERS - - - The SWEEPSTAKE RIBBONS are supposed to be picked up at the show. Usually the secretary will bring the ribbons and rosettes with them. If they don't or if you don't see them, ask the secretary about them. If somehow you don't receive all your ribbons or rosettes, write us, and we will send you your prizes. We have had very few complaints about this, so again, we presume that it is working fairly well.

Start gearing up for the convention show. Texans are hospitable and friendly, and can put on some fine shows. Long ways for us, but we are planning on attending anyways. Look forward to seeing old friends, making new friends and having a good time.

Get your BALLOTS IN AS SOON AS POSSIBLE. VOTE for those you think will benefit the club. Good slate of potential officers again! Makes it easier to vote when all the candidates are qualified and capable. After the votes are counted and the dust settles, I'M sure that the DUTCH CLUB will again be the WINNER.

I would like to take this space to Thank the Board of Directors for taking my proposed youth sweepstakes into consideration. I would also like to add some information and viewpoints that have come to me from several ADRC members who expressed great interest in this youth project. FIRST - I have heard that there is some concern over the life span of a youth member. The life span of a youth member would be no less than that of a perspective adult member. Since some adult members lose interest in Dutch, more to another breed or give up rabbits altogether - they do not stay in the ADRC. With a youth department in the club I feel that membershps would be stablized and more members, when they become adults, will stay in the club. As for those youth members who go to college after high school, I can say that, if they truly enjoy rabbits they will arrange some way of keeping them.
