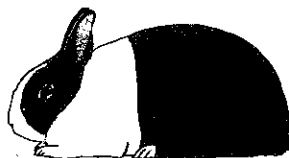

PIECE OF MIND

ATTENTION American Dutch Rabbit Club members and breeders!

Before you read any further, let me warn you that this will be the longest President's message that I have written to date. There are several items I feel that I must call to your attention before you vote. These items are reviewed because I love the Dutch Club!

VOTING

First, many of you will notice that my name does not appear on the election ballot. I elected to decline the nomination for President of the American Dutch Rabbit Club for several reasons. If you still want my leadership, you will have an opportunity to re-elect me as your President (read on). Due to the very low response in the past nomination, I don't feel that the membership did an adequate job responding to the nomination ballot. As a matter of fact, you did a very poor job! Not everyone is to blame, but the only exceptions are those who took the time and effort to fill out the ballots and return them.

The ADRC method of nomination to office or national judge is poorly implemented, time consuming, inefficient and expensive. Nomination ballots are a thing of the past, rapidly being replaced by petition for office. I am strongly recommending that the ADRC adopt the petition policy. Any member in good standing may request a petition for office from the secretary-treasurer. Upon completion of the petition, it would be returned to the secretary-treasurer for membership verification. Any member wishing to run for office must obtain the endorsement by

signature of at least 10 ADRC adult members. If the petition is complete, the name would appear on the election ballot. Election ballots would be mailed first class to the general membership with voting privileges. The same procedure should be implemented for the national show (ARBA Conventions and National Dutch Shows) judges. This affords the opportunity of involvement for any ADRC member judge.

In addition, a short biographical profile would be printed in the Dutch Reporter (DR) to introduce the candidates and enable them to explain their qualifications and platform. As always, write-in candidates are eligible to hold office if the number of votes received so dictates.

CONSTITUTION AND BY-LAWS

Any resolution or change to the constitution and by-laws of the American Dutch Rabbit Club will be discussed and voted on at the semi-annual meetings. Any member may submit constitutional or by-law resolutions and/or amendments. The submission of constitutional amendments must be to the President of the ADRC who will present them to the officers at the executive meeting preceding the general membership meeting. Amendments are due to the President by January 1 and July 1 to precede the semi-annual meetings. The proposed amendments will be published in the JAN/FEB or JULY/AUG issues of the DR. All amendments will be published in the DR at least 30 days prior to the vote.

Several members (Dill, Gehr and Simonson) have expressed concern over the comprehension of amendments and resolutions by the general membership. Discussion at the semi-annual meetings

would help resolve any confusion associated with the changes. By following the aforementioned timetable, these discussions can resolve any confusion associated with the interpretation of the proposed changes.

We do need to simplify our constitution and by-laws, condensing the length but still making them complete. Too much fragmented effort has taken place in the past 6 years in an attempt to improve our constitution and by-laws. Therefore, as your President, I appoint myself chairman and the following committee members to overhaul the constitution and by-laws: Glen Carr, Wenton Carlton, Dick Evenburg, Dick Gehr, Vicki Hertel, Wayne MacKinnon, George Parmer and Jack Wireman. If anyone else would like to serve on this committee, you must contact me by August 21, 1987. If you have inputs for the betterment of the ADRC Constitution and By-laws, contact me by September 1, 1987. I will then solicit the inputs of the committee members and process the revision by September 10, 1987. At which time, I will send the complete revised version of the proposed constitution and by-laws to the DR editor, committee members and ADRC officers. These resolutions will be discussed at the Portland ARBA Convention, October 12-15, 1987 and the NDS in Bloomington, Illinois, May 6-8, 1988. This will allow plenty of time for input and discussion. The revised constitution and by-laws will be voted on in the next election.

ARBA CONVENTION

Portland, Oregon will be the host city for the 1987 ARBA Convention. This annual event will be held October 12-15, 1987.

Please fill out the specials page in this DR to support the list of specials for the ARBA Convention. We still need more money to cover the costs: \$1, \$5, \$10 or more will help. You will be issued a receipt and listed as a donor in the DR and the ADRC convention booth. Your support of this national show is just as critical and beneficial to the Dutch fancy as the NDS. The ARBA Convention is where we can show our pride to other ARBA members and conventioners.

The Cosmopolitan Motel will lodge many of the Dutch breeders exhibiting or attending the Portland convention. This motel is approximately five blocks or 15 minutes walking distance from the showroom. Parking at the motel is free if you are a registered guest. The rates are very reasonable (see page 40 of the MAY/JUNE DR), so call (503/235-8433) today for you reservations. Contact George Parmer (District #1 Director, 503/644-4870) if you have any questions regarding the convention. Jim and Bonnie Kelly will be the breed superintendent and secretary. Dick Gehr will have the honor of judging the entry. So, plan your trip to Oregon in October.

Reed and Dr. Scott A. Williamson) have been contracted for the open class. Ivan Miller, a very well respected, close personal friend, will do the youth honors.

The ARBA Executive Secretary, Glen Carr, will conduct a tour of the ARBA home office during that weekend. This would obviously be an excellent opportunity to show your Dutch and learn more about the activities of the ARBA home office!

SELLER'S CLASS - ADRC GOLDEN OPPORTUNITY AUCTION

Tom Dietrich and his seller's class committee has done an excellent job with the ADRC Seller's Class. They have provided an opportunity for buyers to acquire seedstock and have helped raise in excess of \$3,000 for the ADRC treasury. The commitment shown by this committee in support of the Dutch fancy has been outstanding.

I would like to offer the following suggestions for the seller's class committee to consider.

1. Only the top 10 placing open and top 2 placing youth seller's class rabbits will be auctioned off.
2. The extra rabbits entered in the seller's class will be sold by silent bid. This process will save time and still provide potential buyers the opportunity to fulfill all their needs.
 - a) Dutch will be displayed and potential buyers be allowed to review the pedigrees and talk to the sellers.

- b) No handling will be done except by the seller, seller's class judge, or seller's class committee member.
- c) Extra rabbits will have envelopes placed on their cages for bids to be deposited. Just before the "top of the crop auction", the bids on the extra rabbits will be reviewed.
- d) Minimum bid on any rabbit will be \$15 or no sale will have taken place. The rabbit would remain property of the seller.
- e) If there is a tie for high silent bid on the same rabbit, bidding will commence between the potential buyers.
- f) The silent bid form could look similar to the following:

- 3. The entire sale price of the high selling Dutch rabbit will be offered to the seller of that rabbit. This should act as added incentive to continually upgrade the overall quality presented in the auction.
- 4. The balance of the sales will be divided as presently implemented (50% seller; 50% ADRC).

These are just a few suggestions that I had to the seller's class committee. Listing them in the DR may spark some very good input from some of you. Please mail your comments regarding the ADRC Seller's Class directly to Tom Dietrich.

HISTORY

Marti Dill made the suggestion of publishing the past winners at the ARBA Conventions and National Dutch Shows from start to present. In addition, the listing of Dutch Club leaders might also be included with membership numbers. I have appointed Marti Dill to spearhead the collection of this information. If anyone could help Marti in this hunt, please contact her. The complete

list will be published in every guidebook.

LIFE MEMBERSHIPS

I would like to see the full list of current ADRC life members in the next DR. Therefore, I would like to ask Norma to collect this information and send it to Kay for publication in the next issue (SEPT/OCT).

The issue of requirements for life membership in the ADRC has been raised recently. I believe that 25 consecutive years membership in the ADRC plus 65 years of age is too high of a requirement to be awarded an ADRC life membership. Any member who has dedicated 25 years collectively of paid membership in the ADRC and is 60 years old desires a life membership. Therefore, the current resolution should probably read: Any current member in good standing who is 60 years of age or older and has paid 25 years cumulative membership in the ADRC will be awarded a life membership by the ADRC.

Life membership may still be purchased. Actually, purchasing a life membership is a real bargain if you plan on raising Dutch or being a Dutch fancier for any length of time. The current cost for an ADRC life membership is \$149.

PUBLICITY AND PROMOTION

The ADRC has long been a leader in the promotion of its breed. However, we cannot rest on our laurels. Progressive as well as aggressive advertisement must be pursued to keep the members we have and persuade others to join our organization.

There is no doubt that Al and Barb Butler have carried the publicity torch alone many times and have always been available to help with Dutch promotion. I am calling for help and input for the Butlers from the general membership. Fran Schettler from Danville, California has helped with the sales of publicity items and you can too! The Schettlers attend many shows and carry these items with them to sell and promote the Dutch Club. We need other people like the Butlers and Schettlers who are willing to get more involved with our organization through promotional service.

The Butlers are preparing a catalog of Dutch Club publicity items complete with photos to improve the visibility of these items to the membership and other interested people. In addition, a publicity sheet with items and prices will be printed for mail orders. In the next issue of the DR (SEPT/OCT), a complete inventory of publicity items will be listed along with the prices. Submit your publicity orders for the 1987 ARBA Convention in Portland, Oregon. That way, you will save postage costs and may pick up your order in Portland.

The ADRC with the help of Diane Geitzenauer has finally completed a short brochure to be distributed to clubs and potential members. I wish to thank Diane for taking the initiative to edit this greatly needed promotional item. If you want a supply of these, simply write Norma Hart, secretary-treasurer. She will mail them to you when they are ready, after October 1, 1987.

The ARBA now has the Dutch video available for your review. Send a deposit fee of \$40.00 and a separate check for \$8.00 as a service fee payable to the ARBA. Be sure to include the tape

number you wish to review. The Dutch tape number is 7. Included on the tape will also be Himalayans and English Spots. The video breed education idea is excellent and I am positive that many Dutch breeders as well as potential Dutch breeders will benefit from its use. These tapes may also be excellent judging aids for new ARBA judges or others who simply may need to "brush up" on a particular breed. The tapes are all VHS, so keep that in mind when order the desired tapes. A complete list of breed tapes is on page 5 of the May/June issue of "Domestic Rabbit Magazine." So get your order in early. Contact the ARBA for further details.

SHOWING DUTCH

More Dutch need to be shown throughout the country. Don't be satisfied with the number of Dutch you own and show. You can't have too many Dutch! Good Dutch don't just happen, they are planned.

Think, when you go out to mate your Dutch. Just don't throw doe A in with buck B and expect a miracle. I have found that miracles just don't exist in raising rabbits. You must be a good animal manager to succeed in breeding and winning with Dutch. Patience and planning can be used to produce that winning herd of Dutch. Breed away from problems, not toward them.

Dick Gehr indicated that there is renewed concern over the cow hock issue in Dutch. As Dick pointed out, this is not a new problem. It has haunted Dutch breeders for decades. If any Dutch breeder says that none of his animals are cow hocked to

a certain degree, I'll be the first in line to buy some! All rabbits exhibited some degree of cow hockedness. The problem is the interpretation of severe cow hock. Remember, as breeders, breed away from problems not toward them! If your herd has increased its tendency to "hock-in" or cow hock, then you need to breed away from this trend. Cow hocks are just one breeding concern that may challenge Dutch breeders.

Another issue of concern expressed in recent issues of the DR is the testicular development by junior bucks. Rabbits are unique in that the testicles and scrotum do not develop and descend until the animal is 6-12 weeks old. Many breeders have indicated that eliminating junior bucks for not showing both testicles is discriminatory. However, I personally feel that bucks must exhibit testicles descended into the scrotum or they should be eliminated. I have observed rabbits win B.O.B. and B.O.S. that had no testicular development, no scrotal tissue and were over 5 months old! Some strains of rabbits "drop their testicles" earlier. So breeders must simply be patient to show their junior bucks until ALL parts can be evaluated.

There are several other challenges which face Dutch breeders, but I like to think accepting the challenge of breeding Dutch toward perfection is what makes breeders of Dutch unique. Anything in life worthwhile is worth 100% + of your effort. If you give that kind of commitment to breeding better Dutch you will succeed!

THIS AND THAT

The ADRC needs a sweepstakes chairman. Kay has outlined the requirements for the job in this DR. If you are interested, please contact me by mail or telephone by September 1, 1987.

I was very sad to learn of Walter Cook's passing. He was a long time supporter and friend of the ADRC. Walter and Anna made a monetary gift to the ADRC at the 1987 National Dutch Show in Euless, Texas just two weeks prior to Walter's death. Our sympathy and prayers go out to Anna and the Cook family in their time of sorrow.

SUMMARY

In closing, I would like to remind you to vote. I will continue to serve as your President if enough members write-in my name as their choice for leadership and progress in the American Dutch Rabbit Club. There will be a great deal of change for the betterment of the ADRC. Thank you for your support.

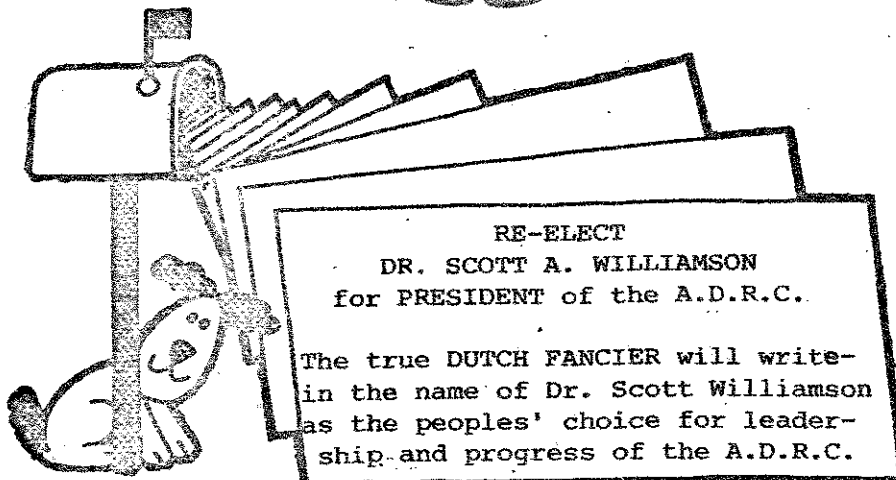
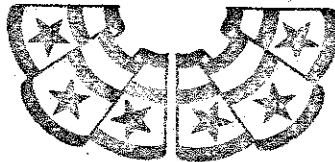

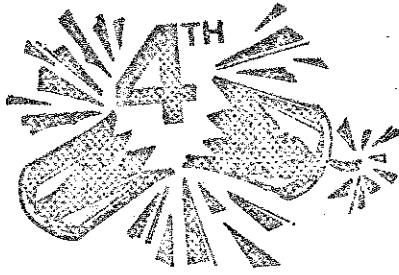

Many exciting things are happening in the Dutch Club. Due to the difficulty that our Editor had with the last edition of the DUTCH REPORTER because of in-operable equipment, the Board of Directors is looking into purchasing new trust-worthy equipment. Kay, and other editors over the past few years, have worked very hard to make the DR, the BEST. They want to have an informative paper but most of all, it must be easily read by all of our members. The DR is one of the most important gauges that our members use in evaluating whether they will re-new their membership or not. Keeping good quality equipment for our editor to use is important. Let your area director know how important a good DR is to you in your efforts to breed a 'perfect' Dutch.

In the Youth Department a new program will be offered at the '88 National Dutch Show. We will add a Royalty Contest for those members attending the show. Show coats will be awarded to our King & Queen while other gifts will be given to the Prince and Princess. I am pleased to say that several of our adult members have offered to help with their time and money.

Many of the breeders who have been raising rabbits for a number of years, get a number of calls from folks who have only been into the 'bunny business' for a short time. Many have started by purchasing an Easter Bunny. Because they are so new, they don't know who to turn to when they have an animal who won't eat, has dis-colored urine or sneezes. They can either call you or they can call a Vet.

Recently, I have had two calls from new rabbit owners who took their pets to a veterinarian, spent alot of money and ended up with a dead animal. In both cases the animal had an easily treatable ailment. One died of a hairball, the other an overdose of a 'cillin' to cure off-colored urine. The problem was that their veterinarian didn't have the knowledge needed to treat rabbits. How can we blame them, how many dollars are spent on rabbits versus the horse or dog. It's only natural that while in school, he studies the most about animals that he will be seeing the most in his/her clinic

It is our DUTY as knowledgeable rabbit breeders to offer to assist the veterinarian when he has problems that he isn't familiar with. Most of the vets, when they realize you have a good sound knowledge of rabbits, are happy to have you for a resource person. Don't worry if you don't know all of the technical terms just make sure you can back up your statements with printed proof. You might consider preparing a phamplet on basic rabbit illnesses or speak to a group of local veterinarians. We don't have the right to complain unless we've tried to solve the problem first.

FROM THE DESK OF YOUR SECRETARY.....



I hope that each of you are doing your best to make plans to either attend the ARBA Convention in Portland, Oregon this year or send one or two of those exceptional Dutch out. It's not always easy to attend the ARBA Convention -- many times the distance is just too great and air fare, motel and food expense and the time off are too hard to come by! I feel very fortunate that we were able to schedule vacation time during this period and that we do have our airline tickets. I'd rather keep my feet on the ground but flight time as compared to driving time just can't be beat!

I'm probably going to offend some with my next statements, but I've never been one to hold back my feelings. As much as I enjoy the ARBA Convention, I personally feel that they are getting farther away from that Very Special Rabbit Show as originally intended. I would like to see rabbits released immediately following the completion of all judging! This would enable those that have long trips home the opportunity to get an early start. It would save the expense of possibly one night's motel and an additional day of food expense. I've always felt that those that are interested enough to stay for meetings, visiting, etc., will do so regardless. Why place that additional expense on a person or family if they really cannot afford it or would just rather leave? Don't say "don't go at-all if you can't afford it"! That's a mighty big event and most of us would like to be there and show our rabbits if at all possible. The ARBA Convention is not, or shouldn't be, a luxury for only those who can afford it! Many of us normal folk "scrimp" and "save" all year just to be able to go for just a couple of days!! Remember, this is my personal opinion! I'm certain that many of you don't feel this way, but we are all entitled to our opinion. In my case, I still have a son at home; - he is 17 (by only two months) but he is in school and I "kinda" like to be around when he is. We only have our children home for a short time as it is before they're out on their own and I like to enjoy that time. I also have a son and daughter-in-law that are expecting their first child in August, and American Dutch Rabbit Club mail that piles in daily whether I'm here or not. I find it hard to enjoy my time away from home knowing that I'll have a "basket" of mail waiting when I get back. I also have quite a few rabbits that someone has to take care of while I'm gone,.....not to mention two dogs! I'd like to see an early release at all ARBA Conventions. After all, if I'm not mistaken, if you have an early flight out, -- you can get an early release for your rabbits. What about the person who drove? Believe me, I "love" the Conventions dearly -- but I would like to see a few changes made that might enable more people to attend and "ENJOY"! In any case, if you have a good one, try to send it out with someone ---- but do try to attend! (In the meantime, if you would like to see some changes in the ARBA Convention, release times, etc., write your ARBA District Director. You have to speak in order to be heard!.....just do it nicely!)

I'd like to point out a few problems that I receive in this office. One of the main items is the fact that sanction request keep coming in later and later.....sanction requests should be sent in 60 days prior to your show date whenever possible. At times, 30 days would even be a blessing! Many of them do not contain an ARBA sanction number. These must be returned! The ARBA does not allow a specialty club to issue a sanction without a proper and valid ARBA sanction number. I could call and verify the numbers with the ARBA office each time, but a phone bill would soon hit an unexpected high. Therefore, these are returned for 22¢ but it delays the process even more.

Address the outer envelope to the American Dutch Rabbit Club C/O Norma Hart, 190 N. First Ave., Coal City, Il. 60416. Be certain to include your name and complete address on the "OUTER ENVELOPE". If this is not included, your ballot will become void. This is used only for verification and the outer envelope is taken off before your ballot envelope is forwarded to the Election Committee. Please follow the instructions on the ballot carefully, but PLEASE VOTE!

Check your Dutch Reporter label and the "Expiring List" in this issue and renew promptly. If your membership lapses for over 60 days, you lose all of your sweepstakes points. We don't want that to happen but it's a rule, and we have to follow it. Please check your expiration date. You'll find it on each Dutch Reporter label and your membership card.

For someone who didn't think that they were going to have anything to write about, I've said more than enough. I'll end, as usual with a quote: "Thank God every morning when you get up that you have something to do which must be done, whether you like it or not. Being forced to work, and forced to do your best will breed in you temperance, self-control, diligence, strength of will, content and a hundred other virtues which the idle never know." SMILE!

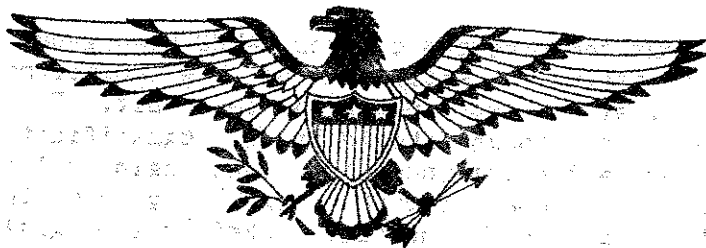

Director's Message.....ADRC Standard Committee.....1988 National Dutch Show

As there really isn't that much to report at this time, I am going to include a couple of other things in my Director's Message.

As for local news, it sure seems dead around here! Yesterday (July 1st), I judged my first Fair show of the season. This was after a 3 week layoff from rabbit shows, and believe me I was ready for it. Starting the 18th of July things will get pretty hectic with 13 shows in 16 days, but it gives me a chance to see members that I don't normally get to see. Remember, if you have any questions, comments, or concerns regarding the ADRC, let me know sometime when you see me, or write to me about them. If I cannot answer you, I will find someone that can. I hope to see many Dutch within the next few weeks, and am sure that they will be very competitive at the Best in Show level.

A couple of words about the progress of the ADRC Standards Committee:..There have been a couple of issues investigated by the Committee. Naturally, "cow hocks" has been an item kicked around quite a bit. To make a definite determination of when "cow hocks" should be a disqualification is very hard. One Committee member suggested drawings that might help realize this problem a little better. I would like some membership input regarding this suggestion. It was stated that perhaps we should add "cow hocks" as a disqualification in our BREED Standard, so as to emphasize it more. On the other hand, as one Committee member put it, we are not the only breed with this problem and by adding it specifically within our Standard perhaps we would imply that our breed was the only one with this problem.

Another area of concern to the ADRC Standard Committee at the present time is "freckles". This being a discoloration of the flesh, found mainly in the nostril or lip areas. I have seen these freckles many times, and as a Judge have given the rabbit the benefit of the doubt and passed these animals. It is of concern that the problem is getting larger, and more Dutch are appearing with this flaw. As the Standard states "Flesh spot or spots in either the white or colored sections" and "Distinct white spot or spots in colored section. Distinct colored spot or spots in white section. Spot or spots must be plainly visible.", some of the ADRC Standard Committee is leaning towards a disqualification for these "freckles". Another member of the Committee states though that if we are going to concern ourselves with something of this nature, what about the "pink" noses? I would also appreciate some membership input regarding this item.

The ADRC Standard Committee is working diligently to correct situations that leave doubt, but sometimes it is very hard and time consuming to come up with something that will be agreeable to all concerned.

A few words about the 1988 National Dutch Show:...There have been 50 rooms blocked at the Headquarters motel for the 1988 NDS. The Headquarters motel will be "Jack and Benny's Best Western Motel". It is located within walking distance of the showroom. A restaurant is located within the parking lot of the motel, and there are many eating spots very close by. The rates for the motel are as follows: Single adult - \$35.00 per night.....2 Adults - \$37.60 per night.....Each additional adult is \$5.00 extra per night.....Children under 18 years of age are free. Of the 50 rooms blocked, 30 have two double beds and 20 have a King size bed and a sofa bed.

As Bloomington is a college town, we will probably have graduation to contend with at that time of the year. The motel personal have informed me that they will hold these 50 rooms until April 1st of 1988. After that time, any room in the block that is not reserved will be released and anyone seeking reservations will have to take their chances. Sooooo, get your reservations EARLY!!! The direct phone number of the motel is 309-663-1361. There is also a toll free number you can call; 800-528-1234. Remember to tell them you are with the National Dutch Show sponsored by the Illinois Dutch Rabbit Club. We are really looking forward to seeing you all there.

I would like to remind all of you that the ballots for election and changes to the Constitution and By-Laws are contained within this Dutch Reporter. If you do it right now, it will only take 2 or 3 minutes to complete these ballots and get them ready for mailing. I really do not believe that asking for 2 or 3 minutes, plus 22 cents, is too much. If you are at all interested in this club and its functions, PLEASE take a moment or two to VOTE. This is a privilege that many people do not have, so exercise your rights and fill in the ballots. Then MAIL THEM OUT!!!

The hot weather of Summer is upon us, with it, breeding and raising young rabbits presents problems. Some tips I have found helpful for raising rabbits in the hot weather are:

1. Use young bucks -- fertility is higher
2. Breed does in the A.M. and then re-breed 8 to 10 hours later.
3. Remove the nest boxes with young in them and put them in a cool area during the hottest part of the day. Return to the does in the late afternoon or early evening.
4. Outside area with plenty of shade over a poorly ventilated building.
5. Carefully observe pregnant does near kindling time.

We are now in the middle of Summer, faced with the heat and humidity that goes along with it. The rabbit shows have come to a stop in this region, except for the State and County Fairs. The very first rabbit show for me was at the Ohio State Fair in 1981 with Francis Morgan judging the Dutch. Now days I attend the fairs as a spectator and not an exhibitor for several reasons. First, since most fairs are held during the summer months I feel that the weather is too harsh for the rabbits. The second reason, is diseases, some of the exhibitors at the fairs bring their animals just for the fun of showing it and may only pull the rabbit out of it's cage for the show and no other time during the year. The last fair show that I showed at proved to be costly, one of my bucks picked up coccidiosis and I lost a total of 15 rabbits before it was brought under control. Several other breeders suffered similat problems, with the cause pointing towards the fair show that we all attended. My last reason for not showing at local fairs is the conditions of the fair grounds inside the state of West Virginia. Since we are not a state of great wealth, our fairs are ranked as of little or no importance. Most of the fair grounds are stuck up a hollow or in the middle of nowhere with tents or sheds serving as buildings with little or no electricity available.

Although I don't show my rabbits at fairs, does not mean that I don't enjoy them. If it hadn't been for the Ohio State Fair (an excellent fair with very nice grounds), I wouldn't be in the hobby of breeding and showing Dutch. I also feel that the majority of fair grounds in other states are much better than the ones West Virginia has to offer.

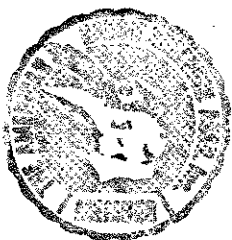
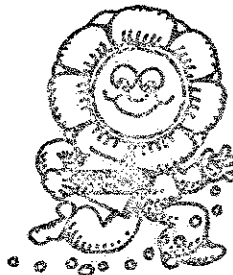

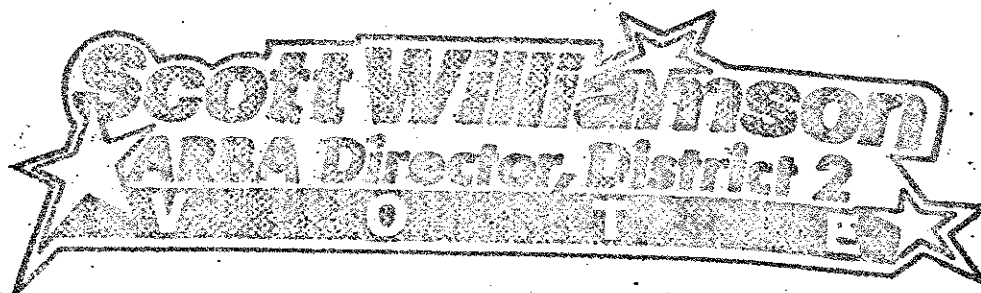

Either your copy didn't arrive in time to express your point of view in the form of an article, you don't care one way or the other, or you didn't read that section. I have a few things to comment on and I hope you read them before you vote. Please remember these are just my own personal feelings about the issues to be voted upon.

1.) LIFE MEMBERSHIP: The way it's proposed, a person is going to be at least 50+ or 65 years old to receive this honor. I personally would like to see one or two issued to outstanding or deserving members on an annual basis by the Executive Board. We have several breeders within our membership that should receive this honor before they die or are too old to enjoy the recognition.

2.) ALTERATIONS of or AMENDMENTS to the CONSTITUTION and/or BY-LAWS:

I agree we need to do something different with our form of voting on issues, to allow additional time for discussion and comments from the members. But 25 signatures of A.D.R.C. members in good standings is a bit too many. I checked out all of the March show reports before they were printed in this issue and it would take some of our members forever to get the number required to sign their proposed change. My math isn't the best, but the number of A.D.R.C. members per show worked out to just a little over 4 exhibitors. You could mail the proposal to several members but you would have to send out nearly 50 to get 25 members in good standings to reply -- maybe more if they reply like they vote! Sorry to sound sarcastic but the figures are proof! I know it's hard to keep up with all the changes but they are made to prevent loopholes...In the event of trying to clear up the matter and prevent the same thing from happening again, the voting has become complicated. I think we could print proposals in two or three issues and the membership would have time to respond with their comments pro and con.

However you feel about the issues, please vote in this election.

Kay's Comments, cont.....

I have spent several hours putting this issue together due to the ballot, I hope at least half of you will take the time to send it in. Less than 10 percent of the open membership got involved and I know more than 7 youth members will exhibit their Dutch at the National Shows they are selecting Judges for. Whether you plan to attend or not, try to select the very best person to judge your breed for your fellow exhibitors. In 3 or our Districts you will find 'write in candidates'. It's sad to see Tom Dietrich had declined the nomination but he has served the A.D.R.C. very well during his terms. I know of several members within District #8 (Ohio and Michigan) that would make excellent Directors, I wish I could cast a ballots for one of them. I'm sure the members from Districts #4 and #6 will have members that will make good Directors -- write them down!!! Maybe it's time for members to start petitioning for the offices. At least the membership would know who wanted to be an officer and why they were seeking the available office. Usually the person that took the time to write a little about themselves and what they would like to see accomplished, will make good officer material. Just remember to write in a person that will be able to attend the National Shows during their term of office.

Next issue I would like to start with 'COLOR' articles, everyone knows alot about black, so let's start with TORT...Send me your TORT ARTICLES. Until next time, KEEP YOUR BUNNIES COOL!!!!

CESAREAN BIRTHS IN RABBITS

Recently, due to heat, we had a doe stress. Naturally she was heavy with unborn young - due to kindle the next day. I had checked on the herd about 3 p.m. and again at 6. At 6, I found her, groggy and acting strangely with a bloody tinge around the nostrils. We poured and rubbed luke warm water over her body. She acted better, sitting up but then lying on her side, being too weak to sit for any length of time. A choice had to be made. We could tell that she would not have the strength to deliver a live litter. If by some miracle she did deliver live babies, she wouldn't have the strength required to nurse them. What to do - save the babies through cesarean, losing the mother or if left to deliver her unborn kits herself, possibly loosing the whole group.

Vern was assigned the job of putting the doe out of her misery. Paul was sent to the house for necessary equipment; a sharp knife, towels and a large plastic bag. I got a nestbox ready putting in a small amount of straw and a clean hand towel.

The plastic bag was laid out on the work table and the doe was placed on it. While there was still involuntary muscle movement, Vern carefully inserted the knife at the base of the belly, close to the vent. He worked toward the front legs, making sure to only cut the top layer of skin and fur. Next was the second cut. He lifted the layer of skin protecting the kits, cutting slowly in the same direction as before. This skin was much easier to cut. Immediately we could see the kits in the birth canal. Another incision was made into the casing that covered the unborn. Only a small prick, then enlarging the length of the incision. One by one, each of us would take an individual kit, still enclosed in the birth sack. They were hard to hold onto the slimy, wet sack. We pierced the sack with a fingernail. Then we peeled the sack off the entire kit, leaving only the umbilical cord. With a pair of shears, the cord was trimmed, leaving about 1/2 inch of the cord. Make sure to clean all of the membrane from the area around the nostrils. Most comes off easily but if some remains, a wipe with a soft towel around the nostrils and mouth will usually get the newborn breathing. On occasion, an animal will refuse to breathe. By holding the bunny about 1 to 1 1/2 feet away from your mouth, you can blow gently but with an even breath. It will grasp for it's breath. Watch this kit to make sure it has taken several breaths before going on to the next. As soon as a kit was reasonably clean, it was placed in a nestbox with straw and a soft hand towel. The towel keeps their delicate bodies from being scratched by the sharp points of the straw. Remember, mother pulled the fur movement encourages them to continue to breathe. The other animals assist in cleaning them when we didn't have the time to do a good

job. After all the babies had been pulled from the sack, we had a chance to count just how many new arrivals we had. This chocolate doe produced 8 nice Dutch. They were a bunch of wiggly-worms.

Our next problem, once the doe was buried, is to find a foster mother. One advantage of raising rabbits versus a calf or horse, is that you have about 24 hours to find a new mother. Newborn kits do not need closterum. Any does milk will do. We had several does who had kindled 2-5 days prior. All of their offspring were too large to share a nest with the newborn kits. We checked over the litters we had, eliminated some of the poorly marked animals, and gave two litters of the same size to one doe. I know you've heard the stories about does rejecting fostered bunnies. The majority of does, when uncomfortable with milk are happy to see any baby rabbit that will relieve them of that milk. If a doe acts suspicious of the additions to her nest, remove the nest, setting it in a safe place for as many as 12 hours and then return the nest to her cage. With the discomfort she's feeling, she'll never check to see if it's an English Spot, Checkered Giant or Dutch. We then transferred the new kits into the old (used) nestbox and a new foster mom. I gave the doe a handful of hay to munch on while we slipped the new bunnies into the doe's coop.

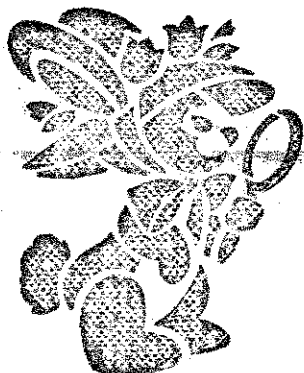
If this sounds like something that is beyond your ability, don't kid yourself. This was only our second attempt at cesarean births. The first one came before we knew how to palpate and butchered a doe who was due the next day. Even being unprepared for that birthing process, we were able to save a big part of the litter.

Most of us complain that our local veterinarian only has knowledge about cats, dogs and horses. If this is true in your area, what do you have to lose by trying it yourself? You've saved yourself a large veterinarian bill, you've gained experience, and very possibly, you have a new litter of beautiful Dutch bunnies.

During a conversation with our vet following the cesarean births of these 8 kits, he asked if we'd call him the next time we did one. He says he never seen one on a rabbit. Who knows, if we share our information, we'll all get smarter.

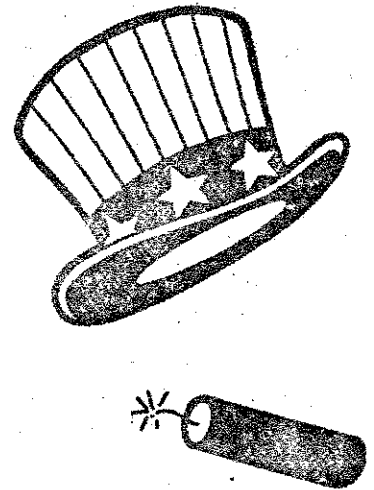

A GOOD DUTCH SHOULD HAVE NICELY ROUNDED HIPS, VERY SMOOTH, ROUNDED UNDER VERY GRADUALLY AND SMOOTHLY. THE DUTCH SHOULD RETAIN THE COBBY, STOCKY APPEARANCE WHETHER IT WEIGHS $3\frac{1}{2}$ POUNDS OR $5\frac{1}{2}$ POUNDS.
