BREEDING BLACK AND BLUE DUTCH

In a recent Dutch Reporter your secretary mentioned that she could not find any articles on the breeding of blacks and blues. Our club has an educational committee, of which I am chairman, and should there be subjects you wish discussed I am sure that I or one of my committee will be happy to assist you. Through the years I have written many articles on the care and breeding of Dutch and find it hard to write articles that will not be a repition of what I have already said.

In the many years of breeding and exhibiting Dutch I have found two things to be

true -- neither Dutch rabbits nor people change very much.

There are a few simple rules to follow: ond one of these which I stress very highly is -- what goes in is sure to come out. I know there can be nothing more discouraging than to purchase a Dutch doe of any color, wait for the doe to kindle and find that you have all the colors of Dutch in your litter box.

You will find that all colors of Dutch will breed true to color with the exception of the steel grays, which is a "made" color. There is no doubt that the blacks are the most popular of colors. This is the dominant color and is used in breeding

blues, chocolates and steels.

There are two kinds of black — one is the true breeding black. This is a black, that regardless of what it is bred to, will produce nothing but blacks. You could take a true breeding black, mate him to several hundred blue does and never get anything but blacks out of him. However, not all of his off-spring would be true breeding blacks. The only way to test them is to mate them to several blues and if all the off-spring are black then that particular animal is a true breeding black. This is the same method used for testing woolers in New Zealands. I, myself see no advantage in these true breeding blacks, except that you will generally get much darker eye color from them. I am mentioning this because there are some breeders who wonder why they get no blues out of a black to blue mating from certain blacks.

In the case of blues the outcome is a bit different. Since blue is recessive, mated blue to blue it will produce nothing but blues. In all my years of breeding I have yet to see a black in a litter of blue to blue mating and have yet to speak to a breeder that I know personally, who would dispute this statement. However, in one of our special editions of Small Stock Magazine, Allen Sole made mention in one

of his articles that he had known as many as 7% black to come out of blue to blue mating. I can only attest to my own experience and to that of many breeders I have

known over the years.

When mating black to blue a common fault is the resultant speckled eyes. To combat this I have resorted to using a blue that comes from a black to black mating (other than the true breeding black), and you will find it quite common to get blues from such a black to black mating. These blues are generally your best colored blues, and when mated back to black, improve the density of color in both blues and blacks.

I know that there are many successful breeders that breed only black to black, but in my experience carrying black to black matings too far has a tendency to produce blacks that do not hold their color. Likewise, blue to blue matings will result in mealy colored ears, and a kind of silver-blue that does not last long.

It is hard to describe what is wanted in a blue. You will find some that call for a second look to distinguish them from a black. They also have a tendency to show a rusty cast to their coat when not in full bloom. There are also those that are too light — those with the silvery cast and the mealy ears. The ideal is a happ y medium, and you will find that this is the color and shade that will look good and last well.

The production of blacks and blues is a very trying problem and calls for strict attention to the selection of breeders. Blacks that carry any white hairs should not be used, especially in your buck, for he is to be used on a number of does. A point often overlooked in blacks is eye color — these should be as dark a hazel as possible. Many of them are too light and can be traced to the use of too much blue blood, which also results in speckled eyes in both blacks and blues.

There is no teacher like experience -- just keep on trying to breed them better than those you have.

A FEW TIPS ABOUT DUTCH AND JUDGES

I wish to explain in this article my thoughts so someone can get some good out of it and raise better Dutch for show. Just a few lines to prove I have the qualifications to express a few of my views. I have been raising rabbits for 35 years (all kinds, but Dutch are my favorites). I have lived on a farm all of my life, have been raising the finest quality mink for 17 years, in fact have raised fox, coons, fishers, and skunks for pets all of my life. I have had 17 years of trial and error in raising the worlds best jet black mink, and have topped the worlds fur market in New York city with black mink and dawn pastel shades for the last two years.

What does this all mean to you readers who raise Dutch? It means it takes years of experience to know color on any animal be it rabbits or other fur bearing animals. This word color is a big one in Dutch. To get color and type on any animal (I refer to Dutch) one must have a picture in mind of what is desired and to recognize one when you see it. A Dutch breeder must decide what color or colors he wishes to raise. The steel Dutch is the most difficult to produce in quantity for show purposes. It was stated in the April issue of the Dutch Reporter that the tortoise Dutch needs the most improvement of all the colors. I say it is the steels, because they are harder to produce and there are less of them around the country. The tortoise is more common in the shows today and there are some good ones around, BUT just look for good steels -- you won't find many at any show, even at Tampa only one is listed on the show report.

The tortoise have come a long way down the road but the steels are raised by only a few who can stand the hardships of trying to get a good one in a good breeding

program.

Blacks are the cream of the show table and one must have fine blacks to compete for best Dutch in any show today. Most judges will place a black best Dutch at most shows, the show reports prove this in the Dutch Reporter. When cor ered after any show most judges aay that the other colors can't stand up to a good black. Here is where I say the judges are wrong -- as there are better Dutch on the show table than

a black, the best steels can trim up the blacks any old day, if the judges had the nerve to place them so. Here at Dutch Erook color and type are the top consideration. We breed black to black with some blue to tone the color. In the blues we want a clear rich blue, not too dark. In the grays we want medium gray, in chocolate we want a rich colored chocolate (no rust). We do not believe in breeding chocolate to black as the blacks from these crosses will have a brownish cast, and we want no chocolate in our black breeding program. We prefer jet black to jet black for the best blacks. In steels we like a medium dark steel -- if too dark they lack ticking and run very dark over back and ears. The use of a blue gray buck to a steel will produce some of the finest steels. Too much blue in the bloodline will cause spots in the eyes, the blue Dutch cause all of the trouble with eye specks, spots or moon eyes because it has been introduced too strong in most lines of breeding Dutch today. By using a good blue with a good black steel in pedigree you will find the first cross will result in all blacks. Breed the black does which are halfblood steels back to a steel or blue gray and you will get some dandy medium dark steels. With medium ticking and get rid of some of the brass on the legs. One must not use a good steel or gray in his fine blacks or they will be ruined, as Dutch from such a mating will have far too many white hairs in the black color.

By using gray to steel some nice medium dark grays, will be produced but the steels from such a mating will be brassy or rusty or meal bag color half way between steel and gray which one does not want for show. Color and type are the foundation of good Dutch today, YOU MUST HAVE IT.

Now a few lines about judges who have pet colors in Dutch when judging. Very few judges have the nerve to place a good steel or gray best Dutch or best opposite Dutch in any show. (Check your show reports for proof.) Are they afraid of offending the breeders by placing a lowly steel or gray best Dutch? Anyway their next judging assignment may depend on pleasing the many not the few. Most judges do not know steels or grays or how hard it is to produce a winner in these colors. Most judges when selecting best Dutch will line up all the best of each color plus best opposite of each color, and you guessed it: the steels, grays and tortoise are tossed in the ash can without consideration, leaving only the blacks and blues for all the honors. 50% of the judges are not well enough acquainted with Dutch to have an eye for color in varieties other than black and blue. Neither do some of them pay enough attention to the disqualifications of Dutch. For proff, last year I showed a Dutch with a spot in one eye below the lid in five straight shows and five different judges placed this rabbit. I did this on purpose just to see what would happen and proved to myself that these judges needed some education in Dutch judging. I also showed other Dutch with split stops, caught on fore leg and all passed with flying colors. places such animals they are eligible for registration, or so it seems.

If a judge hasn't raised Dutch he or she better bone up because I say Dutch should be judged by the point system and by a man who knows and raises Dutch. I am a man like Mr. Collins, I have the guts to stand up and fight for what I believe no matter what the odds.
