

The 1970 National Dutch Show was awarded to the Iowa-Minnesota group. The show will be held in Mason City, Iowa. They will be announcing dates soon. This area is getting to be a hot-bed of Dutch. Expect that they will have a very nice show and they have several in their group that know how to put on a good show. It is to bad that we can't have two National Dutch Shows a year as we also received a very nice bid from Denver, Colo. headed by Pat Herman. Hope they see fit to bid on 1971 show.

You will notice in minutes that our Vice-Pres. Al Meier Jr. has tendered his resignation. Al's reason was that he is very busy and unable to attend meetings. I accepted ed his resignation and appointed Mike Stinehelfer to complete the unexpired term. This was approved by all the Board present and the rest my mail.

The Board saw fit to approve the condensed show reports as the cost of printing and mailing the D.R. has gone up pretty regular. Our advertising rates will be doubled the first of July. Old rates cost the club money. We have set up a budget for the D.R. which will come out of the General Fund. This will be reviewed at each meeting of officers.

The Board instructed Publicity Committee to turn over \$400.00 to the Guide Book Committee. The Guide Book was to go to press as soon as possible after the show. Mrs. Weinhardt, our Sec'y. and Guide Book Chairman has been busy moving, getting a new rabbitry built as well as a new house. Hope she can get the Guide Book to printers soon, if this has not yet been done.

The fifth member of Dutch Standards Committee is Pat Herman. He has accepted the appointment. Time is short for any changes. If you want any, better get them in to our committee. I understand that any changes will be taken up at the A.R.B.A. Borad Meeting in Calgary.

AMERICAN DUTCH RABBIT CLUB, Ludington, Michigan, April 25, 1969 Minutes, Board of Directors Meeting.

The meeting of the Boardlof Directos of the American Dutch Rabbit Club was called to order at 10:p.m. with the following officers present, President, Don Reid, Secretary Treasurer, Jessie Weinhardt, Directors, Doris Leibel, Stanley Goeglein, David Paul. Absent were, Vice President, Al Meier Jr., Directors, Don Lovejoy, Clyde J. Jones and W.R. Griffith. Also present were Publicity Directors, Barbara and Jim Walker.

A motion was made by Doris Leibel, seconded by Stan Goeglein to dispense with the reading of the minutes of the previous Board Meeting since they had been published in the Dutch Reporter was carried.

Since there had been a correction in the minutes of the previous general meeting since publication, the correction was read and the minutes were accepted on a motion by Doris Leibel, seconded by David Paul. Carried.

Under reports of officers the Secretary reported that we now have 690 members and have sanctioned 142 shows since the Convention which is more than have ever been sanctioned in a like period.

Dutch Reporter Editor, Doris Leibel, reported that she had about enough supplies for three months.

The Publicity Committee Co-Chairmen, Jim and Barb Walker reported that they have now received all of the supplies that were outstanding. They were asked if they had ever purchased a Bond and after some discussion it was decided that Publicity and Dutch Reporter Editor offices should be bonded for \$1,000.00 each.

After some discussion regarding the publishing of old Sweepstakes reports in the abbreviated form as in recent Dutch Reporters, the Board, on a motion by Stan Goegelein, seconded by J. Weinhardt, voted to sanction the decision of President Reid and Editor Leibel in this regard. Carried.

There was a motion by Dave Paul, seconded by Stan Goeglein that due to the ever increasing expense of the Dutch Reporter we continue to publish these show reports in this form with the exception of the National Dutch Show and the Convention Show reports until time and finances permit the publishing of complete reports again, carried.

Two bids for the 1970 National Dutch Show, each with equal merit, one from the Iowa-Minnesota group of breeders, for the show to be held in Mason City, Iowa and one from a group of Colorado Breeders headed by Pat Herman for a show to be held in Denver, Colorado were read. Final decision was withheld pending a polling of the entire Board.

President Reid then read a letter from Vice-Pres. Al. Meier Jr. tendering his resignation from office. Same being accepted by President Reid with a tentative appointment of Mike Stinehelfer to fill out Mr. Meier's unexpired term. Such appointment pending approval of entire Board.

A proposed budget for the financing of the Dutch Reporter was discussed. It was agreed that such a budget should be set up semi-annually (at National Dutch Shos and ARBA National Conventions) and that a trial sum of \$200.00 on June 1st, 1969 and \$200.00 on Sept. 1, 1969 should be turned over to the Editor by the Secretary-Treasurer from the general fund for operational expenses.

Financing the new Guide was discussed and it was reported by Chairman Weinhardt, that we secured about half enough advertising to pay for 1000 copies. Since the supply of old Guide Books was completely exhausted and since the Guide Book was our "Best foot forward" in publicity, the Publicity Committee was instructed to turn over \$400.00 to the Guide Book fund and the Chairman was instructed to send it to press

Board of Directors Minutes continued. immediately after this Convention and Show.

The question of honorary memberships was brought up and there was a motion by Stan Goeglein, seconded by Dave Paul that an honorary membership (Life) be granted to $R_{\bullet}D_{\bullet}$ Humbert of Huntington, Ind.

Adjournment on a motion by Dave Paul, seconded by Doris Leibel at 12:20. Carried.

The regular meeting of the American Dutch Rabbit Club was called to order by Pres. Don Reid at 9:10 p.m. with the following officers present: President, Don Reid, Sec'y-Treas. Jessie Weinhardt, Directors, Doris Leibel, David Paul, Stanley Goeglein. Absent were, Vice-Pres. Al Meier, Jr. Directors, Don Lovejoy, Clyde J. Jones, W.R. Griffith.

There was a motion by Alan Miller, seconded by Jim Walker that the minutes of the previous meeting be dispensed with since they had been published in the Dutch Reporter. Carried.

A motion was made by Barbara Walker, seconded by Stan Goeglein that we dispense with the reading of the minutes of the Board meeting from Pueblo as they had also been published. Carried.

The minutes of the Board meeting held the previous evening were read and approved on a motion by Alan Miller, seconded by Jim Walker and carried.

The report of the Publicity Committee was read and accepted.

The Guide Book Chairman reported that we would need 2000 copies rather than 1000 and the cost of same is to be investigated.

There was an explanation of the Guide Book and Dutch Reporter expenses and it was explained that the Dutch Reporter was barely breaking even on its advertising. (i.e. charge for advertising was barely covering production cost) It was also explained that the Dutch Reporter Committee had full authority to regulate advertising ingrates and should take such steps as deemed necessary to make the advertising a paying proposition.

There was considerable discussion of the procedure for selecting Judges for the National Dutch Show and Convention Show. It was felt that members were casting votes for Judges who never attended these shows and had no conception of what the job entailed. The suggestion was offered that the members present at one such show select the Judges for the next one. This was felt to be undemocratic so Mr. Reid appointed a committee of Stan Goeglein and David Paul to explore possible alternative methods.

Volunteers for Breed Superintendent and Breed Secretary for Calgary were Mike Stinehelfer and Doris & Linda Leibel respectivally.

Meeting adjouned at 10:00 p.m. on a motion by Stan Goeglein and seconded by John Nelson. Carried.

REMEMBER WHEN by Tom Shufflebotham......

(a portion of the Show Report of the ADRC National Dutch Show, Indianapolis, Ind. Nov. 1-5 1944.)

Judges: George Bayliss, Hayward, Calif. & Carldon Gaddis, Richmond, Ind. Show Secretary, Ancel Beaver - Show Supt. Lary Bivins.

Our show was well attended by the members, some of them coming quite some distance. Delbert Peck and Johnny Baker from Rochester, N.Y. The entry was not as large as was expected and I understand this was due to the condition of the rabbits at this time, but all in all it was a fine showing of some righty fine Dutch. As most of you know Dick Bernhardt judged the Dutch in the Indianapolis show and the following day Bayliss and Gaddis the Dutch Show, beleive me they really looked them over. Judge Bayliss was Was over three hours on the Sr. Black Buck class. Bernhardt had disqualified several the day before and these two judges were not passing up anything. The disqualification Club was started while Bernhardt was judging and the next day it was renamed the Spot Club and if they missed making anyone a member it was because he didn't have anything entered. Most of the disqualification were for white spots in the colored section, but R.S. Gibbons won the the blue ribbon for spots as he had one with a black spot in the white. Even Judge Gaddis had on disqualified and the only reason they didn't make Bayliss a member was because he didnt have any there. But fellows, if you want to meet a fine bunch of sports you missed something by not attending this show. I did not hear one complaint about the Judging and if anyone had any thoughts of complaining they kept it to themselves. Everyone took his setbacks with a smile. These three judges did a fine job of judging Dutch at these two shows and are to be complimented and they were not as far apart as you might think, for example, the first Sr. Black Bk. in the Indianapolis Show was third in the Dutch Show with the first and second place buck not showing in the Indianapolis Show. One of the busiest and I guess the Happiest fellow at this show was Johnny Baker of Rochester, N.Y. Every time you seen Johnny some older breeder had him in tow and was plying him with questions and Johnny did not fail to ask a few himself, here is a man or should I say boy, as he is only 15 years old, that is going to make himself a name in Dutch. I think his favorite color is Tortoise and from his record in this show he really knows them. The annual Club meeting was held on Saturday evening Nov. 4th and I was told this was, the largest meeting in the history of the club. The seting was called to order by Pres. A commentary by Judge Doris Leibel......Reading the forgoing article brings so many thoughts to mind. Ive been stewing about this one for some time. Why do we have to go from one extreme to the other? From an overly strict to an extremely lax interpretation of the Standards. I've been around long enough to have gone through both phases yet? I can't compromize my thinking into deliberatly letting a general disqualification pass without calling it. Then to be told that this rabbit was Best of something just a week before makes me wonder what goes on here. I'm not thinking of changeable disqualifications but spots in eyes, screw tails, missing teeth etc. I hope that we are approaching an era of reasonable judging. Yes, the animal should have every benefit of doubt, but when there is no doubt, it should be disqualified. How clse will the new breeder know the problems involved. Any Judge who figures that he is being a good "Joe" by being lax is hurting no one but him or her self. Our Standards are written by people who are supposed to know the reasons for what these standards contain. Let's see a little more judging by standard. I can make enough mistakes unknowingly without ressing disgualification
