

It is interesting to note as we see the show sanctions and reports come and go, the different "rabbit show seasons" around the country. Our slack period is during the winter cold, the southern areas have a slack period during the summer heat, and a few areas have shows pretty much year-round. Would be hard on the animals, but I suppose a person could pack up his show string and just go around the States taking in the shows and keep going year-round. I think that perhaps the rest period between the show seasons works out best for us though, gives us a chance to catch up with things and to revitalize our interests with a chance to relax.

Many, many things have happened that need reporting to the membership. We are happy to announce that we are getting tremendous support from the people that make the Dutch club what it is - you and the rest of the Dutch breeders. The membership is rising rapidly. I would still like to urge you to make an active effort to recruit both new members and those who have belonged before. Ideally, everyone that has and shows Dutch should belong. As long as I am talking about sending things in, Please use CHECK or MONEY ORDERS. Cash is acceptable, but dangerous, as it is easily "lost" in the mail and there is no way of checking or tracing cash.

The National Dutch Show was a tremendous success. Not the largest in entries, but a very enjoyable show, with everyone having a wonderful time. My hat is off to those Texans, they may boast a lot but they also follow them up. I know they were a little disappointed in the size of the entry and it is a little unfortunate that there was not more support. Those of you who do no participate in these yearly events are really missing the boat. I can personally vouch for the fact that the N.D.S. is an event well worth attending. Try to make it next year, or at least when it comes close to your general area.

Several things were decided at the board meeting at Houston. For the full particulars see the minutes of the meetings. Briefly, some of the things changed are; the sponsoring club of the N.D.S. may select the Junior Judge, while the Senior Judge will still be elected by the membership as usual. We will publish full show reports of any show with over a hundred entries. We will have a constitutional revision taking place in the near future.

Also, I am proud to announce that the Board of Directors has awarded life memberships to four members who have given long and faithful service to the club. They are Carldon Gaddis of Indiana, Robert Sprague of California, J. C. Lowit of Oregon and William Stedman of New York. All of these members have over twenty-five years of membership behind them and we wish them the best of luck for the next twenty-five, we thank them.

As you know, the election nominations are taking place. By the time you receive this bulletin, the election nominations will be complete. The candidates will be notified to see if they will accept office if elected and ballots for the election will be mailed on August 1st. Again, check your membership to insure that you are up to date. You can save the club the cost of the notice if you will renew prior to having to be notified. You may also renew for more than a year at a time if you so desire. You will receive the next issue of the D.R. in August. The candidates will have their chance to advertise, or whatever, in that issue and perhaps you would wish to wait for that before sending in your ballots. # COMMENTS' OF A DUTCH JUDGE by PAUL J. JURGELONIS

The recent article by John Mellozo regarding the comments found in many of the Dutch Den News Columns prompted me to write a reply. First, let me say that I am a fan of the cobby small type Dutch and I have often admired the stock shown by Mr. Mellozo. I must also admit that the Den News seemed to be promoting the larger specimen. However, I don't think that it was ever stated that our standard should be altered, nor was it stated that a five pounder or a five and a half pounder is better than our ideal of four and a half.

I must say that it was nice to see the other side of the issue. However, I must point out that there were several comments made which I just couldn't agree with and should not be left un-noticed.

The first item which I disagree with is the size of the ideal Dutch. Our standard calls for  $4\frac{1}{2}$  lbs for the ideal weight. This to me is a happy medium between the mighty midgets and the giant size. I am quite sure that most judges and breeders agree that this ideal is adequate and should be maintained. I also can bet that judges will tell you that they have seen cobby ones at  $3\frac{1}{2}$  lbs. all the way to  $5\frac{1}{2}$ . Cobbiness has nothing to do with the scale. The only time that the scale should be taken into consideration is if the animal is underweight or overweight. Cobbiness and type is the general appearance of the animal, the shape of the animal. Not all  $5\frac{1}{2}$  lb. Dutch are rangy. Most judges will admit that some  $3\frac{1}{2}$  pounders are also on the rangy side with ears out of proportion, narrow heads, etc.

Another item in the same paragraph which I disagree with is equating grizzled ears with size and weight. I have seen grizzled ears in all sizes of Dutch. This to me is a factor more related to color than to size and weight.

I think what upsets me most about articles such as John's is that the facts are expressed in black and white with no considerations for the gray areas in between. Nothing in life is perfectly right or wrong. I think we fall into this error when we use too many generalizations. This same technique was used when describing those Dutch which mature below  $4\frac{1}{2}$  lbs. Not all  $3\frac{1}{2}$  lb., Dutch are good Mothers. Not all  $5\frac{1}{2}$  lb., Dutch are good in every way either. You'll find rotten apples with the  $4\frac{1}{2}$  lb., Dutch too. Bad teeth and cow hocks can be bred into or out of any size strain, just like all the other genetic defects listed as disqualifications.

So, what's the answer? Let's all get behind our breed 1,000% and promote the Dutch. Whether they are  $3\frac{1}{2}$  or  $5\frac{1}{2}$ , if they have the proper cobby shape, then they have good type regardless of size. Let's stop using propaganda techniques such as name calling, glittering generalities, card stacking, etc. If we are to remain an active viable club, then we'll all have to pull together. We all know what good type is. If we don't then we have a clear excellent standard to consult. If some of your are still confused, then I'd suggest that you visit the top breeders in your area, and see one in the flesh while re-reading the standard. You'll soon have the ideal set in your mind.

YOU CAN'T BEAT THE DUTCH

### EXHIBITING PRACTICES

My husband and I after breeding Dutch for nine years have recently began to exhibit quite frequently and if I may say so quite successfully, in our local shows.

At a recent show, we couldn't help but notice some of the exhibiting practices of a few of our larger Dutch breeders.

We noticed that one local breeder, always ahead in sweepstake points, had several (almost half) of his entries disqualified! Buck teeth and unbelievable marking disqualifications, really looked bad on "Dutch Row" to spectators who in my mind are always, possibly, future breeders of our great breed.

Are breeders like these greedy for sweepstakes points, premium money or what? They sure aren't doing the breed any good either, plus wasting the judges, show secretarys and everyone else's time and effort.

Is there any way we can join together to help eliminate this type of disgrace to our wonderful breed?

I understand that an inexperienced breeder may exhibit a rabbit with a serious marking or bad teeth, that's the only way they learn. But this, from veteran breeders?

Is there anything we can do for we are very concerned.

I've sworn I'd never get into another argument or say anything about someone else's opinions on Dutch.

Mr. Mellozzo makes my eyebrows raise slightly. He makes me believe I have done wrong in my year os so of breeding. I'm not smart or of even high intellect so I really don't know what I'm talking about. I do wish I had an answer for a couple of questions. WHY is the 4½ pound Dutch racy? WHY has the 4½ pound Dutch have a long head & ears? I've seen Karl Sautters make the choice between a Choc. and Blue Junior Bucks that both were over 4 pounds. He never mentioned grizzled ears except when some "Dum-Dum" entered a buck that had as much white as color on the ears. I see no reason a 6 pound Dutch or even larger couldn't have proper type. I'll admit the small Dutch are easier to get type on. Yet Mr. Mellozzo with poor type goes back & says  $3\frac{1}{2}$  to  $4\frac{1}{2}$  gives 6,7 & 8 to a litter. Remember the  $4\frac{1}{2}$  with no head, ears or type just a junk Dutch. He is contradicting himself. should have been caught at a proof reading and returned to the gentleman for his confirmation. Sometimes someone writes something in anger or is very tired such as getting home from a show after having a runt thrown off for underweight. I can understand this.

Now, I'v e just got going real good again after moving. I have in the past kept a few pens for small Dutch. These records are kept just as my decent Dutch records. After breeding  $3\frac{1}{2}$  lb. Dutch for 4 years I do have a few Does that will produce 7 to the litter. The young are  $1\frac{1}{4}$  to  $1\frac{1}{2}$  inches long at birth. The heaviest Dutch I have had from these in the last year and a half is 2 lb., at 5 months old. These does when bred to a decent buck can't pass the babies. A real good buck kept from these failed to produce young large enough for the show table or the eating table. The Netherland Dwarf already has a Dutch class so why mess-up a decent breed because a few people breed for markings alone.

My decent size Dutch put meat in the freezer and also show fairly decent (once in awhile). They pay the feed bill very easily. I don't have good Dutch as I've never raised the perfect one. Maybe someday someone will change the standard so mine are perfect.

Incidentally, I have won BOB by the scales. The only win I ever felt bad about. The lady that owned the other animal was such a good sport it made me feel like H---!

Now the Dutch sure as Heck aren't on the up grade in the country. The standard will be lowered. Too many people don't have the patience to breed for type, weight and color. The markings will turn up sometime. When they do, you got it. A very well marked Dutch isn't worth a D---, with the wrong type. BUT, what will you do with a smaller Dutch? Hold it over the French Frier by the hind-leg and eat it on a toothpick? You people may have the answers. I haven't I just can't swallow this article and this is said with all due respect to a senior breeder. (CONTINUED)

THEY know how to "Breed" but YOU have to be smart enough to know what they are to "Breed" to.

### NOW ITS YOUR TURN

Having always been interested in the Dutch Rabbit there was just 1 color that I never had in my rabbitry and know very little about—the Chocolate Dutch.

Oh Yes, I know about the markings, type, etc., but what about breeding and offspring? When breeding Blacks and Blues, you can cross them over without significant complications, perhaps a spotted eye once in awhile, but many big breeders do it all the time. I follow the 3 litter plan color line. To make a long story short, I purchased some Chocolate Does (2) that were marked well but had two The faults were 50% stops and even though they had good type, they were small physically (3 3/4 #). I also had purchased a buck, 4# Chocolate, but he also had 50% stops. I bred one with the chocolate buck and produced 8 young, all chocolate, with steps 50% or more. I discarded this litter at 3 days old. I personally can't stand long stops even if less then 10 points were allowed. The other Chocolate Doe, I bred to a black buck 41#, and she produced 7 Black of which I am keeping 4. The four have stops that are \( \frac{1}{4} \) to \( \frac{1}{3} \). I plan, in about 3 months to breed the mother (Chocolate) to one of the two sons (Black) in obtaining Chocolate young. Hopefully I should obtain three quarters of the young, Chocolate, with hopefully 50% short stops. Well at least I am optimistic. Knowing all the variables in the pool of genes, I stand a chance of producing an outstanding (CONINTUED)

Chocolate and if lucky enough a buck.

Another problem that I anticipate is what to do with all the Chocolate bred blacks I produce. I understand that they shouldn't be bred to Black as it will give the Black the light yellowish cast, which by the way, the litter now exhibits. The Black-Chocolates and my other Black-Black, are entirely different shades. After asking this question, I have probably answered same in that the Black-Chocolates should only be bred to other of their kind or Chocolates. I am really afraid to cross this into my Blacks and Blues, although some breeders have, successfully (Mr. Cook, of Milwaukee). Hopefully I will be able to put a decent chocolate on the show table by the late fall shows and the National Dutch show in the Spring of 1976.

I would appreciate any constructive criticism from Chocolate breeders in the form of a reply.

# BOARD OF DIRECTORS MEETING NATIONAL DUTCH SHOW - APRIL 25, 1975

The meeting of the Board of Directors of the ADRC was called to order at 8:00 p.m. by President Stinehelfer, April 25, 1975, at the National Dutch Show, Houston, Texas.

Members present were Stinehelfer, Bengton, Guetschow, Reid, Eich and Geitzenauer. Members absent were Lovejoy, Shufflebotham and Cooper. Others in attendance, Leibel.

The minutes of the previous board meeting were read. Reid corrected the motion he made referring to the appointment of the DR Editor and Point Keeper to read as follows: Regardless of the election outcome, the board requests that the President appoint a Dutch Reporter Editor and a Point Keeper, as of January 1st, 1975. Minutes were accepted as corrected.

The minutes of the last general meeting were read and approved as read.

The treasurer's report was presented.

The Secretary's report was given. The affairs of the club are bouncing back rapidly. We are securing new members and renewing lapsed old members at a good rate. There are still many details to be worked out in the association's activity but this is progressing well.

Motion by Bengtson seconded by Reid, that the Secretary be instructed to write the Kahlers, the Dutch Reporter Editors, a letter of commendation on the fine job they are doing. Motion passed.

Motion by Reid seconded by Geitzenauer, that the Kahlers be allowed to initiate booster ads, as they are the editors of the DR and may set policies of this nature. Motion carried.

There was a discussion of the payments to be made to the Kahlers for their work on the DR. Motion by Bengtson, seconded by Guetschow, that the Kahlers be paid \$50.00 per issue or a total of \$1.00 per sanction for the year, whichever is greater. Motion carried.

Motion by Reid seconded by Eich, that all monies for the DR be sent the DR Editors and they they be required to issue a quarterly financial statement. Motion carried.

There was a discussion on the dropping of the Constitution and By-Laws from the Guidebook, as it is outdated much of the time (CON'T.)
