Add word "Incorporated" at the end of name. Article I

Article V Delete complete article and replace with:

Section 1 The elective officers of this association shall be a President, Vice-President, and six directors, who shall be elected for a two year term by and from the membership. The President, Vice-President, Secretary-Treasurer and the six Directors shall constitute the Board of Directors. Each of

> the eight elected members of the Board of Directors must reside in a different state. Any member to be eligible for any office

must be an owner and breeder of Dutch rabbits.

Delete complete article and replace with Article V

The Sec'y-Treas. shall be appointed by (2/3) Provisions Section 2 two-thirds majority vote of the Board of Directors, to serve a minimum term of three years. The Sec'y-Treas. may be reappointed by the Board of Directors, who may also remove him/her from office, for cause, by 2/3 majority, during any term of office.

The term of office shall begin on January 1st. (this article to take effect upon the expiration of the current elective term of office of the Sec'y-Treas.

Article V Delete and replace with:

Section 3 The President and three directors shall be elected biennially on the numerically odd years for a term of two years. (To take effect upon the expiration of the current elective term of office of the President and Vice-President).

Article VI Voting Procedure - Section 1 A single nomination ballot with a return envelope addressed to the Chairman of the election committee shall be furnished to each member in good standing, by the Sec'y-Treas., on or about April 1st of each year. Ballots shall be returned in a double envelop with the members: names or numbers on the outer envelope. The outer envelope shall be removed and destroyed before the inner ballot enve-

lopes are opened. No name, number or identifying mark shall appear on the inner envelop. The Chairman of the election committee shall receive these ballots until May 15th, at which time the polls shall be closed. He shall then assemble the committee, open the envelopes, count the ballots and certify the results to the President, the secretary-treasurer and the editor of the Dutch Reporter by May 20th.

NOTES: The general fund balance above is a bit misleading. The publicity funds will make up the \$687.32 balance not covered by paid advertising of the guidebook cost. This would bring the General fund balance to \$309.20. While this balance is down from the \$854.40 Dec. 31, 1975 balance, this may be explained by the extra, one-time cost of Guidebook mailing of \$260.00 and the fact that we have paid for a half $(\frac{1}{2})$ year's supply of paper for the D.R. (\$223.00) and we also have paid for enough ribbons and rosettes for the remainder of 1976 (\$438.65).

Projected costs for the immediate future include: 10,000 D.R. Covers \$130.00. Estimated costs for the election \$275.00. Printing stationary and envelopes, year's supply, estimated at \$150.00. 1975-76 Sweepstakes trophies \$110.00.

SAM

I've got a Dutch named Sam. Sam is quite a ham, but Sam has a problem that needs - - to be discussed.

Sam has a hook, on his left front leg.

Please shed no tears & don't fear. For Sam has a Grand Champion leg.

Please don't be surprised!

But let us compromise - - - Sam's been disqualified too.

When judges are around, Sam holds that joint down, and neatly tucked under is the hook, the judges can't discover.

Oh, they know it's there . . . but as long as he's in his natural position, they have to make a big decision. (CONTINUED)

SAM CONTINUED

Some judges place him low and some place him high, while another Tugs, pokes and pulls and says, "I've got to be sure."
"Sam has got to go!"

Since we started showing Sam, I've been doing some research. I know there must have been some people standing back thinking the judge must be blind. And I know one judge got down to 2 in the class, picked him up a little askew and reading his thoughts, he said, "I must be blind," needless to say Sam placed 2nd that day. However, one judge did pull, tug and literally dug until he found the hook. Sam was a little upset and so was I. But the majority of judges have been generous with Sam and he does have one grand champion leg.

On page 63 of the American Dutch Rabbit Club Guide Book gives instructions to Judges - - The following is re-printed from that page.

"The Judge <u>must not</u> stretch out the hind legs <u>nor pull</u> the front legs out of normal position, thus distorting the undercut. Only irregularities of the undercut showing when the Dutch is in his normal position, as described above are to be considered. This also applies to the elimination, 'When the body color extends below the first joint below the shoulder of the fore legs."

Did you know that the ARBA "Standard of Perfection" under Dutch says nothing about judging Dutch in their natural position!

Did you realize that all judges haven't read or even have a copy of our ADRC Guide Book, but all judges should have a recent issue of the ARBA Standard of Perfection.

The English Spot breeders, have written in the ARBA Standard of Perfection, one paragraph, entitled a "Statement to Judges" explaining how their English Spots should be handled and judged.

"Statement to Judges"

English, except for examination for disqualifications should be judged without handling, save perhaps to compare certain markings closely, let the rabbit pose in it's natural position. DO NOT DIG, POKE AND TUG AT THE ANIMAL - - - ABOVE ALL DO NOT FLATTEN THE ANIMAL DOWN ON THE TABLE WHILE JUDGING. The best view of the Rabbit can be obtained by stepping back from the judging table and allowing the rabbit to move naturally.

Well I hope Sam and I stir up some discussion on the subject. I'm sure Kathy would enjoy printing Pros and Cons on this subject in the D.R. I would enjoy reading them.

Shouldn't we as DUTCH BREEDERS take a SECOND LOOK at what is written in the ARBA Standard?

Well folks - - do you agree or disagree with Georgia??????????? Would you like to see the ARBA Standard Changed to read like the English Spots or not???????? Even if you can say all you want to in one sentence let us hear from you. Just don't enter into personalities of a certain judge or judges, unless it is something good. Kathy

Lately though, he's taken to defending me, and it's becoming a real problem. He's begun attacking, people, especially boyfriends. He scared one off and keeps others nervous. I could never give up Repeter of course, but is there any way to stop him from attacking my friends?

Dear S.C.: The answer is castration. For Repeter, that is. Territory-oriented male rabbits often become possessive of their nearest and dearest human companion. His territorial drive is related to production of male hormones. Neutering him will stop the androgenic (male) hormone production and within a week or two, Repeter Rabbit should begin to mellow in his relationship with friendly Homo sapiens of the male persuasion.

 This may pertain to all breeds, not only Dutch, but being a Dutch breeder for a number of years I have seen it in this breed quite often.

There is a very nice specimen on the table, the judge is in doubt of it's weight. Will it make the standard? Maybe it's a little heavy or light. Some judges may not have a sense of weight in his hands and he will not weigh the rabbit. He will go ahead and place the rabbit first. He finishes judging the classes and then comes the time to pick best of color. He has to decide about that small or large one again. He will pick it best of color because none of the others can compare to it - - type, color & markings, etc. Then comes the big one - - Best of Breed, now what? That light or heavy one is still best on the table but can't go further because of it's doubtful weight. The judge will pass it by for this reason. I've seen this happen so often, it is pitiful.

Now for the point. This judge was not fair to the breeder or himself if the rabbit was passed by for B.O.B. or B.O.S. for the weight reason. Tough Luck. But if the rabbit had been weighed and was within the weight limits it would be B.O.B. or if not in the limit, eliminated. I do believe the Breeders, Judge and Rabbits would have had a better shake. The breeder would have more respect for the judge. The judge would feel more sure in his mind. The rabbit would travel to more shows or stay home and enjoy raising more rabbits.

As I say this can pertain to all breeds. The older breeder knows better, but the new ones will hurt themselves.

This is not meant to be anything more than educational for breeders and judges alike.

HOW TO PROPERLY CARRY & HANDLE RABBITS

I have been requested to write an article in regard to the proper way to pick up rabbits, pose them & handle them for examination.

Improper handling can cause serious injury to the rabbit. Any rabbit, regardless of size or breed, should be fully supported at all times.

In order to properly lift up a rabbit and turn it over for inspection, you must grasp the ears and scruff, a short distance back from the ears, with your right hand and turn it over. Do not grasp the rabbit too close to the head as you may choke it. If you pick up the rabbit too far back, it will cause the animal discomfort.

Do not lift by the ears as they are only held to prevent the animal from twisting or turning around.

When the animal is turned over, you can rest the body on a table or your body.

HOW TO PROPERLY CARRY & HANDLE RABBITS CONTINUED

The most important thing to remember is to always have a firm grip on the rabbit and to get a supporting hand under the animal. The rabbit's weight is supported by both of your hands or a table

Never pick up a rabbit by it's back and let it kick and fight until you have supported it by both of your hands.

ONE OTHER BIG MISTAKE is to CONTINUOUSLY STROKE the FUR from the BACK TOWARDS THE HEAD. This will break down the guard hairs and in many cases this will cause the rabbit to moult.

I would like to suggest that all members that have not purchased an ARBA Book of Standards to do so. Pages #14 through 18 illustrate how to pick up a rabbit and check them for defects, etc, without torturing the animal. The ARBA Book of Standards may be purchased by sending \$3.00 to our A.R.B.A. Secretary.

CHOCOLATE DUTCH

When breeding Chocolates it is always best to keep a few simple things in mind.

First, as with any color of Dutch, it is best to use well marked stock of good color and type. Of the Chocolates that I have seen, the type is good but, on the average, doesn't seem to be as perfected as that of Blacks. Good Chocolate color is one thing that is beautiful to behold. The standard calls for a glossy chocolate brown running deep towards the skin, blending into a bluish dove under-color next to the skin. The key to this is the bluish dove under-color, animals that have this usually also have a rich glossy Chocolate color too.

As far as breeding goes, I have found that the use of some Blacks in the breeding program greatly helps, darkens the color. Presently, I am using a black buck of excellent type from Black & Chocolate parents on my Chocolate does. This gives me two blacks & four chocolates from every six babies born. Maybe I'm just lucky but the chocolates are usually the better marked animals. One good indication to color is the eye color, generally if the eyes are dark the animal will grow up with a beautiful fur color.

Maintaining this color in good condition is a problem. (CONT)

that we all have come up against. Heat is probably the one 'greatest cause of dulling. The only way that this can be checked is by keeping the animals in as cool an environment as possible in the summer.

An article in a local paper remeinded me that some of our people live within town limits. For those of you that do - -Please read this article from a Pennsylvania newspaper, dated April 10,1976.

SUIT SEEKS TO KEEP RABBITS

NORRISTOWN: A Lansdale family that has been raising rabbit for six years is seeking \$105.000 and an injunction to prevent the borough from putting a stop to it's hobby.

James Grayveal and his wife Betty Jean of 849 Sycamore Drive have filed suit in Montgomery County Court against the borough of Lansdale and four of it's officials - - (CONTINUED)

SUIT CONTINUED

The suit says the Graybeals and their two sons have been raising rabbits since the Easter season of 1970. The sons are said to have won numerous awards for the rabbits.

The plaintiffs claim they were assured by borough officials in June 1970 and in June 1975 that the rabbits did not violate any borough ordinance. The Graybeals claim the rabbits were never sold for profit or raised for any other commercial reason.

The suit says the plaintiffs received a notice July 24, 1975, of an alleged violation of the borough zoning code. The pertinent section reads: "No animals, livestock or poultry of any kind shall be raised, bred or kept in the borough of Lansdale." Dogs, cats and other household pets not bred for commercial purposes are specifically excluded from the prohibition.

The suit says the plaintiffs were advised September 24 by Landis they had 60 days to terminate their hobby. Rather than give it up, the plaintiffs put their house, where they had lived 16 years, up for sale with the intention of moving.

Although the house was listed with a realtor, the suit claims it could not be sold and the borough refused to grant an extension past March 21.

The suit claims that, on three occasions - Jan. 20, March 22 and March 25 - Robert Comfort obtained search and seizure warrants for the rabbits from Justice of the Peace Sherwood Zepp, but no rabbits were found in or around the premises.

The plaintiffs claim the purpose of the warrants is to harass, annoy and humiliate them. The suit says they were forced to exterminate some of the rabbits and move the others away.

The plaintiffs are asking for an injunction to restrain the defendants from searching their home and from declaring or enforcing any ordinance that makes the possession of rabbits a violation. They are seeking \$5,000 in compensatory damages and \$100,00 in punitive damages from the borough.

A hearing on the injunction request has been scheduled for $April\ 30.$

End of article. It would be the wise woman or man that indiscretely checks up on the town ordinance to see if they would be liable. God only knows our club cannot afford to lose you.

At the expiration of the period they may either be renewed through mutual agreement or another selected to be our representative. A certificate of extra ordinary service will be issued and signed by the current presiding president of the A.D.R.C. Attesting to the fact with the thankful hand of all members. This certificate can be treasured as a lasting memento of their service.

This writer believes this will be a post that will be honored and sought after particulary so for our older breeders which would both recognize them as master breeders yet promote locally for our club. They should after their period of service be honored by having their names etched into our Guidebook.

The representatives selected will work under the influence of the publicity chairman but this should not be construed as a total indebtedness to the publicity committee.

CHOCOLATE DUTCH By CHAS. O. LEWIS

For years the A.O.C. classes in Dutch were composed of the odd colors, blue-gray, blue fawn and occasionally, in years gone by a yellow. To these the judges gave scant consideration in selecting best Dutch, best Junior, etc., as their various shades and light belly color made it difficult for a judge to determine undercut, color runs, etc.

In the fall of 1935 after considering the matter for a year of so, I made a contact with Mr. E. Mitchell of Northhampton, England through the secretary of the United Kingdom Dutch Club and I purchased from him the first Chocolates to come to America, among them being the buck which won the 1933 Junior Chocolate cup and was runner-up for the adult cup the next year.

As our American standard does not provide a special color class for Chocolates, they have been shown in the A.O.C. classes and have had no trouble winning over their lighter colored and various shaded competitors which formerly dominated those classes. In fact, at some of the large shows they have caused the judges to notice them to the extent of a best Dutch win at Orangeburg, New York, a best Junior win at Mineola fair and best A.O.C. at many shows including two convention shows. This proves conclusively that the Chocolate are here to stay and a challenge to the Blacks & Blue for premium honors previously exclusively won by those two colors.

This contact with Mr. Mitchell has resulted in a friendship by correspondence, which I value very highly and has brought considerable pleasure to me & has shown him to be a fancier, willing at any time to contribute his knowledge & experience for the advancement of the Dutch & benefit of the American fancier. He is now a member of our American Dutch Rabbit Club and one of who we can be justly proud.

As Mr. Mitchell's previous article on Chocolate Dutch explained he started to make Chocolate Dutch in 1925 with a very fine Black buck & 3 good (for those days) Havana does & by careful selection & judicious breeding brought along his strain until in 1933 he produced the buck which won the English Junior Chocolate cup for that year & narrowly missed getting the adult cup the following year. This buck is the one mentioned above.

In my correspondence with him during the past two years he has been my constant adviser in the breeding of Chocolates on this side, being just as anxious as I to see that they progressed properly. For the benefit of Dutch fanciers at large, I am giving below some of his hints which might well apply to some of our other breeds as well.

The following are quatations from Mr. Mitchell's letters:

"You can correct heavy cheek markings in does by mating to bucks with CORRECT cheeks, NOT high ones, as there is a tendency in Dutch to ultimately run high. In fact, if not watched, the white to beat out the color markings all over the body and then throw piebalds (pintos) as Western Americans call them."

"It sometimes helps if you want to put in good points to catch the prospective parent with the good point desired, right on top breeding condition; and the other side less keen. Also a hint; a doe mates when she is ready and sometimes a favorite buck is used when somewhat stale, and resultant youngsters follow (CONTINUED)

after the doe, her nature at the time of mating being stronger."

In connection with the care of my winning young buck Chocolate
Brown Bomber, his advice was as follows and might well apply to any
good buck.

"Don't over-show him. Just keep him for your big convention show this month (Fort Wayne) and hold him at stud at 7 months to your best does, keeping away naturally from faults same on both sides. Use him quietly until 10 months old. Give him a white of an egg, say twice a week in a little crumbly moist mash, just what he will eat at one meal. A hint I would pass on for use in all your bucks also sluggish does. If the white of an egg does not work on sluggish does, try maple peas well soaked. Also plenty of exercise on the floor and a night or two in a spare buck hutch."

In addition to the straight chocolate matings, it is advisable to breed a chocolate buck to a good Black doe, preferably of straight black blood. This mating will produce all Black Dutch in fact the mating of a Chocolate buck to any color doe except Chocolate will produce all Black Dutch just as a Havana buck will produce all Blacks when mated to any other color. The young of this litter will in all probability be not very well marked due to the outcross, but the best of the does should be kept and bred back to the Chocolate buck, when the resulting litters will produce both Black & Chocolate in varying amounts. The Chocolates from these litters can then be worked into the regular line thus adding new blood and at the same time tending to deepen the Chocolate color. The Blacks can be bred together to insure having on hand a Choco-Black doe or two when needed.

The color of the Chocolate Dutch is a rich dark reddish shade Chocolate and not the dark brown shade seen on our present day Havanas, especially those of imported English strains.

In showing juniors, I have found in some instances that the judge remarked "light in color". The Chocolates are like Havanas in a good many respects, but the juniors due to their markings, can be shown at an early age, long before they have their dark adult color and coat, while a junior Havana is generally held until he has a good dark coat before being shown. Judges should take this into consideration when judging Chocolates especially juniors and should not judge them from the color standpoint of the Havana.

Like Havanas they should be kep in indoor hutches away from the direct light which has a tendency to fade and burn the color. The Chocolates have wonderful type, and if our American breeders will try to hold to it, and in the introduction of new blood, either of Chocolate or through Black does be sure, to give it careful consideration there is no reason why in the near future a Chocolate should not be bred which will wrest top honors, away from the Blacks and Blues at our large shows.

My experience with Chocolates during two years has shown me very plainly the mistake we American breeders have always made in outcrossing too much instead of inbreeding. I think every Dutch breeder gets inquiries which call for an unrelated pair or trio, and it is hard to convince the beginner that a closely related pair or trio of selected breeders from the same strain will produce better results than can be obtained from an outcross of outstanding specimens obtained from different breeders. When one cosiders that since 1925 this strain of chocolates has been bred together, with no outside blood being introduced except by the Choco-Black line, and still produces more active and vigorous stock than a good many outcrosses do, one must realize that in order to breed the best Dutch, one must stick to one strain and by careful selection of the best and strongest build up a line of winners for one's self. Brother to sister, son to dam, sire to daughter, half brother to half sister, etc. Do: not be afraid to make these matings but just be sure the same Faults aren't on both sides, for in closely related stock such as you will eventually breed, faults are very easily accentuated, if not guarded against. just as good points are as easily bred into the line.

Dutch fanciers, who are now raising Chocolates & those who eventually will, will find me at any time ready and willing to do all I can to help them along just as our English club member, Mr. E. Mitchell, has helped me.

COMMON RABBIT DISEASES & THEIR CONTROL

EAR CANKER

CAUSE-Caused by the mange mite a very small mite that infests the ears of rabbits. SYMPTOM - Irritation set up in the ear by the mites is followed by the formation of scabs. These itch and the rabbits will likely scratch or hold head to one side. If mites reach inner ear, pus poisoning and wry neck or even death may follow CURE-Kill mites with any good carbolated ointment

after first removing the ear scabs with a sterile blunt instrument. Treatment without first removing the scabs may prove ineffective. Never wait until the mites have reach the inner ear because control may then be impossible.

SORE HOCKS

CAUSE-Bacterial : infection of the hock following bruises or scratches. Found most in filthy hutches, and in hutches with wire or slatted bottoms.

SYMPTOM-The hocks are affected by sores which are slow to heal. Pus may form and the animal will be very uncomfortable. The very heavy breeds are most subject to sore hocks.

CURE-First clip hair over sore area, then drain sore of any pus that may be present. In mild cases a simple dressing of carbolated vaseline may cure while the more severe sores should be disinfected with iodine or mercurochrome and then the hock wrapped to keep it clean during the process of healing. Repeat this treatment as often as needed until the hock is well. A straw litter will help prevent hock injuries.

MINUTES OF THE BOARD OF DIRECTORS MEETING

Treasurer's report was presented (published in full elsewhere in this D.R.) The current balance showed a deficit of \$378.12 but was offset by recent expenditures of supplies of ribbons and paper for the D.R. (ribbons supply will last for a year, paper for ½ year.) and a bookkeeping sum of \$687.00 dollars due the general fund from the publicity fund for the remainder of the guidebook costs. Motion by Don Reid, seconded by Geitzenauer that the report be accepted as read.

Secretary's report was presented. 729 members on April 15,1976. Ballots would be mailed out on May 1st. The ARBA convention committee would honor the selection of judges that our club had made for the convention show. Brief officer's reports were given.

Committee Reports were given. Roger Guetschow discussed the proposed constitutional and by-law changes necessary. After discussion it was suggested that these be presented to the membership at the membership meeting for their ideas.

The publicity committee presented their financial statement which listed slightly over nine hundred dollars balance. Motion by Reid, seconded by Cooper that the report be accepted as read. Motion carried.

The D.R. report was read from the last issue of the D.R. Motion by Reid, seconded by Guetschow that the report be accepted as read. Motion carried.

Under Unfinished Business the bids for the 1977 NDS were considered. Three bids had been presented, The Kansas State Dutch Breeders, The Ohio State Dutch Club and the Michigan Breeders. Then after a discussion concerning sending information about Judging Dutch to Judges, a Motion by Bengtson, seconded by Guetschow that Bill Geitzenauer have some copies of the judging information in the Dutch Guidebook reproduced and then send them to Don Brady, who would see that they are sent out to new judges. Motion carried.

Motion by Guetschow, seconded by Cooper that the Kahlers be allowed rental payments for the use of their mimeograph machine, due to the Dutch Club's machine being inadequate. Motion carried.

Motion by Bengtson, seconded by Guetschow that the Kahlers be allowed to dispose of the obsolete office equipment they have. Motion carried. (CONTINUED)

BOARD MINUTES CONTINUED

After discussion concerning the youth page for the D.R., suggested by Mark Boan, the board agreed that this was a function for the D.R. editorial committee, and they could go ahead with whatever they felt would be best for the D.R.

Motion by Bengtson seconded by Reid that the minutes of the 1975 NDS board meeting be amended to show that Walt & Anna Cook were to be awarded life memberships at the Milwaukee, Convention. Motion carried.

Motion by Geitzenauer, seconded by Guetschow that the publicity funds transfer \$687.32 to the general fund to pay for the balance of the Guidebook cost, not covered by advertising. Motion carried.

Motion by Reid seconded by Guetschow that meeting be adjourned. Carried.
