SECRETARY'S MESSAGE

Another fine National Dutch Show is history. While not the largest in history, the Hutchinson, Kansas NDS will go down as one of the nicest - great facilities, wonderful friendliness and beautiful weather combined to make it very memorable. Our thanks to all those who were concerned with making it the enjoyable event that it was. And notice that I didn't single out anyone of the show committee, that's because the whole thing was so well run that it was apparent that all were doing a fine job. Our hats are off to you KANSANS.

Now we start thinking about the ARBA Convention at Houston. Am very disappointed with the membership response for convention specials. I would like to thank the couple of people that did respond - but the real question is - where are all the rest of you members? I'm not good at twisting arms, nor will I beg. Maybe we need to have a new club officer - or an added duty for one of the present officers - of club soliciter for specials.

The nomination election is over by the time you read this message. I have only had a couple of responses concerning the mailing of ballots by 3rd class mail. Only one request for an additional ballot due to non-receipt. Either it worked reasonably well, or no one cared enough to respond. I do know that it was a great money saver. Slightly over seven hundred ballots and the difference is between 13¢ first class and 2¢ third class, or a savings of 11¢ per member. If you have criticisms, let us know, but at the same time, let's do what we can to make it work if at all possible. The board of Directors at the York convention voted to send the ballots Third Class. One change that happened too late to be on the ballot is that Darrell Bramhall will not be judging the Dutch at Houston, as the show committee would not honor our request. So he will be placed on the final ballot automatically.

Judge Cecil Green will be officiating in Darrell's place at Houston. We are looking forward to a fine show. They had a fine NDS there and many of the same people are involved working on the convention show.

A suggestion was made at the NDS concerning the seller's class. This class has benefited the ADRC greatly over the years. At Hutchinson it brought \$220.00 to the club. We would like to THANK the donators and the buyers both. The idea was that perhaps we should auction off rabbits and have half go to the club and half be returned to the breeders. Might draw more rabbits and benefit both the club and the members more.

Every once in a while we get thoughts from members concerning ideas they have had. Why not jot your ideas down in the form of an article for the DR. I'm sure the Kahlers would appreciate it & food for thought may jolt others into thinking about things.

Hope you have a happy summer. The fairs will start soon, and the busy season is upon us. Our best wishes.

MINUTES OF THE BOARD MEETING - APRIL 22, 1977 1977 National Dutch Show - Hutchinson, Kansas

The meeting was called to order at 8:50 p.m. on April 22, 1977 at the 1977 NDS, Hutchinson, Kansas. Answering the roll call were President Stinehelfer, Vice-President Roger Guetschow, Secretary Bengtson and Directors Eich and Brady. Absent were Directors Cooper, Reid, Lovejoy and McNamara. Also in attendance were publicity directors Elmer & Millie Hand and Dutch Reporter Editors Bob & Kathy Kahler.

Motion was made by Brady, seconded by Eich to dispense with the reading of the minutes of the preceding meeting, as they had been published in the DR. Carried.

Treasurer's report was given by Secretary-Treasurer Bengtson.

Under officer reports Director Don Brady reported that every new judge had been sent a copy of the Dutch judging handbook, as a few other judges that members had requested that a copy be sent to.

Publicity committee reported. Motion by Guetschow seconded by Eich that report be accepted. Carried.

Dutch Reporter committee reported. Financial report is published in the DR and that they have enough paper and supplies to last till the end of the year. Things will be ok as long as the ads and articles keep coming in.

President Stinehelfer read a letter from Director Don Reid and Director Don Lovejoy and Secretary Bengtson read a letter from Director Lynn Cooper, all of whom were unable to attend.

Under unfinished business, there was a motion by Bengtson seconded by Brady that the matter of out-of-country members having to pay extra for postage costs be referred to the constitution committee for an amendment to the constitution changing the membership rates appropriately. Carried.

Under new Business, Eich made a motion seconded by Bengtson that AL EMERY be granted LIFE MEMBERSHIP. Carried.

A discussion was held concerning the re-writing of the sweepstakes rules, which are presently too complicated and do not always correspond with the ARBA rules. It was decided to submit these proposals to the membership through the DR to get a sample of feelings of the membership.

Motion by Brady, seconded by Eich to accept the bid from the Ohio State Dutch Club for the 1978 National Dutch Show. Carried.

Motion by Bengtson, seconded by Guetschow to change the NDS show rule #2 to accept bids for the NDS two years in advance of the show. Carried. (CONTINUED)

Motion by Eich, seconded by Bengtson to submit a letter from Mark Bean to the Board to the DR for consideration by the membership. This letter concerned youth activities and a possible youth sweepstakes.

President Stinehelfer announced that Jack Wireman had resigned from the election committee and that he was appointing Al Butler to replace Jack. President Stinehelfer also announced that he would not be a candidate for re-election for office, as he was nearing retirement age and would like to retire.

Secretary Bengtson announced that \$220.00 had been made on the

emen: I propose to you, the ruling body of the American Dutch Rabbit Club, that a separate youth sweepstakes series be established in the club. I suggest that this series would not require separate sanctioning, simply that youth members choosing to show their Dutch in the Open classes be given the opportunity of a separate listing for sweepstakes standings. Such a program could be carried out by having youth members, ages 9-18, the same ages as ARBA regulations, indicate their wishing to participate when joining or when renewing an American Dutch Club membership. Youth sweepstakes participation would be indicated with the addition of a "Y" at the end of the member's name in the secretary's file. At the end of the sweepstakes year it would then simply be a matter of compiling a separate listing of the top 10 or 15 youth achievers in the country.

Like Houston two years ago they were short on rabbits, but lots of hospitality. About 250 entries in the open. Excellent facilities, solid partitions between rabbits and wire floors. The weather was excellent for people and rabbits. The quality was top notch with very few disqualifications.

The way it looked the Blacks were first and the Torts were probably second, have you noticed how the torts have come on in the last 4 years? Wonder Why? The competition was so good we never won a first. On Torts it was pretty well spread around, which is a good sign. Complete returns will be found elsewhere in the DR. (Ed's Note: I Hope.)

As usual going into new territory you meet new people and hope-fully make new friends. Nelle had lived in Kansas and I spent a lot of my younger days in the Osage so we know Kansas people and know they are great.

But aren't most Dutch breeders great? However you will find most are not pepper caters or Tequila drinkers.

Speaking of food and that ranks as one of my main events, the banquet was great (buffet style) however the kitchen at the show was outstanding, large Ham sandwiches, baked beans, cold slaw, no end of home made pies, pickles and cakes.

Now to jump to another subject if you already know some of the facts or tips, I am getting ready to present be patient as we have a lot of new breeders that may appreciate them.

We are going into hot weather and the following tips may help you save some rabbits.

FIRST - when preparing a nest box (winter or summer) we put an inch or two of shavings in the bottom under the hay this absorbs a lot of moisture and in hot weather about the third or fourth day we throw all the hair & hay out to leave the shavings. (CONTINUED)

By this time the babies have enough fuzz on them to keep them warm and they will be a lot cooler.

If you have freezer space go to the local laundermat get used bleach bottles, fill with water and let freeze, place in pens in hot part of the day and notice how the rabbits will lay against them.

Now we come to that old bug-a-boo late summer and fall breeding problems, call it what you will and this problem has been diagnosed by all the experts. In our book the biggest problem is FAT. We have had better success putting Does on the floor as many as you have room for with one buck. Plenty of water and since we feed hay in our pens we always have hay in the worm beds on floor plus spilled feed from the feeders. So if, you have this situtation don't feed unless you absolutely have nothing on the ground, and then only about a tablespoon full per rabbit once a day, but scatter your feeders so the timid Does will get some.

Now these Does will fight and knock some hair loose the first day or two until, they get their "pecking" order straight, if you have a real timid Doe you may have to pick her up. In two or three weeks you can start palpating and start picking them up as they show definite signs of being bred.

Having just mailed my dues for my third year in the Dutch Club I still feel like too much of a novice to offer any great words of wisdom to my fellow Dutch Breeders. As a newcomer, however, there are a few observations that I'd like to make which I hope can be of interest to all. The guarder below error of the best distribution of the contract of the contr

First of all, in these days of inflation, rising prices, etc., it should be obvious to all members - new and old alike - that the \$5.00 dues for the Dutch Club just has to be one of the best values anywhere in the U.S.A. It's almost beyond comprehension that anyone interested in these great little rabbits couldn't benefit from membership. The only excuse I can think of is not knowing of the Club and this is where our members must be constantly active - -- - telling our story. (COMPINIED)

Secondly, I've been constantly thankful for the help and advise received from other Dutch breeders. The time they've spent simply talking shop with newer breeders has to be of benefit to the improvement of the Dutch breed. In our own case, we were extremely fortunate to have been able to participate in both the National Dutch Show and the York Convention, both near to home in 1976. My advice to those new in Dutch is not to be scared by this level of show. Show your best even if it's just one rabbit. The experience and friendships gained will have a far reaching effect on your Dutch program. It's really an indescrible pleasure to see all of those good Dutch even if they're not yours, and you'll find that the Dutch breeders are the greatest.

Thirdly, I can't over emphasize the contribution made by the Dutch Reporter. The publication's style is one which makes the reader feel like part of a nationwide family. You feel you know people you've never met. For example, after reading some of Nelle Brady's articles when I first started to receive the Reporter I was intrigued by some of the things she wrote and felt compelled to write to her for further information. This was the start of a correspondence which went back and forth for some months and resulted in our family getting a start with a trio of Torts at the '76 Dutch Show, Out of the friendship this trio was named Don, Nelle and Texas Lady. Others who have been especially kind to us are Roger Eich, Warren McNamara, Larry Thompson and E. D. Smith, and I musn't forget Elmer Hand and Larry Bengtson either. All of these breeders have taken the time to provide advice to a novice who was inquisitive.

In summary, after four years of having Dutch I can only say that the Rohrer rabbits are not as good as they could be, they're not as good as they're going to be, but they're a whole lot better than they used to be. We've set goals for our breeding program based upon a lot of observation and discussion, accompanied by much thought. We now know what we're striving for and look forward to constantly putting a good Rohrer Dutch on the table. We feel our Dutch Club memberships are making this possible.

Every rabbit publication I have read recently has mentioned frost bite on the rabbits ears and feel like everyone else, we have had the worst winter in memory in our area. We had unending days of 35-50 m.p.h. winds, coming down the Potomac River. For the first time I know of, the river froze solid and stayed that way for over a month. We had snow on the ground for six weeks straight. Our house is 25 feet from the river bank, the nearest wind break is the Maryland shore 1½ miles away.

Our rabbits came through the winter fat, sleek and beautiful. We didn't lose so much as one bunny. (CONTINUED)

VIRGINIA CONTINUED

We have raised rabbits since we were children, because our parents raised rabbits our daughter, Robin is a fourth generation rabbit nut. We raise rabbits the "old fashioned" way. My husband builds our hutches. We live 8 miles into the woods, surrounded by wildlife preserve. Since Fox come to eat apple and carrot bits that have dropped under the hutches, we need secure hutches for our rabbits-- - they must be snake proof too. My husband builds wooden hutches-- - wood "bedrooms" with a large door for cleaning. The "living room" and floor of the hutch is made of 1 inch hardware cloth. We have large front doors on the hutches, and both doors have snap closings so they cannot bump open. They have solid roofs, covered with roofing material. He uses Pine because it is light weight and easy to clean. We use a good, stiff nylon brush to brush off the floors - but very little dirt catches on the wire. Every hutch is scrubbed with household strength Lysol once a week, unless we have a doe ready to kindle. We do not disturb her for a week before kindling, and until her bunnies are a week old. We have only had one Doe kill her litter and that was over 20 years ago. We use water bottles in the summer and plastic bowls in the winter. The ice pops right out of the plastic bowls.

Our hutches are on racks made of corner posts and 12 foot long 2 x 4's. These get the Lysol treatment too. In the winter we keep hay and straw beds in the hutches. We have "storm covers" on all four sides of our hutches. They are made of the heavy gauge plastic that is used to cover windows. The covers are made of four panels, stapled to the hutch at the top. When not needed they fold up out of the way. We drop the panel on the side the rain or snow is coming from. When the winter wind is too bad we close the covers completely, using clothes pins to snap them together.

The article "Environmental Conditions" in the latest Dutch Reporter gives a method of getting the rabbits to use a "bathroom" area. We use the method my Dad used. He always made sure one corner of his hutches was a fraction of an inch lower than the other three $(\frac{1}{4}$ inch will do.) 99 out 100 rabbits will always go to the low corner.

We have had people horrified that we use wood and hardware cloth hutches - but the hutches have stood up to attack by a Great Dane, German Shepard and an Irish Setter. A friendly visit with the dog owners, and an explanation of the County leash laws and laws covering Agricultural animals, plus a firm statement this was the one and only warning they would receive has kept the dogs from returning to our fenced in yard. The Dane & Shepard owners are interested in rabbits now.

Hope our storm cover idea will help someone else get their rabbits happily thru the winters to come.

FOSTER DOES

A newer breeder recently asked how she could get more litters from Does in the amount of time (April to November) in her Latitude of the country. Well nature and gestation time has something to say about this but it can be helped a little. Providing heat will exit slightly but is very expensive. An answer but yet not an answer. This person uses the Foster Doe Method.

Breed say 5 Does to kindle together. At kindling pick the best 8 out of the 5 litters and after identifying through markings give to the Doe, of the 5, who had the worse marked litter. Be sure when you place them in the nest that the Foster Doe has some Vicks rubbed on her nose. This will deaden her sense of smell and allow the alien young time to acquire the "smell" of the new nest. This will then free up to 4 Does for servicing. They can, if they are not in too bad a shape physically, be rebred within 3 days after kindling. Save the hair or nestbox of each by marking the Doe number. Each Doe can then use her own hair again without looking like she has been shaved. This method gives each doe 30 days to lay around resting. As any breeder will tell you the young are much more demanding of the doe after 3 weeks. In other words a Doe raising a litter to weaning will look like she's been through the war, particularly if she is a good doe? The way to be in the case of the control of the case of the

This system has worked for this writer for years and it is quite possible to get 5 to 6 litters out of a good throwing Doe in one year.
