An enthusiastic group of Dutch breeders formed a Dutch club to further promote their breed along with the American Dutch Rabbit Club, and repeat the saying, "You can't beat the Dutch". They held their first neeting at the Indianapolis Rabbit Fanciers show held at Bridgeport, Indiana on Hovember 7, 1971.

Wilbur Williamson acted as chairman and Patricia DeHaven as recording secretary previous to election of officers which was the first order of business. Results were as follows: Wilbur Williamson, President, Lynn Shaw, Vice President; Alvin C. McKeeman, Secretary and Treasurer; with three board of directors, Gene Francis, Dr. Terry Reed, and D. K. Brown. Dues were decided to be adult individuals \$2.00, husband and wife \$3.00 and youth to age 19 at \$1.00. We are going to apply for our charter with the A.R.B.A. SHORTLY after this article appears in this Dutch Reporter. We are well on our way with 23 signed up with dues paid. Of course, we must pay for our club charter with A.R.B.A. We intend to have an Indiana State Dutch Rabbit Show in 1972 and there are sanctions, etc. to be paid for.

Now let's stop talking about money and talk onmembership. We welcome all Dutch breeders and rabbit enthusiasts to become charter members. Let's make ourselves a committee of one to help this club move ahead. We don't as yet have any application forms so just send your check to the secretary and earmark it form the Indiana State Dutch Rabbit Club for promotion of a breed that had held its popularity as long or longer than any other breed and we of the Indiana State Dutch Rabbit Club want to keep it that way. It is a very versatile breed, stands our cwey popular in the showroom, produces one of the best finished fryers, is used extensively in laboratories to aid mankind, is easily handled by youth and if handled carefully will respond lovingly. At our first meeting, we didn't receive nembership of any of our Indiana judges. We need then in our association. 

FROM THE MAILBAG: 1944 MINE OF THE CONTROL OF THE C

Dear Doris,

I have been meaning to write this note for nearly a year. First, you should be congratulated again for the efforts you have placed as Sec./Treas. of the ADRC and efforts in getting the Dutch Reporter out to the growing number of Dutch raisers.

I am pleased with the recent election, especially the new points counting system, this will certainly give a boost to those in the less populated parts of the country. I am though, very disappointed in the defeat of the dues increase. Everyone wishes increased service for the same amount of financial support that has been apparent in the past. As you are finding out, this is a falsehood and not very realistic.

The main reason for writing is to take a closer look at the sweepstakes series that is annually spensored by the ADRC. Looking at the recent published standings ... the following states are solidly represented in the top 20 rankings:

- 6 members from California
- 9 members from Ohio
- 2 members from Texas
- 2 members from Minnesota
 - 1 member from Connecticut (where ever that is)

I am sure that there are many other Dutch raisers from more than 4-5 states.

Out here is the West where ADRC members are fewer, we also have fewer shows and sanction support because of the tremendous distances we need to travel to shows.

Example: 1,000 miles round trip to shows in Calgary, Alberta Canada 800 miles round trip to Great Falls, Montana

1,000 miles to Wester Oregon shows

One doesn't make many of these shows, if there is not a Dutch sanction. Then we question why since even the sanctioned Dutch shows usually have 6-20 Dutch, with the exception being the Washington State Annual Convention and some of the shows on the West coast of Oregon and Washington, 600-1,000 miles away by round trip.

The sweepstakes points that we are fortunate to gather in are just a drop in the bucket to the points awarded at shows in California, Ohio and the East Coast areas. We are also interested here in the West in a regional Dutch Association or at least an annual show, but haven't gotten off the ground again because of the traveling distances.

I personally feel that if we could have some sort of incentive from the ADRC on a Regional Sweepstakes basis, that we would be able to get additional sanction support, membership support, and begin to again get the increased numbers in the Dutch raisers of the area. This point also brings up the issue of the National Dutch Show, that is usually out of reach of raisers in the Pacific MW and Canada (Western).

FROM THE MAILBAG (Cont'd) -

Many of the Dutch raisers in the Northwest supported the bid of the Tri-City (Three Rivers RBA) area in Southern Washington in its bid for the 1972 National Dutch Convention. We regret that we did not succeed, but are not discouraged, because we believe in our efforts and our product ... The Dutch!

SUGGESTION: Can the membership and the ADRC begin to look at our annual Sweepstakes series in the light of the previous conversation. I personally would take on the responsibility and workload of organizing a MV Regional Dutch Sweepstakes Series in the following states: Washington, Oregon, Idaho, Montana and two Western proviences of Canada; British Columbia and Alberta. (We have support from of our Dutch neighbors living in Canada. They come down on a regular basis to many of our northern Washington and Montana shows and are great competitors.)

This type of series would promote increased interest in Dutch competition in our isolated PMW region.

The regional sweepstakes idea is not a new thought, as I have heard it mentioned at several shows this past year in our region. The idea would not detract from the National Sweepstakes Series, but would rather add to the interest of gaining more sweepstakes points and perhaps a shot at the National top 20 Dutch sweepstakes winners.

Doris, I would like to hear your opinion and that of other Dutch raisers in the nation. I am sure that our regions showing problems are probably seen in other parts of the country. What say?????

Thanks for the opportunity to sound off. You haven't heard the end of this from the PNW. We all need to work together for the support of the Dutch and make it truly a rabbit that can't be beaten
