MINUTES OF THE BOARD OF DIRECTORS 1977 ARBA Convention, Houston, Texas, November 6

The meeting was called to order at 8:15 p.m. by President, Mike Stinehelfer at the Tidewater II Motel. Present were President, Stinehelfer, Vice-President--Roger Guetschow, Secretary-Treasurer-Larry Bengtson and Directors: Don Reid and Don Brady. Absent were Directors: Don Lovejoy, Warren McNamara, Roger Eich and Lynn Cooper.

Motion by Reid, seconded by Guetschow to dispense with the reading of the minutes of the previous meeting, as they had been published in the Dutch Reporter. Carried.

The Treasurer's report was read. Motion Reid, seconded by Brady that the report be accepted subject to audit. Carried

Under officers reports, Secretary Bengtson reported that the membership is holding fairly level. Bengtson also suggested that there is a need to start on a club-wide celebration to commemorate our 50th year in 1979. He also commented upon the need to begin working on projects for the near future, such as the 1980 ARBA Standards for Dutch and to begin thinking of a new guidebook for 1981.

Director Reid reported upon the Domestic Rabbit Magazine published by the ARBA would be changing to ARBA control in the near future. This would provide more coverage, cheaper advertising rates, and a section for specialty clubs to have a regular column. Oren Reynolds will be the editor and Ed Peifer will be in charge of advertising.

Don Brady reported upon his project of sending the illustrated Dutch brouchure to new judges, and stated that he was current with these efforts.

Letters were read from McNamara and Cooper, expressing their regret at not being able to attend the Convention and stating they expected to be in attendance at the NDS in CANTON, OHIO in 1978.

Director Lovejoy had reported to President Stinehelfer earlier in the day that he had a conflict with another meeting and would be unable to attend.

The Dutch Reporter report was read to the Board. Motion Reid, seconded by Guetschow that report be accepted subject to audit. Carried.

The publicity committee was read. Balance on hand \$237.51. Elmer and Millie Hand also announced that they would retire effective January 1, 1978. They also expressed thanks to Ted Merickel for the donation of some fine posters.

Under old business, Secretary Bengtson reported that the change to the constitution and by-laws concerning membership costs for those living outside the U.S. had been submitted to the membership on the last ballot and had passed overwhelmingly. (CONTINUED)

The youth situation was discussed at length. Motion by Brady, seconded by Bengtson that the discussion be tabled until more response or demand was generated by youth members. Carried.

Under new business: Secretary Bengtson submitted a bid for the 1979 NDS from the Minnesota, Iowa & Wisconsin Dutch fanciers group.

Bengtson then talked about the Golden Jubilee celebration for the ADRC in 1979, and the need to become active for this project immediately, concerning the long lead-in time required for some projects. Among items mentioned were, special magazine issues for Dutch rabbits, a new shoulder patch celebrating the 50th year, special stationary, membership cards, ribbons & rosettes for the sweepstakes series for 1979 and also special issues of the DR commemorating the celebration.

Bengtson nominated G.A. Burke & his wife Moneleta for life membership in view of their years of membership and service, seconded by Reid. Carried.

Bengtson nominated Al Meier for life membership in view of his years of membership and service, seconded by Reid, carried.

Bengtson nominated Jack Wireman for life membership, to be awarded at the 1978 NDS in Ohio, for his years of service and membership, seconded Brady, Carried.

Bengtson nominated Mike Stinehelfer for life membership, to be awarded at the 1978 NDS in Ohio, for his years of service and membership. At this point the chair was turned over to Vice-President Guetschow, seconded Brady, Carried. The chair was then returned to President Stinehelfer.

Motion by Reid, seconded by Guetschow that the expenses of the board meeting room be paid by the ADRC. Carried.

Motion by Reid, seconded by Brady that the DR editors be authorized to purchase a new stapler for the DR, cost approximately \$93.50. Carried.

Motion by Reid seconded by Brady that the show reports be continued in the DR as they are presently. Carried.

SWEEPSTAKE SHOWS BY LARRY BENGTSON

Partially as a response to a nice letter from Estel and Patsy Schultis, partially from discussions held at the ARBA club officer's meetings at the recent convention and also from several other occasions past, present and I'm sure again in the future, concerning sweepstake procedures, I am going to attempt to pass on some thoughts and information to the membership that I hope will help the situation.

Estel and Patsy wrote a letter concerning the fact that their show was not listed in the last DR and that they thought that they had sent it in soon enough that it should have been. This is correct, it should have been and it was in the listing that we mailed to Kahlers for inclusion in the DR. Unfortunately, for some reason, the Postman failed in the keeping of his appointed rounds, and it took some ten days for this First Class letter to reach it's goal. By then it was too late for that issue of the DR.

As you are aware there is a two month period between the publishing dates of the DR. There is also a two-to-three week period until the delivery of the DR to the majority of the membership. There is also a two week period prior to the publishing of the DR, when the show schedule has been compiled and sent into the Kahlers. So we are talking of a length of time of three months and possibly longer. For this reason we don't feel that we could send the listing in sooner than we do. For this reason, we have repeatedly reminded people that while we accept the sanction requests later, we cannot guarantee that they will appear in the DR unless they are well in advance of the show date.

So, members, what I want to say is that if you are a show secretary, send those sanction in <u>well</u> in advance. And if you are not the show secretary, but just a member of the club, let these people know how important it is. This applies to all specialty clubs. When I visit with other specialty club secretaries I find that we all have the same problems, and usually the same thing that happens is going on nationwide.

The next step and our most perplexing one, is to send in ALL OF THE NECESSARY INFORMATION with the sanction request. We do not process an incomplete sanction request anymore. We tried to just write and ask for the necessary information, but too often did not get a response, and were left hanging. So now we just return the sanction request with a notation of what is missing, and to re-submit with this information. People do respond this way. What do we want: There are a few basic facts that we need to issue a sanction and most clubs are the same in their requirements:

ARBA Code number. NO CODE - NO SANCTION. ARBA RULE.

Date of Show.

Sponsoring club.

Location of Show.

Show secretary and complete address including ZIP CODE.

A check or money order for \$6.00
Believe it or not, we have several times received a check in an envelope with no other information. We also have special problems with fair shows, as they generally do not understand the procedures, or just what an ARBA code is. If you local fair sanctions Dutch WHY NOT TAKE THE TIME TO MAKE SURE THEY KNOW WHAT IS EXPECTED (CONT.)

of them.

We send the ribbons out via third class mails prior to the show. We have had few problems in this area, although a few do go astray. We simply replace those. It has worked well to date.

The last step is to receive the show report. There is a 30 day limit to send this. Here again, Dutch members, lend a hand. Our show report is not too complicated, but with your experience you can assist those secretaries.

In that way even if the mail would go astray I would be sure to have most of them. If you would start to send them every Monday morning I would have them by no later than Thursday - If I don't get them by Friday I could let you know. This may be a little simple but I honestly believe it would work. Just type the show on a plain sheet of paper as you get the requests (No special order-I will sort them out) and then Monday morning put it in the mail. DIRECTOR FROM MICHIGAN

Dear Fellow Dutch Breeders: As Kathy states some of us Directors have been rather slow in sending in articles for her. I'll have to plead guilty, as our friend "Gietzie", Bill Geitzenauer has done more than his share of very fine articles. I want to say, "I agree with a very large amount of his writings, especially on youth."

We have very little respect for a person who will pass on to a child a badly bred rabbit. It may not be a first or second place winner, although we have sold several to youngsters, just getting started this year and they have done very well in Michigan and Ohio. Get these kids off on the right track, give them kindly advice, explain carefully to them the questions they ask. They are our future.

We had the pleasure of helping a young lady in New York State having a renewed interest in Dutch after a dismal experience with the stock she had before. She is now a happy young Dutch Breeder.

Also as Bill says, "give the youth a good break on price." Most of us believe the practice of out-right giving a rabbit to a child will make the child feel it is worth nothing. If you charge just a small amount, it is money they have to part with and they will value the animal, because they have paid a reasonable price for it.

We sure had a miserable winter and a very hot summer but considering it all we came through with our pens filled and we lost at least 150 to 200 babies in the terrible cold. Even after 3 or 4 weeks the cold was so bad the young did not thrive. Then all at once heat and as usual long ears, but when the bodies catch up with the ears they don't look so bad.

Our sales emptied our pens fast in the Spring but Summer breeding was hit and miss.

The one thing I want to mention here is loss of your young, or the young not doing well or going backwards at 3 to 5 weeks of age. After long years of experience I can tell you it is the Mother's milk slowing down and becoming very toxic to the young. I have lost a whole litter before I observed what was going on. I have 2 or 3 in a litter get sick, so I pulled the Doe away and those left were looking ready to die but in 2 to 3 days were picking up again. We had a Chocolate a few years back and she had gotten sick from Doe's milk. Eight weeks from the time she was taken from the Doe she won Best Chocolate in about a class of 30 and went on to be a Grand Champion. You find this problem in the hot summer months rather than in cool weather. I have had many breeders complain about this happening to them this year.

This article will be in print long after the Convention at Houston and we will have missed seeing and visiting again with old friends and new among the Dutch breeders and there are no better.

I must tell you about the trip Flo & I made the first of August to the South, Kentucky, Tennessee, Georgia and Virginia.

We arrived at Whitwell, Tennessee at about 4 p.m. on August 2nd. Had already made up our minds we were going to visit Wm. (Bob) Griffith and his wife Wilma though we had never met Wilma. postmaster said, he knew where Bob lived but did not think he could direct us in and around the mountains, so he had his wife call and tell the Griffiths we were there. Bob was at Whitewell in about 15 minutes and we followed him back to their home. Meeting Wilma was a pleasure and she made us feel very welcome, with Bob contacting Billy Luck and wife - more rabbit people and having them come over to meet us. Bill & Mrs. Luck spent several hours visiting too and the time flew by. Anyhow we were invited to stay at the Griffith's home overnight and we surely did appreciate it and enjoyed ourselves. We still claim "The Dutch", "The Dutch Breeders" and their friends are the best. Bob had some fine Dutch and Polish and it is hard to figure how their ears stay short in that heat. Again friends if you have problems I might help you with do not hesitate to write. 30 years has taught me a lot.

When we got to Lucasville, Ohio on the way home we knew we were near the Rice Rabbits. We looked him up in the phone book and asked him if he had a Sr. Buck, N.Z.W., we could get. He said, "He'd be over in 15 minutes and was with a White Buck that had placed 1st in our Detroit Convention in 1973. We visited about 45 minutes and then headed for home.

MAN'S INHUMANITY TO RABBIT

The 1977 show year is almost over but little has been done to upgrade our system of selectively placing Dutch at our shows. This has been a real complaint at some of our shows in the East. After listening to exhibitors and observing their complaints it is imperative that a system must be develope to teach people how to judge Dutch to our and the American's Standard. There was always some exhibitors who complained that their Dutch were not selected first. In the past the majority of the time it was only the one exhibitor's ego speaking, not the concensus of the majority. With the amount of mail received on the subject it does merit consideration. From personal experience it seems that some judges are excellent on some breeds while almost being totally ignorant on others. Their technical dictionary on the different breeds has a lot to be desired even going so far as to call stops "boots" and ignore blazes calling them narrow or wide cheeks! Gentlemen and Ladies how can we progress with this amount of non-instructing duties performed each Sunday. It is no wonder that newer breeders are in a quandary asking questions that they would normally observe at the judging table. In all fairness we in the East do have our handful of excellent Dutch Judges but cannot pick them to judge our Dutch without upsetting the show Superintendents.

At the last show the judge finally and triumphantly pick Best of Breed a Black Sr. Buck. The way the rabbit was posed you would think the judge was proud of his decision! A fellow breeder of many years was standing next to the table. The people were trickling away returning their stock to the carrying cases. The only 2 observers left were this gentleman and myself. After calling the judge over (the B.O.B. had not been picked up as yet) the man asked how the animal could be B.O.B. The judge perhaps humoring him stated that it was the best Dutch at the show. He also proceeded to point out the good points. After completing his tale the breeder proceeded to tell the judge that if this was the best Dutch at the show, heaven help the rest of them. The judge still keeping his cool was looking for a carrier to rid himself of an impending situation but none came forth. The exhibitor took the B.O.B. rabbit and proceeded to point out two. mind you not one, external disqualification. The first was a crooked right hind leg so obvious that it was fully one inch out of alignment. It was even hard to place the hind legs together to get a look the stops. It kept slipping out and opposing the normally easy to do The judge looked around (no other exhibitors within 20 feet) and at the breeder and stated "I sure didn't see that one", with a sheepish grin. He then stated "well you miss one once in awhile." The breeder then told the judge that the person who it (the rabbit) belonged to should be informed of the fact and not use as a stud buck, because 9 out of 10 times it is genetic and can ruin an entire herd in two years. The judge agreed but made no effort to note this on the card which was laying next to the rabbit. exhibitor then showed the judge where there was an excess of white hair (and there really was) in the ears enough to disqualify the animal. Again the judge admitted not seeing the white hair or even mentioning "grizzled ears" on the remark sheet. The judge admitted that the white hair in excess was enough to disqualify the animal. The carrier arrived, picked up the rabbit and took it back (CONT.)

to someone's carrying case. The rabbits for the next breed were arriving on the table and he left the exhibitor and started to check for disqualifications and eliminations of the new breed. Case closed.

For some reason or other this has happened twice in the last 3 shows that this writer has been the observer. The animals were two different animals and presumably owned by two separate breeders. In both cases the Dutch had crooked hind leg/legs!

It has still been my unfortunate displeasure to, this past year, see some atrocious Dutch judging. On one occasion I as an exhibitor was forced, because it was doing an injustice to many new breeders observing, to call the judge's attention to the fact the Dutch DO NOT have Eye Circles, rather they have cheeks which during the short conversation he thought were worth 20 points.

On another occasion this spring a judge was not looking at the neck when checking the Dutch. After observing two classes, I asked why he was not checking necks, from over the table quietly. He remarked that there are NO points on neck, so why look at them. My reply was that spots in the white often show up there as well as there being 5 points on the neck. He looked put out so I dropped it! He never did look at the neck with some 45 Dutch yet unjudged! In the past 3 years this writer has gone to less and less shows because of this. I wonder how many fanciers have gone home and NEVER returned.

Would it be possible to issue judging licenses for Fancy breeds exclusively rather than ALL breeds as is in most cases. It has been extremely candid that what is happening has produced LESS RESPECT for the A.R.B.A than WE including myself would like. Our old timers preach to new breeders the merits of excluding Dutch with bad traits and breeding for point majority with type color and markings being in that order most important.

As a matter of fact a judge last Sunday asked me why MORE points aren't on the Dutch type. He said it must be, to be a Dutch. I looked sheepish and said, "I don't know why." He stated that other judges he knew asked the same question. Perhaps you yourself have asked the same question.

We are told to place a formal protest at each show this happens. Do you know how this upsets a show? How to get on everybodys "X" list without even trying? If you've ever seen it happen, what do you think of the person protesting? I understand that the A.R.B.A. is making it harder to obtain licenses. Does this mean that each new judge will know our Dutch and 30 some other breeds, EXPERTLY? Look up the word in the dictionary. It is a step in the right direction, perhaps only a baby step but a step never-the-less. Maybe a computer would help.

As you can see man's injustice to rabbit is still occuring! (All pertinent facts and names available to A.R.B.A. officials only.)
Hopefully my A.R.B.A. number will be re-issued next year!

KATHY'S TWO CENTS

As all of you know by now, Iam probably the most unknowing when it comes to rabbits. I mean my hobby is people and typing and also writing at shows. Bob's hobby is rabbits. Anyway when I was typing Bill's article and he thought maybe we should have judges who would judge only Fancy Breeds. Here in Illinois it wouldn't work. I just went through some of Bob's remark cards and some of the Judge's remarks on his Dutch were: about the blaze, neck clean, cheeks, saddle, undercut, stops, Color, fur and of course type. Now these remarks varied from ragged to good but the point is - the judges who gave these remarks do not raise Dutch, nor do they belong to the Dutch club. Bob does have some remarks by a Dutch breeder and let me tell you some of these remarks: Good Type - pinched hindquarters. Fairly Good Type - Pot Belly. My Question is can a Dutch with Pinched Hindquarters or a Pot Belly have GOOD or FAIRLY GOOD Dutch Type. I don't believe it can.

I believe a FORMAL protest is about the exhibitors only good answer but like Bill, Iam sure most of the breeders would accuse us of being sore losers. So the next best thing is to quietly inform the show officials at that particular show that if they hire that particular judge they can count your entries out. I guess you could say this is a form of blackmail but it does work. I know that the Dutch exhibitors here in Illinois stick together pretty good and when we see our Dutch being mutilated then we just sort of by mutual agreement vow never to show under that judge again. Like I have stated we will let the show officials know. The Dutch in Illinois are usually in at least the Top Six breeds shown and also we have many exhibitors (some show other breeds), but we usually all buy raffle tickets and eat dinner at the show.

Also since this show three other Dutch Breeders have asked me if I noticed this Judge's conduct. Inefficient judging is bad for the exhibitor but a display of this sort is very Disgusting to say the least. However, this judge very seldom judges in Illinois and I certainly will do my best to see that if he does it won't be Dutch. I would like to state again that this WAS NOT an Illinois Judge and I compliment ALL other Judges I have showed under for their Honesty. I have NOT ALWAYS agreed 100% with their placements, but I have NEVER BEFORE doubted a Judge's Honesty.
