PORPOSED CONSTITUTIONAL AMMENDMENT

Change the first sentence of Article I of the By-Laws to read as follows:

Insert after the first sentence the following additional sentence:

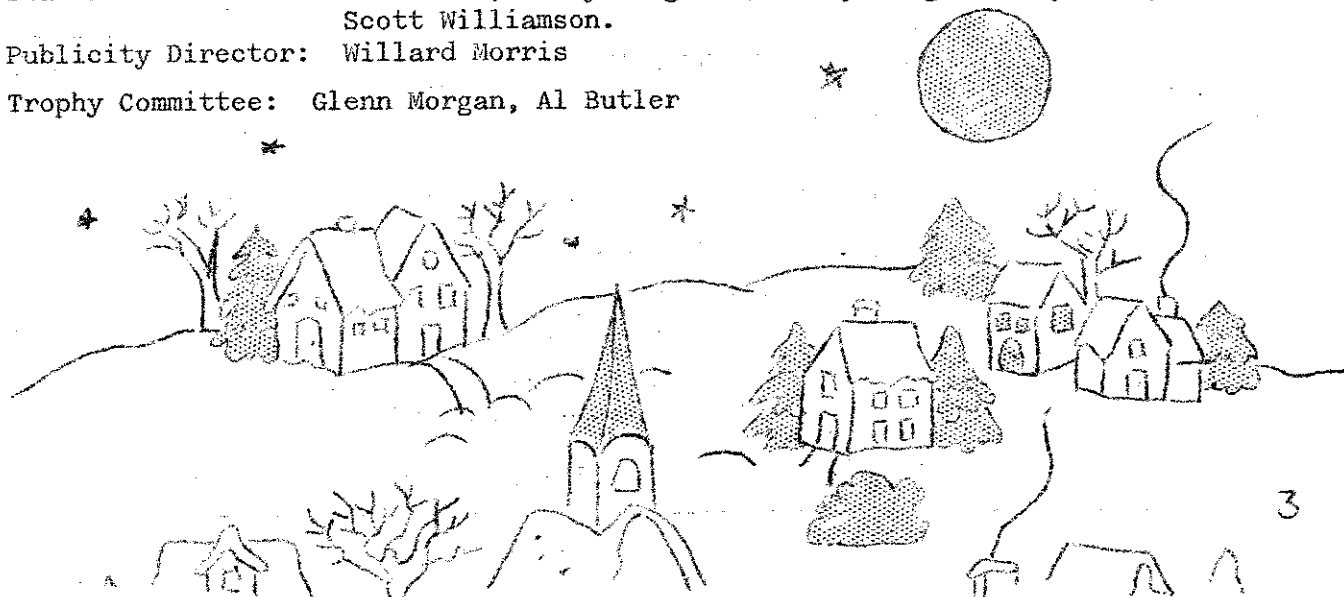

AMERICAN DUTCH RABBIT CLUB MINUTES

Board of Directors

October 8, 1978

The meeting of the Board of Directors of the American Dutch Rabbit Club was called to order at 8:30pm October 8, 1978 at Saginaw, Michigan, the site of the 1978 ARBA Convention Show, by President Jack Wireman. Present were Vice-president Guetschow, Co-Secretaries Doreen & Larry Bengtson, and Directors Lynn Cooper, Don Brady, Roger Eich, and Don Lovejoy. Absent was Bill Geitzenauer.

A motion was made by Cooper, seconded by Guetschow to dispense with the reading of the minutes of the previous meeting, as they had been published in the Dutch Reporter. Carried.

Under officers' reports, Vice President Guetschow reported that things seemed slow in his area. He has been busy working on the 1979 National Dutch Show plans, and on the proposed sellers class rules for the convention show. Director Eich reported that the Dutch entries seemed to be down in his area, but that the lab business for Dutch was very strong. Director Cooper reported that Dutch also are down in his area, and that we need to be promoting our youth in order to improve the future for the Dutch. Director Lovejoy reported that entries seemed to be lower in the West Coast area also. He commented upon the quality of the Dutch Reporter, and that he feels that it is the backbone of the club. Director Brady reported that his project of sending the guidebooks to new judges was going well, and that he had even received thankyou's from some recipients. Secretary Bengtson presented the financial statement (which is published separately) and told the Board that the office of Secretary is running very well, with few problems, and that the Dutch Reporter being with the Secretary's office was working out well. President Wireman reported that the 1978 NDS final report was done, and presented the board with a copy. He reported that there were many good reports on the NDS, and that it was a very successful show. He discussed the reasons necessary for moving the DR, as Kahlers were moving to a new area, and were unable to continue publishing the DR. He thanked the election committee for a fine job, and also announced that he has appointed the same election committee for 1979.

Under committee reports a letter was read from Glen Carr, chairman of the Standards committee, recommending that there be no changes in the present standard.

The election committee report was presented. (Printed elsewhere in DR)
Larry Bengtson gave a report on the Golden Jubilee committee. We are busy working on a special issue of the RABBITS magazine in January. We are planning many new and existing items for the DR during the 50th anniversary year. The most important item however, is that we are in need of a lot of support from all the officers and members if the GOLDEN JUBILEE is to be successful.

Under unfinished business there was a lengthy discussion concerning the sellers class. It had been decided to try a new approach at this show, and new rules which were more appropriate to this show were developed.

There was a motion by Brady, seconded by Cooper that the following Sellers Class Rules be used on a trial basis; until we have some experience to base more permanent rules upon.

1. All entries in this class subject to sale to the highest bidder.
2. No entry fee to be charged for this class. Rabbits entered in this class may or may not be eligible to register. Donors not entering rabbits in open class must either make arrangements with the sponsoring club for the care of the entries or provide adequate care during the show in some other manner.
3. Entries to be given to the Sale Chairman. The Sale Chairman will have the responsibility for inspecting entries to determine their health and suitability, and may refuse any entry(s) he feels are not in the best interest of the ADRC. Entries will be accepted until judging time.
4. All pedigrees MUST be accompanying rabbit to be sold at auction. There is a limit of five rabbits entered per individual, family or rabbitry.
5. The sellers class will be judged as one class without regard to age, sex, or color.

Board minutes, continued.

6. The time and location of the Auction sale will be determined by the Sale Chairman and board of directors of the ADRC.

7. Any rules or regulations not provided for shall be decided by the ADRC Board. (Note: Following #1 the additional sentence should be inserted.) The sale price of each animal shall be split in half, with one half being returned to the person donating the rabbit, and the other half of the proceeds going to the ADRC. The above motion concerning the Sellers Class rules carried.

The Publicity Committee report was given by Willard Morris. He reported that he has been able to get a number of new items, and that they seem to be selling very well. He noted that he could use more ideas of what people would like them to get, and that as long as things moved well, there would be a constant turnover of new items. The Board commended Morris for his good work on the Publicity Committee.

New Business: Election results were announced. There was a motion by Brady, seconded by Lovejoy that the top three directors candidates be accepted as elected to office, with the concurrence of the members in attendance at the General Membership meeting. Carried.

President Wireman asked for approval to appoint Mickey Watters of Tennessee as Director to replace Don Reid who had resigned. Board of Directors concurred.

After a discussion on the Dutch Reporter situation, there was a motion by Guetschow, seconded by Brady that it be approved to accept President Wireman's recommendation to leave the Dutch Reporter with the Secretary's office. Carried.

After a discussion concerning the purchasing of the mimeograph machine from Kahlers for a price of \$500, there was a motion by Brady, seconded by Guetschow, that the purchase of the mimeograph machine be approved. Carried.

There was a short discussion concerning the Seminar on Gray & Steel color to be held at the convention. It was decided that the best time would be after the ADRC meeting and auction.

Secretary Bengtson discussed the idea of having officers responsible for certain jobs within the club.

There was a discussion concerning the NDS committees having cooping available by Friday morning for early arrivals.

President Wireman presented the bid by the Eastern Dutch Club to hold the 1980 National Dutch Show in Allentown, PA. Motion by Eich, seconded by Brady to table the bid until the Board meeting at the 1979 NDS. Carried.

Motion by Eich, seconded by Brady that the meeting be adjourned. Carried.

The meeting was adjourned at 10:45pm.

IN THE GOOD OLD DAYS

It was our pleasure to be able to visit with Mr Dutch himself, our own TOM SHUFFLEBOTHAM, at the recent ARBA convention show in Saginaw. Tom was looking great, and as usual enjoying himself. Tom sure is a veritable wealth of information about Dutch, and Dutch people, and he was gracious enough to send me a couple of DUTCH REPORTERS, one from 1945 and another from 1947.

I am personally extremely interested in these momentos of our club's history, and I would like to ask that anyone who has these items to share them with me. If you can send me them, I will make copies of them for my own files, and return the originals to you. From time to time I will use some of the information for articles for the DR, as I run across things that I feel will interest you.

Our DUTCH REPORTER has always been one of the ADRC's best features. For years it has been one of the best publications of any of the specialty clubs. It is interesting to note that in the April 1945 issue of the DR, there is a mention of a contest to design a new front cover for the DR. The new cover design was contributed by Herman Roerig of Iowa. It is the cover we used on the DR for one issue about three years ago, to show you some of our history. The five small Dutch that grace our present covers are the same, but the large drawing of the Dutch is quite different. One interesting item is the length of the stops on the old cover. They are longer, as at that time the standard called for stops half the length of the foot. The style of the lettering is the same as our present cover, but it is rearranged quite a bit.

By coincidence, there is a short article in the April 1945 issue concerning the name DUTCH REPORTER. I'll repeat the entire article as it is short and of interest for other reasons also.

Have just received a letter from the member that supplied the name for our bulletin, Mr. Herbert Lawrence, and he says, "I AM IN THE ARMY NOW." He is stationed at Camp Leonard Wood, in old Missouri and has promised to drop in and see us the first chance he gets. He states his rabbitry is going on just the same, and that more stock has been added instead of reducing, and that post war plans are in the making. How about you members dropping him a few lines, I know he will be glad to hear from you. Address: Pvt. Herbert Lawrence, ASN 42210911, Co. C., 30th LTBN, ASFTC, Fort Leonard, Missouri."

So even though World War II was in full bloom, the never daunted Dutch fanciers continued on, right up to the present. Another short article to R.L.Souers, who was then the Secretary-treasurer and DR editor is of interest:

Dear Mr. Souers;

Enclosed you will find \$1.00 in Defence stamps for the Annual Dutch Show, which I wish you to use on any color of Dutch you see fit, as so many put (specials) on one color only and other colors are way down in prizes. I think this is one real way to boost the Dutch rabbit and I think anyone could spare at least one 25¢ defence stamp. I will send a few from time to time, and hope to see many other breeders do something for the Dutch. Come on Dutch Breeders, lets see what we can do. Respectfully, William N. White, Centralia, Illinois.

Apparently even in 1945 collecting specials seems to have been a problem. Note however, that our great National Dutch Show existed way back then, over 33 years ago. In that DR they also report that the Judges selected for the National Show were James Blyth and R.J.Bernhardt. Both of these men are still members of the ADRC, and both have been honored with life memberships for their contributions.

Do you know that the April 1945 DR was seven pages, both sides, and yet had sixty (60) advertisers in those pages. That is more than we have now.

Four of the Directors of the ADRC in 1945 are now life members of our club, and they are James Blyth, Tom Shufflebotham, Charles O. Lewis and George Bayliss. A fifth Director, Carldon Gaddis, just recently passed away, and was a life member also.

In June a lady called who's son had purchased a pair of "good black Dutch" the summer before. The son was planning on showing them at our county 4-H fair along with 10 young they had. But they didn't know what color some of the babies were. So that night after work I stopped by to see if I could help. HEAVEN HELP THE DUTCH CLUB if this is the kind of rabbits they are passing as "good black Dutch"! This boy is 12 years old. He paid \$45. out of his paper route money because he wanted something good and he really liked the Dutch he had seen, though it was obvious he hadn't seen many. You could tell he kept excellent care of them. His hutches were outside, but sheltered and clean. Neither the buck or the doe had any type. Their color looked like someone had put flour on and rubbed it in, it was so faded--all the way down. Both would have been disqualified. The buck had a drag on his shoulder all the way through the saddle. The doe had 2 split stops. The babies had long narrow heads, lop-type ears, drags like the buck & stops like the doe--and EVERY COLOR IMAGIONABLE. Faded Tort with bad ticking, lilac, and something I would guess to be either Gold or Cinnamon, since I've never seen either of these.

Our club is really growing and we all seem to be a pretty nice group of people, but with something like this happening, how long are we going to last? This pair of "Blacks" was sold to this boy by a member and told it was two of his best. They were not purchased in our area, so the breeder probably thought no one would ever know.
