



The Bengtsons term of office as General flunkies for the ADRC runs out as of January 1, 1932. We were appointed by the Board of Directors to serve a term of three years. Since this may be the last time I edit the Dutch Reporter, I want to take this opportunity to thank everyone who did his or her part to support this publication. Special thanks to Bill Geitzenauer who is the most steady supporter of the Dutch Reporter with his articles. No other member or officer has contributed as regularly as Bill. I know how hard it is sometimes to knock out that next article when you feel that you have exhausted all of your ideas. He has always come up with a new thought provoker. Something that gets a response or answers a question.

For in a litter of six or eight Dutch what percent of rabbits can you keep? Say one or two percent and then the others must be culled. Any information would be appreciated.

Editor: It would be very difficult to keep track of local labs from this distance. I would suggest that you talk to other Dutch breeders in your area and see what they know. I think that usually you would find that labs do not buy from individual producers. At least this is generally true in this area. They usually have a supplier that buys from many raisers and then fills their orders as needed.

In our listings of show winners, we list those not belonging to the Dutch club only as a NM - why not give their names and the denotation NM so we members can approach these folks and ask them to be part of our wonderful, friendly organization. 1931 ARBA Convention & Show Syracuse, New York Minutes of the Board of Directors Meeting

American Dutch Rabbit Club

The meeting was called to order by President Brady, of the Board of Directors of the American Dutch Rabbit Club, Syracuse, New York, October 19th, 1981.

Present were President Brady, Vice President Williamson, Directors Wireman, Geitzenauer, and Williamson. Also present were Al & Barb Butler and Tom Dietrich.

The minutes of the previous Board of Director's me eting were read. Corrections were made by Wireman concerning the Date of the NDS, the time of adjournment and that it was Jack Wireman, Al and Barb Butler that presented the resolution concerning a youth membership in the Youth Committee Report.

Officer Reports:

Wilbur Williamson reported that he has been attempting to develope more interest and action concerning the Youth, but was having little response.

Scott Williamson had several suggestions to present; a Dutch logo rubber stamp for the publicity committee, having a Dutch tape made up for the ARBA tape files, Having ribbons and rosettes sent out after the shows instead of prior to them, and he commented upon the lack of specials at the ARBA enovention show in Syracuse. He also commented upon the excellent job the publicity committee was doing, with their many new items.

Don Brady reported that things were improving at the shows in Texas, with more members and exhibitors recently.

Bill Geitzenauer reported that things seemed to be going very smoothly for both the Eastern Dutch Fanciers, and the ADRC, and both are thriving. He said that he would have to return home to work the next day, wo would miss the general membership meeting. He also reported that the members in his area would like to see the specials required for best of each variety raised to at least \$2.00, and that many thought that double sweepstakes points should be awarded for the two national shows each year.

Jack Wireman reported that the Dutch entries were still down somewhat in Ohio, part of the cyclic pattern of popularity of breeds, but that they were working to bring it back up.

Larry Bengtson reported on the financial condition of the club, noting that we were in excellent financial condition, considering the recent raising costs of postage, printing and ribbons. The membership is slipping slightly, as seems the case with several other specialty clubs. See financial statement elsewhere.

Committee reports.

Al and Barb Butler reported that sales for the year are around\$1400 with the purchases about \$1100. They presently have an inventory of about \$18 00 which is paid for. Jackets are picking up in sales. They reported that they did \$593 in sales at the NDS in Champaign. They also did \$139 in sales the first day at the ARBA convention in Syracuse. Business seems to be thriving.

Wilbur Williamson reported a lack of response to his inquiries concerning youth activities for the club. He has contacted several people who had earlier expressed interest in assisting, but has not recieved any responses. He needs some people from different areas to help, and is open for suggestions, help, or any assistance anyone would be interested in contributing.

NEW BUSINESS:

Motion by Jack Wireman, seconded by Scott Williamson that Roger Eich be awarded a honorary life membership. Motion carried by majority vote.

Motion by Bengtson, seconded by Bill Geitzenauer that a honorary life membership be awarded to Lester and Louise Johnson, to be awarded at the 1982 NDS in Hutchinson, Kansas. Motion carried. Minutes of the Board meeting continued:

Another Sweeptakes Opinion

In the last issue of the Dutch Reporter (July-August), Bill Geitzenauer had an article on the minimum requirements for specials on Dutch. He stated that the local club would make about 33% profit if they do what he calls for. But he forgot a very important item and that is class money put up by the local club.

Using his figures of 60 to 90 Dutch in a show and an average of \$112.50 at \$1.50 entry fee per head. The cost to the local club will be:

Sanction fee \$3.00 Special fee \$16.60 Half Judges fee \$35.00 Class payback \$45.00 Total cost \$104.60

Using this with 75 rabbits entered in one breed like Dutch the local club now makes \$7.90. Out of this must come the cost of mailing in the sanction report and the checks to the exhibitors. If there are 9 exhibitors, the cost of mailing is \$1.80, envelope \$1.50, cost of checks \$.90, for a total of \$4.20. Now you have a total profit of \$3.70.

I would think that this would be a very good show. The reason being that the show paid for itself. But there are others that would not agree because the dlub did not make anything. The only thing that I can see with Mr Geitzenauers minimum requirements is some clubs raising their entry fee up to \$2.00 or \$2.50 per head.

Most of the breeders that I have seen at different shows did not even want the ribbons that they won and a few have even refused to take of have donated the trophies they won back to the club.

If a man is showing rabbits to make money he has made the biggest mistake. The reason for showing is to find out if what you are doing is right. Or if there is something wrong to find out what you can do to correct it. Another reason is to meet people with the same interest and make new friends.

Well, I think that I have taken enough of your time and maybe space in your magazine. So I will finish and say Thank you and hope to see some of you at the spring shows.
