



will be one of the larger breeds in the area.



The ARBA Convention in Seattle is over now. I did not attend but shipped in four rabbits. When I picked up the rabbits at Detroit Metro I was talking with one of the air freight employees who had a pet rabbit for 7 years and had it litter trained. He said it was smarter than their dogs.

The next National Dutch Show will be in Canton, Ohio, hosted by the Ohio State Dutch Club. Their last show was very efficiently run, so with most of the same cast doing it again, — it should be an event all Dutch breeders will want to attend.

I got started in Dutch rabbits as a kid. My dad raised numerous breeds but I did not really care for any other breed than the Dutch. I was about eight when I got my first Dutch. She was a bred chocolate doe named Tracy. She had Snoopy, Chip, Blackie and Inky in her first litter. Snoopy was sold as a show animal - Blackie and Inky were put into the mothering program - Chip was put into the food program. I still have a hard time eating rabbit to this day. I got out of rabbits at about the age of 10 years but after college, etc. got back into Dutch in about 1976. It is a very interesting and challenging hobby for me.

Some Dutch breeding tips I find helpful are: do not use thin headed does or bucks in your breeding program - when breeding blacks, throw in a deep blue buck to enrich the black color - you don't have to have alot of rabbits to win the big shows, - quality rabbits over quantity. I have 12 adult rabbits as of now.





GRAY DUTCH

THINK!

This is my own opinion but not copyrighted.



First, I cannot see gray in the brown sandy grays we have on the table. Next, the standard says, "Faults- brassy tinge, white hairs." Standard says, "slight sandy tinge permissable." What color of sand are we using here? White, brown or something else?

You talk to standard people and they bring up the English standard they use in England. I believe we want to raise American rabbits by an American standard. Now, wouldn't one of our sandy grays look nice if we used white sand? How about some red sand? We have the brown sand now. I do believe that the grays should have more of a blue hue to them. Not completely like the blue-gray now but more so than the gray now.

Take a stranger to rabbits and show them a blue and a gray. They will call the blue "gray" and the gray a "brown." If a new breeder talks to you about gray Dutch, make sure they are not referring to the blue.

As of now we call them gray. We can't call them sandy as we have more colors of sand.

We have the same problem in our steel and torts. The judges keep placing torts no matter what color they are. The breeder thinks he has the right color and doesn't try to improve. The judge didn't know, so he was no help. Don't blame the judge as maybe he never saw good tort color.

It boils down to one point. Monkey see - monkey do. A.R.B.A. says we have to have a permanent, legible ear number. OK - the judge goes to read it, uses a flash light or holds the rabbit up to the sun. It could be an A or C. Card says C - breeder says C, so the judge says OK! If it can't be read, eliminate it so the breeder will make it plain. If not, this same thing will go on show after show. The same goes with our color of Dutch.

At one time, if no undercut could be seen it was called gray. If you could see it, it was a steel. Undercut determined the rabbits' color. Now, if its a dark undercut it's a steel and if no undercut or light undercut, it's a gray.

I hope some sense can be made of this and some of you breeders will sit down and give your points of view. If you think I'm all wet, well toss me a towel to help me get dry.

HELP US GROW

While talking recently with a Dutch breeder friend he remarked that he had an abundance of good Dutch but no cooping to put them in. After a highly successful season of matings the young produced were now ready to be seperated. This is not uncommon but ironic that just one month earlier he had a chance to sell some to at least 2 breeders that wished some stock if they were offered.

Another friend recently confided that he had started at least 3 new or newer breeders of Dutch this year and had in fact oversold what he had produced this

The state of the s

year by over 100%. What this meant is that he will start 1983 with less than half the breeding does that 1982 was started with. Yet, he was quite satisfied that he did propagate the Dutch club and Dutch rabbits. Needless to say he will not be in a position to sell any stock for many months, perhaps up to a year.

Those of us who have been at both extremes in our program know that a blend of both is desireable. We must release a percentage to new breeders so that perpetuation of the Dutch rabbit is insured. If new breeders or breeders of Dutch who are in trouble due to unforseen circumstances are not "handled" by the Dutch community, two things will happen. One is that the membership and hence the breeding of Dutch rabbits will decrease at, if figures are correct, 20% rate each year. (Not 60% in 3 years but 40%, 20% of that left) What this means is that if we do not help other members, new or not, in three years only 60% of the rabbits will appear on the show table as we have today. After looking at some show results in the D.R. I wonder if perhaps this is not beginning to happen. Through a supreme effort of some we are now enlisting new members for our club and status quo is the result. It does seem then that the same number would be shown each year, but this is not so! Perhaps these new members are and have been showing anyway but not joining the club until now.

The way it is going is very dangerous for our club. Eventually the non members will theoretically all become members but more important than this is that the number of "shown" Dutch will continue to depreciate or fall off. This eventually will turn into an avalanche type of structure in that the older breeders find less competition at the shows. In finding that there is no necessity for trying harder for perfection may become lack-a-daisical and cut back on their own show herd or lose interest altogether and fade out into some other more challenging hobby.


We today, will have everything to say about tomorrow concerning the breeding and showing of the Dutch. We are our own masters of this destiny. All of us must strive to get that beginner started over a period of time or save a breeder that needs help. We must preserve the hundreds of Dutch masters who have preceded us and helped to get us started through their perseverance, responsibility and down right compassion.

Don't be afraid to sell that older pair that have produced good Dutch. You have gotten your glory from their or God's reproduction. Get that human being started right by letting them have something you are proud of. It will come back 10 times to you in benefits in that feeling of accomplishment, "tasks undertaken - tasks completed."

In closing, please be careful as we still need you as your work never seems to end - probably as it should be.



A LITTLE HELP By Bill Geitzenauer



While talking to one of my friends, he remarked that when a litter was to be weaned he removed the doe from the cage rather than the youngsters. Many of us do this periodically for some reason or another, but rarely consistantly. He said this reduces the "shock syndrome" which does happen and is characterized by a few days where the young refuse to eat. This weakens the youngsters often making them susceptible to deseases that normally are controlled by a healthy Dutch.

Most of us keep the sexes together until they are 12 weeks old whereby the bucks must be isolated from the does and each other. The does may be left together for another two weeks unless they show signs of fighting. I have noticed that if they (does) are next to a bucks cage, they tend to be more uncomfortable during this period showing signs of restlessness and may begin to fight or worse.

Being asked more than a few times when to breed young does, have personally bred them between 16 weeks and 25 weeks. How do you know? By observing the does themselves. They must, of course, be healthy, filled out, being large enough to handle it. It is something that cannot be taught on a chalkboard but must be observed by experience. Some are not ready even at 5 months old but if at 6 months old they have not developed, there is something wrong either in the breeding program, type of food or the environment.

Never hold them back intentionally more than 6½ to 7 months unless you cut their feed down slightly. The doe tend to accumulate fat and becomes sterile unless cut down in intake. For those that you have trouble breeding, (adults) you may do what some of us do. We add a teaspoon of white vinegar into their drinking water for about three days and it seems to help. Maybe Dr. Reed could figure this out sometime. All in all, even though they are animals if you treat them like human beings with compassion by trying to understand their actions we can all have healthy developed Dutch to admire and show. Never say die, — as quitters are the losers in the end!

STAND UP AND BE COUNTED

Naturally my rebuttal of we are getting bigger and stronger all the time was not met with skepticism. People believe what they see, not what an enthusiastic supporter tells them. I can't blame them. If I were on the other side of the fence and didn't know better, I'd be skeptical too.

Over the years many close personal Dutch friends have made the remark to me, "who cares about the ARBA Convention; the only show that counts is the NDS."

I'm sorry my dear friends, but you are wrong. I too rate the NDS as the numero une show; however, the ARBA Convention is a very close second. Convention may fall into some totally different category. There is the person who is presently involved with another breed but considering changing or adding a breed that is more competitive and challenging; there is the person with no breed who is shopping and, as I met in Seattle, there is the new Dutch breeder who came to the Convention to see the best Dutch in the Country and perhaps talk with some of the top breeders, only to be disappointed at the turn out and question whether it's always like this. These are the people we need to visibly show and encourage. Take it from an eye witness, the Dwarfs, Whites and Lops of the Country are being very visible and stealing our thunder.

I know one of the big negatives of showing at a Convention, be it the NDS or ARBA is the cost involved depending on your georaphical location versus the location of the show. Travel and lodging are expensive and the economy could be better. But please, before you completely write off a Convention, consider some options: (1) Car or van pool. With a couple of phone calls or a little correspondence you may find one or two other breeders in your general area who would like to go. Get together and cut your travel expenses in half or thirds. (2) Perhaps through the D.R. or secretaries office we could have a "roomy" bulletin board. With Jenn in college the last three Conventions I've been traveling alone. Last year I "roomyed" with two other people from different parts of the Country. We all had rabbits in common and it sure did cut the hotel bill. Wish I'd found a "roomy" this year. (3) If you absolutely, positively can not make the trip, consider shipping your animals. This could be done one of two ways. Air freight or excess baggage. If you have a friend who is traveling by air to the Convention, perhaps they would take a carrier of your animals also. You can't expect them to handle your whole rabbitry but it certainly does no harm to discuss the transportation of one carrier. Also, contrary to the popular voiced opinion, shipped in stock is well cared for but if you are a confirmed Doubting Thomas, check around for a breeder friend who is making the trip. I'm sure they would be willing to keep a watchful eye on your stock; after all, you'd do it for them, wouldn't you?

I am already planning and looking forward to my trip to Colorado in 1983. I would dearly love to see a 300 or more Dutch entry; but, only you can make it happen.

Editor's Note** I have always tried to keep from voicing my opinion to articles that come in for publication, but if Barb will permit, I'd like to make an exception to that rule.

Barb, Excellent article with alot of good points, but I'd like to try and speak for many of those, like myself, who were unable to attend, or ship their rabbits to the ARBA Convention. Believe me, we would have liked to have done one of the above. To start, I don't at all feel that the Dutch are on the downswing simply because the Dutch entry in Seattle was down. It only appears to me that the Dutch may be slightly down in the Northwestern area as opposed to some of the other parts of the Country. Take Syracuse or Milwaukee for instance; There were 194 Dutch entered at the ARBA Convention in Milwaukee in 1980 and 173 in Syracuse in 1981. Both of these had minimul entries from the Northwest. Still the entry looked pretty good. I would have to speculate and again say that possibly there are more Dutch breeders in these areas.

Dutch breeders from the Northwest, at that time, possibly found that travel to either of these shows, even though they would have given an arm or leg to attend, was just much too costly due to the distance involved. Even sharing expenses can be of some hardship to some. Many travel with their families. When this is the case, there isn't much sharing that can be done and not only have you the cost of continued......

one person but 2,3,4 or more! Travel, motel, meals, banquets and any extra expenses that you may encounter can be too much of a burden at times. As far as the NDS being the only show that counts, I too disagree. You are correct! The ARBA Convention is a very close second, and I'm sure more would have attended this event if would have been at all possible.

Due to the economy and my husband being one of the fortunate (?) ones who is employed by Caterpillar Tractor Company, our plans for our family to attend had to be forgotten. First priorities first! I'm sure we are not the only ones who had to forfeit what could have been a delightful time, meeting new Dutch Breeders, in Seattle. Hopefully I will be fortunate enough to meet them in the near future.

As far as for sending rabbits with a friend, when even air freight can't be fit into a budget,— this may work out fine for many, but how many friends will say that they would be happy to take them even though they are too polite to say that they would rather not have the responsibility.


At one time, we promised to look after and bring home a trio of tort Dutch for very good friend who couldn't stay to the completion of an NDS. When arriving in the showroom the morning they were to be released, we found that one of the does from that trio was missing. After a very thorough search and a call to the party from who they were purchased, we had two to bring home. We weren't at all responsible for what had happened, and our friends were the first to acknowledge that, but it doesn't make you feel any better about the incident. Therefore, even if you don't mind sending them with someone, consider the position you may be putting them in.

I'll close by again saying that I feel the Dutch breed is constantly climbing upward. It just turned out that due to the distance and expense involved, Washington couldn't be as well represented from other parts of the Country as we would have liked. I feel sure that these people understand the circumstances that were involved. My thoughts, as those of many, were in Seattle at that time.



Most ADRC members don't know us. (Franco & Beth) We live in Rockville, MD. and like so many of you, we raise Dutch rabbits. We raise Blacks, Blues and Chocolates. We're going into our second year, and LOVE IT!

We got started with the help and patience of many local breeders. Dan Rohrer of Hagerstown, MD., and, Tom Hadaway of Chestertown, Md. are the two dominating bloodlines that make a "Lucky Foot" rabbit.

We have cleaned out our garage, and it is now wall to wall Dutch! They are sheltered from the wind and rain, but still get the outside temperatures that they love so much - with the exception of summer! We keep a grooming table and baby scale outside, and try to spend as much time with our Dutch as possible.

Something we've noticed, and I've never heard it mentioned, is how quiet a rabbitry can get all of a sudden when a doe goes into labor. The others stop playing with their pieces of wood, they stop jumping around, they stop and sit casually chewing a pellet or sniffing the air. Have any of you ever noticed your Dutch doing this? We're very curious to see if this holds true in other rabbitries Food for Thought, con't....

Something else we haven't heard of yet is the way we palpate does. I have found that as the does progress they would rather be rolled onto their backs while you have them in your lap. This seems to relax them a great deal. Especially if they are carrying a large litter. When I do this, I'll stroke them between the eyes to let them know I won't hurt them, and then gently place my fingertips on their stomach. In this way you can feel them roll very easily - and if it's hard for you to palpate (it's still difficult for us) this seems to make it easier. It might also instill confidence in the doe.

Here again, we'd like to know if this holds true for other breeders or not.

HOW WE GOT STARTED

One year ago June, my son, Jim, age 13½ bought a Dutch Tort doe from Stan Summerlin (just as a pet - ha ha). She has one small flaw. I said she was going to be a pet and there would be no more --- in August we bred her to her father, a buck Mr. Summerlin owned at that time. She kindled 5 young which we raised and sold.

In Sept. of that year we obtained a pet buck that a friend of Jim's didn't want any longer. He's about 3½ years old and such a love. We bred him to our more.

Early spring came and Jim decided he wanted a black & white Dutch. Mr. Summerlin had a beautiful buck that he said would really go places and no doubt would win big for Jim. Unfortunately, he died.

Sept. of '82 we bought a pair and a buck. The total number is now 6. Three does, three bucks. I realize we don't necessarily need three bucks, but two belong to Jim and one is mine. He (the rabbit) & I understand each other. When I first brought him home, I put him in one of our large wire cages that are off the ground to about waist high, - he went berserk, racing around and scared to death. I took him out and put him in a smaller cage with hay and a piece of sheet rock & closer to the ground. After a few days I raised the cage little by little and finally put him in the big cage beside the other rabbits. Now he's fine. Mr. Summerlin said that perhaps he had been raised on a wooden floor and so didn't know how far off the ground he really was.

One of the young new does had a case of loose bowels, and since we had lost the black & white one, I had read up on disease and certainly didn't want to lose her too. The recipe I used was; boil 4 cups of water and a handful of rice, - strain the rice, cool the water and put the water in her bottle. She drank it for about three days. She is doing extremely well and growing by "leaps and bounds".

In Sept. a neighbor and I built a 12' X 8' wire enclosure, (mainly to keep dogs out). It has a green plastic roof and is winterized with plastic wrapped around the outside. We have five wire cages hung across the back and I wire hutch on legs on the front (soon to have it hung also). We keep all our supplies in there It's small, but adequate for our needs. I spread cedar shavings under the cages as it helps keep odors down, and about every other month I rake the manure out and spread it in our garden, under azaleas, etc.

Come the middle of this month, we hope to have a new litter and in Jan., 2 more litters.





A letter from Dick Gehr was read concerning the money that could be saved by giving out large flat ribbons for BOB and BOS in the open sanctions rather than the rosettes. - An order for 250 shows is placed twice a year and the annual savings to the club would be \$754,00.

A letter from Wilbur Williamson of the Auditing Committee was read. The books were audited November 4, 1982 by Wilbur Williamson, Myrl Milhahn and William Evenburg and found to be in excellent condition. All debits and credits could be checked and cross checked. Records prior to 1982 were not available because they were trashed by the previous secretary-treasurer.

It was announced that the passing of the hat at the Dutch banquet in Seattle netted \$125.00 for specials at the 1983 ARBA Convention.

There was a general discussion on youth points: it seems there are a number of youth and adults confused as to when points will count and when they will not.

Al Butler gave a report on the 1983 NDS. Prices for the ads are as follows: full page \$20.00 - 1/2 page \$10.00 - 1/4 page \$5.00 - breeder or judges listing \$3.00 -There is a possibility our banquet will be family style served by a local Grange and our entertainment may be the same as 5 years ago, the Kitchen Comedy Gang. Ohio State Dutch Club has set their entry goal at 600 open and 150 youth.

Jim Kelly brought up the fact that many breeders from the Northwest feel like orphans within the ADRC. Breeders from the area expressed a desire to re-form a Northwest Dutch Rabbit Club and possibly host a NDS. Their two big concerns were would someone with past experience give them helpful hints on how to go about putting on a good show and would the rest of the country support them! YOUTH SWEEPSTAKES ...

By Dick Gehr

I had the pleasure of spending a day with Scott & Dianne Williamson a short time ago, and as we discussed the happenings at Seattle, he made mention of the youth sweepstake points, and the questions raised about them. After some discussion, it was decided that the findings of the Committee for Youth had been misunderstood. I will try to clarify the issue.

At Hutchinson, Kansas it was decided to start a youth sweepstakes. There were to be youth sanctions with ribbons for EOB, BOS, and BOV. At the end of the year, trophies would be awarded to the top five in the country (accumulative points to count) and a special ribbon for 6th. through 10th. place. It was also established that the youth program and sweepstakes would have to be self supportive through sanction fees received.

It was also brought up about shows that do not have ARBA youth sanctions. more, next page....

When this was the case, an ADRC youth sanction could not be obtained. It was thought that possibly the youth could receive their points if they showed in the open class, but no final decision made at that time. It was to be discussed and decided by the Committee for Youth.

Those of the Committee that could get together, discussed the matter at <u>length</u>, and came up with the following:

FIRST: As open show reports are sent in to the secretaries office, it is impossible to determine if the sponsoring club making the request has an ARBA youth sanction. (unless they applied for an ADRC youth sanction) With this being the case, you would not be able to know whether to count the youth's points if they showed in the open class.

SECOND: It would not be fair to count points from the open classes, as they would be different, in most cases, from the points the rabbit would have won had it been shown in the youth division. FOR EXAMPLE: A youth shows a Dutch in an open class of five rabbits and wins 2nd. place. This gives the youth 20 points, whereas, if the same rabbit had been shown in a youth class, there might have only been two in the class. Even taking first place, the rabbit would only get 12 points, so it would be unfair to give the rabbit more, or less points than it would be entitled to in a youth class. This being the case, all rabbits being shown in the open class receive open sweepstake points, while those exhibited in the youth, receive youth points.

THIRD: Since the youth sweepstakes is to be self supportive, it would not be right to possibly award a trophy for points accumulated in the open class, as the money from the youth sanctions is what will be used to pay for these trophies.

FOURTH: If we would allow points for youth to be awarded from open classes, we would be defeating our purpose of a youth sanction. The sponsoring club would feel that it would be a waste of money to pay for a youth sanction if the youth are going to receive their points even if they show in open class. Without the aid of the fees collected through ADRC youth sanction, there would be very little chance to have a youth program.

Based upon these reasons, the Committee for Youth decided that youth points can <u>only</u> be accumulated by showing in the youth class of an ADRC youth sanctioned show.

We realize that there is sometimes a problem of persuading the sponsoring club to obtain a youth sanction from specialty clubs. Possibly a few youth can get together and donate the sanction to the club. If the club is made aware that you are showing Dutch in a youth division and enough is shown to warrant the \$5.00 fee they have to pay, they may decide to sanction with us at all future shows.

We are extremely sorry for any misunderstanding and inconvenience you may have had concerning the accumulation of youth sweepstake points. In order to lay the ground work and establish the youth program, and have it survive, (we have a 3 yr. trial period) we must follow the above decisions.

Possible Youth Programs

While at the NDS in Hutchinson, Kansas, tentative plans were made for the Youth Committee to meet around June 1st. to start planning some programs for the youth to become involved. The two other parties, beside myself, that were to be at this meeting live approximately 100 miles from my home. Have you ever tried to coordinate a meeting with people during the summer living this far apart? It was August 7th. before we could all get together to discuss the youth.

Several ideas were tossed around in trying to make the programs attractive to all of the youth in the country. We have not finalized any of these ideas, and opinions will be open to all youth. Several of the ideas are listed below:

#1 Achievements in Dutch - A booklet or notebook with questions for the youth to complete. Possible information; What have you done to promote Dutch in your community? To what other organizations do you belong? How did you learn and start raising the Dutch rabbit? What are your plans for continued education on the Dutch rabbit? Photos of your Dutch rabbits and some rabbit activities. Have you ever assisted in putting on a rabbit show? What problems have you encountered in raising Dutch? List shows that you have attended and your placements and winnings.

#2 Get Of Sire Class - We thought this might be an interesting project for the youth. Other species of animals have this and there is a learning experience in it. It will make the youth more aware of the type and quality of his or her sires used in their herds. The rules and regulations are fairly simple and easy to abide by. The Get of Sire would involve 4 rabbits. It would be the herd sire or buck and three of his direct offspring - preferably 2 does and 1 buck with one of the does being over 6 months of age.

#3 Judging Clinics - We felt this to be a very necessary endeavor. It would create more interest in the Dutch and also benefit all the Dutch breeders in years to come. The young people would be able to tell others what a Dutch should look like, and more important, maybe some would become good Dutch judges. The clinics could be held at the ARBA Conventions, National Dutch Shows, State Conventions or in any place where the Dutch are popular. Maybe Dutch judging teams could be formed and contests held throughout the country.

We are trying to put together something for the very young ADRC member, below 10 years old. This will take the cooperation of many people from all different parts of the nation. All of the programs that we hope to design to make raising Dutch more interesting, challenging and fun, will require everyones cooperation and alot of hard work!



I would like to apologize to all the youth members in District 9 because I neglected to notify anyone about my accepting the job as well as reporting any news in our area.

I am glad to accept the job as ADRC youth director of district 9. I have raised rabbits since my early childhood, but I never actually started breeding and raising Dutch until May, 1977. Dutch have been quite a challenge, and it is a great occasion when one of my little bunnies wins Best of Breed. I hope all of you have reached or about to reach the goal you are aiming for, such as winning a Best of Breed.

I hope the new youth program we are working with will help you achieve your goals, further your knowledge of the breed, and encourage you to continue working with rabbits. I am positive that the ADRC is taking this challenge more seriously and more thoroughly than any other club. The ADRC probably has the greatest support for the program, both from youth and adult members. I only wish that the youth members would show their support more often. In the last issue, Shannon Sanford of Ceres, California told us that her Black Dutch named Midnight won Best in Show at the Mid-Valley Youth Club Show. In the "Secretary's Message" column, Mrs. Hart informed us about the upswing in youth membership. This is the kind of information which is important not only as news but it shows someone cared enough to send something for the youth column, whether it is for the youth or the entire membership.

In Virginia, the Dutch business is slow. Many breeders are cutting back or getting out of Dutch. I have reduced my Dutch to two Black does. I don't want to get out of Dutch, but due to the shortage of space, I was forced to sell most of my stock to other breeders. I have been so busy with school and the State Fair of VA. (I worked as asst. secretary, doing all the pre-show work) that I simply could not continue breeding and culling stock. I recently bred three does and I hope by the time the litters are due I can spend each day carefully preparing my animals for show.

I would like to congratulate Ed Smith of Yorktown, VA. for winning BOB at the State Fair of Virginia. There were 62 Dutch by 8 exhibitors.

I would like to notify all youth breeders about the Richmond Rabbit Breeders Association Fall Show which will be held Dec. 4, 1982. If you would like a catalog send me a note. The Dutch specials look good, so try to be there. (I'm sorry Matthew, but the reporter isn't mailed until the first of December, so your show will be over when this is read. Do hope you had a large turnout of Dutch, both open and youth)

In closing, I would like to point out a resolution the American Rabbit Breeders Association is attempting to have passed. It states that anyone wishing to apply for a registrar's license must have passed their 17th. birthday. I am 15 and I was eligible to request an application in 4 months. When I read the article, I was pretty darn mad and I have sent a complaint to the ARBA concerning the unfairness and stupidity of the resolution. It not only effects me but others who are young and anxious to become registrars. They say "very young members, at a tender age, don't continue their work or fail to present themselves for the exam, thus taking undue time and effort that could be spent on a serious breeder."

Are they saying the youth are forgetful and are not concerned? That the youth are not serious breeders? If they are, why not just drop the youth program in the ARBA? I have seen several adult members quit during their attempt to get their registrar's license, I have seen many adult members fail to promptly register or complete the paperwork for registratio, and I have seen adult members give up their registrar's license completely. Either there is a failure in communication between breeders, registrars, and the ARBA or the entire system is at fault. The test should be open to all but verbal, written, and behind the table testing should be stricter. This new resolution will only hurt the youth program and discourage youth members who want to be registrars and judges.

All applicants for a registrar's license must have had at least 3 consecutive years of practical experience as a rabbit breeder and have been a member of the ARBA for 3 consecutive years immediately preceding application, and must be endorsed by the local association of which the applicant is a member. If there is no local club where the applicant resides, the applicant must, in such cases, have the endorsement of five members of the ARBA, in writing accompanying the application. Application for registrars license are made to the office of the Secretary of the ARBA. Forms will be sent to be completed by the applicant and returned with the proper fee. Applicant must assist or work under a licensed judge at three shows and shall secure the endorsement of at least two. Applicant shall assist the judge with at least one class in each breed when awards are placed. The Secretary will notify the applicant of the name of the judge who is to conduct the examination. To apply for a judges license you must be an ARBA member and have held a registrar's license for a period of at least two years immediately preceding application. You must have registered at least 35 rabbits and attach the application to a certificate from the officer in charge of an official ARBA Judge's Conference certifying to his attendance at, and participation in, such judge's conference, and be endorsed by the local association of which you are a member. If there is no local club where you reside, then you must have the endorsement of ten members of the ARBA. The applicant for a judges license has two years from the date shown on his/her application to assist in judging at least 8 shows under licensed judges, in addition to the shows worked in connection with qualifying for a registrar's license. You must secure the endorsement of at least 5 judges you have assisted. During the course of the 8 shows, applicant must have worked with at least 10 breeds. (Application for all brred license). Applicant shall assist the judge with at least one class in each breed when awards are placed. All applications for judges license must be made to the Sec'y. of the ARBA and be accompanied by the proper fee. You are notified as to who your examining judge will be

If we have to be 17 before you can apply for a registrars license and then another two years before you can apply for a judges license, - then work 8 shows, which could take quite some time, the youngest judge would be about 20. At this point, the new judge would be well out of the youth membership range and thus there would be no point for a judging contest. I certainly hope that you understand my point of view and write to the ARBA concerning this issue.

I hope you all do well during the fall show season. I wish you the best of luck and happiness during the Christmas season. May the good Dutch be yours.
