

#### SECRETARY NOTATION:

As per Section 2 of the By-Laws and the fact that the General Fund was experiencing difficulties, the monies alloted the Publicity Fund COULD BE transferred to that department or to ANY ADRC PURPOSE upon approval of a majority vote of the Board of Directors. Since there was no evidence that the Publicity Department is having any difficulties, no monies have been transferred to them. (Those funds that would be transferred are exactly one-half (½) the amount that your secretary earns for her percentage of each membership processed AFIER the \$1.00 contingency fund monies are taken out.) No percentage is received for life memberships processed!

The amount that could be transferred at this time from October 1992 through November 1993 is \$487.75

#### American Dutch Rabbit Club Minutes of the Board of Directors Meeting 1993 ARBA Convention/Tacoma, Washington

The regular meeting of the American Dutch Rabbit Club Board of Directors meeting was called to order by President Wenton Carlton. Those officers answering roll were; President Carlton; Secretary/Treasurer Hart; Directors Richard Gehr; Chuck Christ; Fran Schletter; and George Parmer. Those absent were; Vice-President Fred Mullinax and Directors Kevin Hooper; Jack Wireman; Jack Pugh and Dr. TE Reed. The Board was saddened to learn that District #2 Director Myrl Milhahn had passed away.

Director Parmer made a motion that the reading of the minutes from the last meeting be dispensed with as they were previously published. The motion was seconded by Director Fran Schettler. MC

The Treasurers' report was given by Secretary/Treasurer Norma Hart with a General Fund balance of \$ 3345.26 and the Money Market (Contingency Fund) balance of \$ 5232.81. The total funds available were \$ 8578.07. Director George Parmer gave the ADRC Publicity Funds report sent from the Butlers. After all income, and all expenses paid, the Publicity Fund balance was \$ 467.28.

REPORT OF OFFICERS:

Director Fran Schettler stated that there had been a definite increase in the amount of Dutch shown in California after the 1993 National Dutch Show. She said that there had been a double specialty show held in August that was record breaking and that there were many new youth showing interest. Director Schettler asked if the ADRC Standard Committee had missed the American Rabbit Breeders Association's deadline for material to be included. It was noted that this stated, as read, was actually incorrect. The ADRC Standard Committee received notice to start their recommendations for 'Dutch Standard' clarifications or changes. The 'actual' deadline to get our requests for this to the ARBA Standard Committee is June 30, 1994.

Director Chuck Christ noted that it is really only Wenton Carlton and himself showing Dutch with really no changes in his area.

Director Gehr and Secretary Hart noted that the Dutch are definitely not up in their area. Director Gehr stated that out east the Dutch seem to be plentiful. He said that he has noted both quantity and numbers at the shows that he has judged in that area. Director Gehr wished to go on record as saying that the 1993 NDS in California was one of the finest National Dutch Shows that he had ever attended. There were no problems encountered, the building was excellent and he stated that he was treated fantastic! It was just an excellent show!! Secretary Hart noted that the membership was increasing with 99 Husband/Wife (198), 246 youth and 336 adult memberships for a total of 780.

Director George Parmer stated that New Mexico and Colorado

are really beginning to go with a Farmington, New Mexico show having 75-80 Dutch entered. He said that there were a couple of new breeders now getting into showing.

Director Schettler also noted that she has received many calls out of Idaho and Wyoming for stock as they have been unable to acquire any quality in that area.

REPORT OF COMMITTEES:

Director Christ briefly went over the ADRC Standard Club ballot that is in the current DR for membership vote. If there are any questions on this issue or what the ballot consists of, one of the Standard Committee members will be happy to assist.

It was noted that the ADRC Secretary has approximately one (1) dozen guidebooks available. The Guidebook Committee has not received the ads or articles needed to send a new guidebook to the printers. It is a 'possibility only' that we will have to make some necessary changes and/or corrections in the present edition and have to printer run off only the amount of guidebooks needed to get us through until January 1995. The ADRC Publicity Department will be contacted to see if they have any extra issues available.

There was discussion on some new items with a Dutch emblem on them that were for sale in the Publicity Booth and whether or not they had been approved by the Butlers. The sale of these new items were to bring additional income for the ADRC Publicity Department. The maker wanted a set fee for each product while the Publicity Department could charge any additional on each item that they determined profitable. The Publicity Department was to take orders for the product only and collect the required fee set by the department. The Publicity Department would then give the orders and only those fees required to the maker. The maker would send the product to the buyer and all extra proceeds from the sale (determined by the department) was theirs. The Board present voted in favor of (4 to 2) selling them at this show. Director Parmer and Schettler voted no. President Carlton asked and received approval to appoint Kevin Hooper to contact the Butlers with regard to some changes in items and also for their opinions on some publicity concerns.

President Carlton also noted that he had received a call from someone about the possibility of a new breed combining the Dutch and the Rex. The Board present unanimously agreed that we want 'no' part in this matter and that should he wish to continue the issue, he would have to apply through the ARBA for a new breed standard.

Director Parmer stated that there were 259 Dutch entered in the open. After scratches, there were 248 with 47 exhibitors. There were 134 Dutch 'entered' in the youth.

Directors Parmer and Schettler are checking on the possibility of a Dutch breakfast for Wednesday morning about 8:00 AM. The membership will be notified via notice at the ADRC Publicity Booth when this is finalized.

Board Minutes continued......

President Carlton will check on the ADRC Seller's Class at the Convention and we will receive notice of that ASAP! Being no further business, Director Parmer made a motion to adjourn. This motion was seconded by Director Schettler. MC



## 70th ARABA CONVENTION, TACOMA, WA LOSING TO ONE OF THE BEST

Having just relocated to the Kansas City area this past April from Seattle, and also starting a new job with the #1 rated radio station in the Kansas City market (94 FM KFKF plays continuous country favorites) they would never forgive me if I didn't get that in., I found it impossible to attend this year's ARBA Convention in Tacoma, WA. It seems like every time there is a convention, almost in my backyard, I end up moving right before the convention. The Southern CA convention I moved to Seattle, Tacoma convention - on to Kansas City, and next year Tulsa - (oh no! I hope not again!) Anyway, my good friend and neighbor and an excellent Dutch breeder. Bob Bergene, was driving to the convention and offered to take my entry for me. (Actually I don't think he really wanted to, but I'm 25 lbs. heavier, 9 years younger, and am prone to fits of rage when I don't get my own way!). So, I was very happy when Bob offered, and Bob's lovely wife Charlene says that Bob should be as good as new when the cast is removed, which goes to show - you must be very careful when you twist somebody's arm.

After culling the size of the herd down once again for the move here to Kansas City, I'm just now starting to get it back to where it was. Last spring I noticed that my Dutch were starting to get a little on the large size, by that ! mean adults were pushing 5 lbs. consistently. They were nicely marked and typed, but "BIIIG". So once again ! turned for help to Bob Bergene, Bob has this little black buck named "EAR" (named because when he was born his mom wanted to help him be born a little too aggressively and nipped off the tip of one of his ears). EAR is built like a little tank, but just 2 1/2 lbs. At three years of age Bob still thinks he'll grow some (yeah, right). This rabbit has it all, massive head, cobby and marked excellent. So, I breed EAR to one of the best brood does I have, named SUE. SUE is a black doe who was one heck of a show doe, winning many Best of Breeds during her show career. In late April a litter is born, most were marked very good, but there was one that was a heart stopper. One of those I call a "1 in 300" bunny - about once in every 300 kits. There is that one that you know is destined for great things, well this kit kept getting nicer every day. He had it all... type, markings, "the whole ball of wax". (For you younger breeders that is an old guy phrase, which means the rabbit was "a major league happening, solid, too cool for words Dutch hopper dude"). I tried each day when I fed him not to get too excited but it

was tough. Then one day at eight weeks of age, I find him in his cage (you guessed it) dead! I didn't cry but the four letter words were in abundance. I immediately took the brood doe SUE back to Bob Bergene's house, Bob and his family were gone for the 4th of July holiday and I was taking care of his rabbits while they were gone. I bred her again to EAR (my wife Trudi said I did it because I'm a pervert and I just wanted to see a 2 1/2 lb. buck try and mate with a 5 lb. doe - it really is quite funny!) Anyway, Bob still doesn't know I did this, 'til now, and what's he going to do about it, unless he wants to be known as "lefty" Bergene? August 2nd another litter arrived, another nice little black buck is born with almost the "whole ball of wax" (youth breeders see above for description of "whole ball of wax"), except this little guy, SAM is his name, has a full neck. Other than the full neck this buck was going to be tough to beat, so on to Tacoma he goes along with some other fairly nice Dutch (the preceeding comments were personal comments and not based on any Dutch judging expertise). To make a long story short, and my goodness this has been a long story (sorry about that) SAM came in second in a class of 26 black ir. bucks, to a buck owned by Jill Dobson of Escondido, CA. According to Dr. Reed's comments, he lost only because of that full neck. The first place buck of Jill's went on to win Best of Breed and Best 4 Class rabbit in the Convention, which brings me to the title of this article "Losing to One of the Best" (it took me awhile to get here, but finally.....). Jill took not only Best of Breed, but also Best Opposite Sex with a black ir, doe. Jill traded these two rabbits away before the show even started to Ken Emerson for some Torts. That Ken has a good eye (and just what he needs, two more excellent rabbits for his herd!). Now that Jill has achieved some National attention the whole Dutch club will know what I and most everyone in the Southwest knows, that Jill Dobson is one of the best Dutch breeders in the country.

Jill, along with the late Jackie Duncan, have done more to promote the Dutch breed in Southern California than any two people I know. She started the Sun Valley Dutch Fanciers of San Diego several years ago. At the time a rabbit show might have had 15 to 20 Dutch shown, now local shows in the Los Angeles area will have 50 - 60 Dutch average and Sun Valley Dutch specialty shows have 100 or more per show on a regular basis.

Jill and her husband, Gene, have raised a herd of solid winners over the years. Jill is also the kind of person to sell top quality Dutch at very reasonable prices, especially

to Youth members. I can't tell you how many times I've been beaten by someone who bought a champion rabbit "dirt cheap" from Jill, Jill and I have shared and traded rabbits for a long time. The knowledge of the breed she has is second to none. In this day of trying to get the most for your money from a responsible breeder who cares about your future in the hobby, I think you could do no better than to talk with Jill.

Jill called me from the ARBA Convention in Tacoma to give me the news (in fact she called me before she called her husband - eat your heart out Gene). She told me when her black jr. buck was named Best 4 Class in the Convention she "thought she was going to have a heart attack" (if it had been me I would have needed rubber underwear). She was thrilled. I couldn't be more happy for her. No one deserves it more than Jill Dobson.

So, I don't feel so bad if "I Lose to One of the Best".

ED: Thanks for the article Rick. Any of us that have been around for awhile know that Jill is indeed a very good supporter and promoter of our breed. I was thrilled for her when I heard she won Best 4 Class. A feat not too many Dutch breeders can say they have accomplished. We are proud of Jill.

To make a comment on a portion of your letter, if you ever get tired of those "BIG" 5 lb. Dutch, send some my way. As a judge, I would have to say the Dutch are becoming too small in the past few years. The "toys" show well, but aren't very good at production. At least that is my experience. Also, the ones that don't quite make the 2 1/2 lb. limit, end up beating juniors until they are ready to retire! Sad, but true. Give me a 4 1/2 to 5 lb. Dutch at maturity anyday.



#### LOWELL SIMONSON

It is very hard for me to report on the passing of one of our Dutch family, especially when it is someone I considered one of my best friends.

We received a call the other night from Eric Mixdorf, informing us that Lowell had passed away.

For anyone associated with Dutch over the past 5 years or more, and attending a National Dutch Show or ARBA Convention, you probably had the good fortune of meeting Lowell. He was a man of few words, rather quite, but his presence was noticed by all that knew him. Leaning on the judging table, smiling, and thinking... who knows what?

In all the shows I judged at which Lowell was exhibiting, I always appreciated the fact that he would never complain about a placement. He might say that he saw a class different, but he would honor the judge's decision and accept it. That is one way that he and his old traveling buddy, Dale Zentner, were so much alike. As a judge, you had to appreciate these two gentlemen. Their accomplishments in raising Dutch speak for themselves, and you had to admire the fact that they probably knew more than most of us, but never acted like it or made remarks that would lead one to think that.

Lowell was a successful breeder, a good person to help others out when they needed a little something in their breeding program, he helped get new breeders started, and thought nothing of traveling any distance to attend a big show and visit with rabbit friends.

I called Scott Williamson to inform him of Lowell's passing, and we got to talking about some of the old times. We commented that the ADRC has lost several very good members in the past year or two. I said to Scott, "Can you imagine the show they are having up there? What competition." Lowell, Dale Zentner, Johnny Nelson, Myrl Milhahn, Del Cockey, along with some others that I can't recall at the moment. Scott's reply was, "Yeah, and Tom Shufflebotham is probably threatening to kick all their butts!" Anyone knowing Tom can appreciate that.

Alas, we have lost another good man, but the concession is that he is with many other good Dutch people that have passed that way also. Just like remembering special rabbits, shows, and wins, we shall also remember these special members of our Dutch family. Unfortunately, I could not find a picture of Lowell to include in this issue. Perhaps we will have one for next time.



The color was detectable on the bottom of the paw. It was my understanding from Carrol Hooks, who judged her a month previous, that a judge was not allowed to spread the toes apart in order to see if the color bled down into the She said you are allowed to look at the top and space. bottom only. I would like to ask you which one is right? Which one is wrong? If it is not written anywhere in the standard how can one judge take it upon himself or herself to preach it as law. We need the judges to at least be consistent. It certainly does not look well for the seller of the rabbit and it certainly upset a whole family whose hearts were set on winning or placing high with this Is there some way we can eliminate this among our rabbit. judges?
