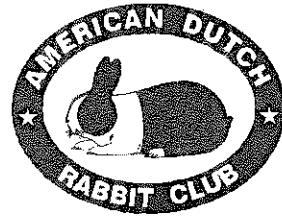

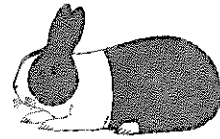

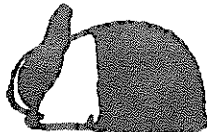

This issue is hopefully back on schedule. There have been several things that have put the DR behind, and hopefully those are behind us now. I know this is your only way of knowing what is going on in the club and when the DR does not show up on a regular schedule, you not only can lose touch, but lose interest as well.

This issue contains the election results from this year. As there were no contested offices for the Board, the results consist of the judges for the next couple of

National Dutch shows. I have also made sure to have the judges for the future ARBA conventions listed in this issue. We will be adding more judges to this list as it is deemed necessary, based on the approximate number of Dutch that will be shown.

I will be appointing new committees in the next few weeks. The committees to be appointed are the ARBA Judges Selection Committee, Election Committee, Dutch Reported Committee, and publicity committee. This makes it hard to get the experience on the Board, while knowing you have someone who will be around for a while.

The National Dutch show for 2002 will be hosted by the Hoosier Dutch club and be held in Indianapolis. Val Slack and Kay Stearns will be heading up this show. Now is the time to be making plans to attend. They could also use your support for the show. The NDS is an event that takes money to carry out. If you would like to make a donation, please send it in soon, as that will help them plan for the show. Many hands make light work, and the same goes for many donors.

If there is an idea or issue that you would like to have addressed, please contact one of the Board members or myself. We want input from the membership, but more often than not, we hear nothing.

Speaking of... If anyone has ever thought of going to a Dutch Nationals before, please consider attending this particular one. The last DR had a preview of what is to be expected. The location sounds fabulous and the events planned will keep us busy and well fed. What will be especially interesting is to see a show with Mr's. Worden, Goeglein, Miller, Shaw and Shull filling the superintendent shoes. It is worth going for this alone. I would be very interested in hearing from any members in my district (or any districts for that matter) that have tips we can share with other members. What have you done to make a move to a new home go more smoothly? Do you like your automatic watering system if you have one? Do you like a particular grooming aid, brushes, nail clippers, etc? Finally, I have recently moved to the Madison area and want to give you my new address and phone number should you need to call me. It is:

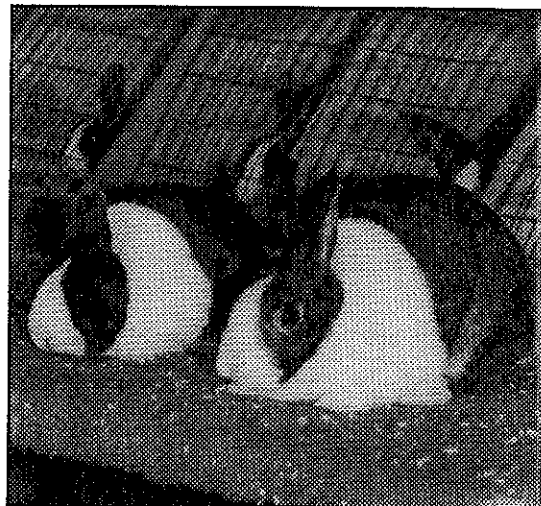

M AINTAINING THE PRODUCTIVITY OF YOUR HERD

Raising Dutch rabbits is not hard. Raising good ones is a bit harder. What do you do when you have trouble raising, not good ones, but anything at all?

This is what I have gone through the last two years. I have written a couple of articles on this already. This is more of a what to do to keep out of that trouble.

I did not say that I couldn't raise any Dutch or any good ones. I could and I did, but it took a lot more effort than it normally would. I had does in many colors that were not good mothers, or that died while kindling. This occurred due to various reasons; Inbreeding, randomly keeping does that had poor maternal instincts (bad luck), etc.

The major problem goes back to the fact that I kept does that were out of does who were not the best mothers. In many instances, these litters or young, would not have survived if it weren't for the fact that I don't lose many bunnies to the Elements, because of my nursery setup. A good doe will raise her litter in even the

coldest weather. I move my bred does to a nursery that never gets below 35 degrees, and there is no wind. Therefore the does not have to produce as much milk, nor pull as much fur, to keep the litter going. I can also check them easily, and add fur or foster bunnies as needed. This aids in raising the litters, but it can fool you into keeping does like I did, who were out of marginal mothers.

The problem can be avoided by strictly culling out those does that do not do the best job. I know that many, including myself, normally expect the does to loose or do poorly on their first litter. I have changed my philosophy on that. A good doe, providing she is not bred too early, should raise her first litter as well as her second, third and so on. Now, if a doe does do well on her first litter, I will cull her out. I have done this for the past year. These were a lot of tough decisions, as these were some very nice does. But, it has achieved the desired result. The does are providing much more milk to their litters, building better nests, and raising more vigorous bunnies.

You will still occasionally run into a problem. I kept several black does, and a tort or two, who were out of a very

good black doe. She was a very good mother and I decided to base my black herd on her. All of her offspring had breeding problems. It never did make any sense, as she was not inbred. That is why I did not have much in blacks the last two years.

The other practice that you need to watch is the inbreeding/line breeding. I don't do a lot of color mixing (except for my steels). Therefore, you need to keep a few bucks to use on your does. As you get litters out of buck A, those offspring can be bred back to buck C, whose offspring can be bred to buck B, etc. This, if done properly can keep a wide genetic base, and help you to avoid the inbreeding problem.

The moral of this story is cull, cull, cull.....for everything. You really can't be too strict in your culling practices. You may occasionally cull one too soon, and it will come back to bite you on the show table, but it will pay off in the long run.

ARE YOU A DUTCH AMBASSADOR?

Mr. Webster gives us four (4) interpretations of the word *Ambassador*:

- (1) A diplomatic official of the highest rank appointed and accredited as representative in residence by one government to another, usually for a specific length of time;
- (2) A diplomatic official heading his or her country's permanent mission to certain international organizations, such as the United Nations;
- (3) An authorized messenger or representative;
- (4) An unofficial representative i.e. ambassador of good will.

Numbers (1) and (2) probably have little relation to the America Dutch Rabbit Club. While we are a great bunch of folks, we would not qualify as our own "county". Number (3) should however, apply to the officers and directors of this club, while Number (4) should apply to us all.

The officers and directors of this club are charged with the responsibility of being an authorized voice of the American Dutch Rabbit Club. The authorized "voice" part means listening as well as talking. I have given some thought to this and listed some qualities that might make us all good ambassadors.

- (A) A good ambassador can be identified as such. Club officers and directors have duty to make themselves known as officials with the

club. Club members and potential and future club members should know who we are and that we are there to spread the "Dutch message".

- (B) A good ambassador is approachable, interested and willing to help out. We are all too busy. If you take on official responsibility however, you must be willing to sacrifice for the good of the club. You must be approachable by club members and anyone else interested in Dutch rabbits and want to know more about them. We should take all such contacts seriously and view all such inquirers as potential members. There is a hard and fast rule that goes with this inquiry

business: ALL SUCH PEOPLE WILL APPROACH YOU WHILE YOU ARE THE BUSIEST TRYING TO GET YOUR RABBITS UP ON THE JUDGING TABLE!!! It will not matter if you have sat around all day waiting for the Dutch judging to start, they will not approach until you are trying to get them on the table or listening to the judge's remarks. While it is tempting to not take the time to talk to these folks it is our duty to do so in an encouraging manner.

(C) A good ambassador takes along a few sale rabbits to most shows or has some reasonably available for current or new members to acquire. Here in the South we are constantly trying to get the number of entries up. How can we do this if new breeders cannot get stock? I know breeders who never sell any rabbits to new breeders. That is a personal choice for breeders but it cannot be a choice for a club official. The club official either needs to have stock to offer or arrange and connect the new breeder with someone who does. When I began with Dutch some 3 years ago, I found it almost impossible to find brood stock to start with. I traveled to Michigan, Kansas, and Florida to get my start-up rabbits. I was determined. Potential breeders who are not as "hard-headed" as me might

just have given up and raised lops or something.

(D) A good ambassador goes out of his or her way to get good rabbits into the hands of youth exhibitor's especially new breeders and exhibitors. The number of youth who "stay in rabbits" into adulthood is probably quite small. There are many, many competing interests out there for our youth. The only way to improve the numbers of adult members is to increase the number of youth members. I once sold a rabbit to a 6 yr. Old girl who took the doe and was best of breed the following week in a large show with Tex Thomas judging. I wish I could tell you that getting that rabbit to the new breeders was a benevolent act. Actually it was pure ignorance on my part, but the outcome was good. She is still showing Dutch rabbits. That rabbits still beats me. (It will probably live forever).

(E) A good ambassador listens. To make our club stronger we must solicit criticism and suggestions. When the membership has concerns we must listen and act upon those concerns. There is a great deal of apathy in our club. Positions for directorships and officers come up with very little or no interest. When no one wants

to run for a position it causes our President to have to appoint nuts like me to directorships. Now that should be a concern for everyone!

(F) A good ambassador educates. Judges, exhibitors, and newcomers all need educating from time to time. At the PROPER AND APPROPRIATE TIME there is nothing wrong with telling a judge that dewlaps on Dutch are not a disqualification or that s-t-r-e-a-c-h-i-n-g a Dutch out to view the undercut is not a proper procedure. We must also answer the "why do they call them grays again" and "why does the club want the grays judged last in the order" questions.

The list could go on but I am sure you get the idea. While officers and directors may have the responsibility to act as ambassadors, every member has the duty to be "good will" ambassadors to the same degree. Being a good will ambassador is good training. You ever know, Kevin might appoint you to something.

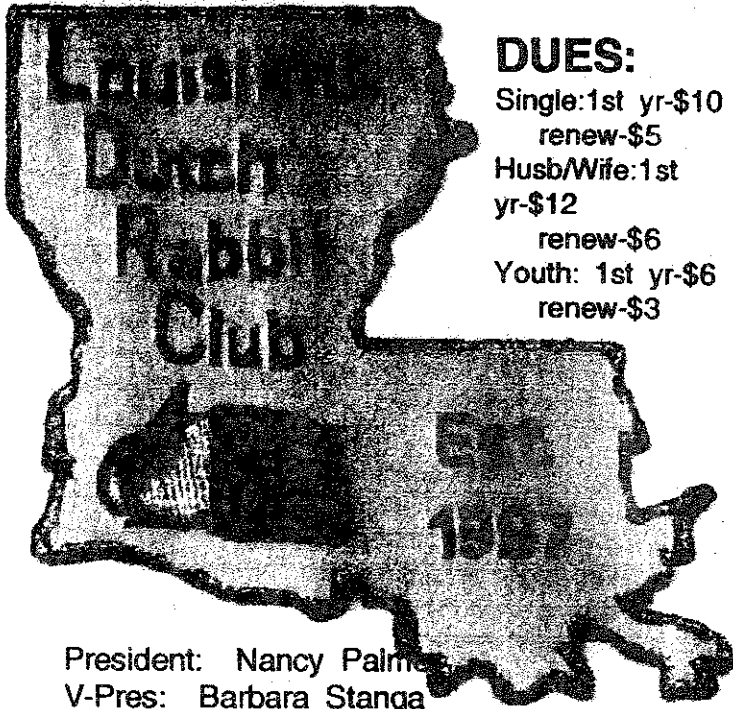

As usual, the Blacks and Blues were the most challenging. As most of you know the BOB & BOS came from these varieties. There weren't enough Chocolates and Steels to get really competitive but the Grays were the most disappointing. If you were one of the exhibitors that happened to be present, I'm sure you detected a huge let down when I got to the Senior bucks in this variety, they "all" looked like Coke bottles with very nice markings, Believe it or not I judged the class on surface and under color, they were that close. the BOV & BOSV came from the junior class' since they were the most compact and had the best "type". (hopefully they were compact because the breeders are working on type and they just didn't have time to start to stretch out.)

The last thing I would like to comment on is the Dutch Breeders themselves, AS USUAL the help was fantastic and went as smooth as any large show can go. My hat is off to "ALL" who helped get the 300+ across the table in 1 day. could not have done it without you, Again "thank you" for the opportunity to judge your Dutch, Had a great time and experience, look forward to doing them again sometime.

Thanks for giving me the opportunity to comment on the quality of the dutch at convention in the youth.

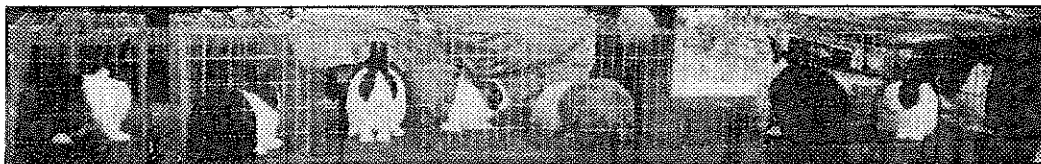
It was an extreme pleasure to be able to judge the dutch youth at the 2001 convention in SanDiego. There were some extremely nice animals displayed there.

The exhibitors were well mannered, presented themselves well at the table, carried all the rabbits up to the table, and kept the show running smoothly. I can't remember only a few minor hitches in the classes being judged. It was a delight to have all the animals on the table ahead of me, and not having to stop to wait for them to come up.

One of the things that impressed me was the attitude of the exhibitors. They were well dressed, well mannered, and good sports persons. This shows me that you as adults are teaching excellent values to your children. It is so humbling to work with youth of this caliber. My hat is off to the youth, and to those behind them teaching them about our wonderful hobby. They are the future of our industry, and of our hobby, you can be so proud of them!

Some of the things that they could improve on are perhaps some body type in the blue's. The black's were excellent. The chocolate's were outstanding. The tort's need to improve on their shading markings. Several had to be disqualified not because of type, but because of dark black shading markings. They need to be blue smoke, not black. I demonstrated this to them by putting them up against a black, and then against a blue. The gray's were nice, and the steel's had good color. Overall the quality was good. Their coat quality varied according to where they were from. It is so hard to get them into good coats in the warm weather. Profoundly an excellent presentation by your youth exhibitors.

6. Photography: Rabbit related. Single or series, see catalog for details.

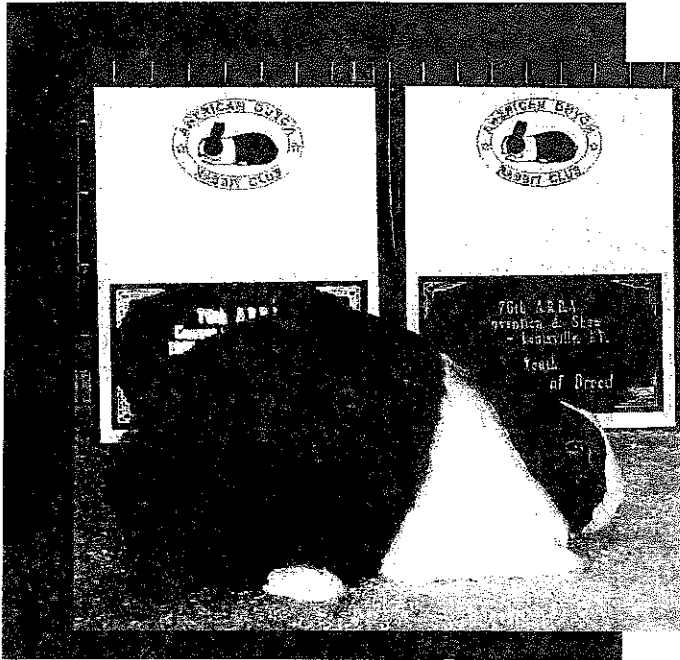
