The meeting of the Board of Directors of the American Dutch Rabbit Club was called to order at 8:20 P.M. by President Don Reid with the following officers and directors present, Sec'y-Treas. Jessie Weinhardt, Directors, Don Lovejoy and Doris Leibel and Vice-Pres. Mike Stinehelfer

There was a motion by Doris Leibel, seconded by Mike Stinehelfer that the reading of the minutes of the previous meeting, which had been published in the Dutch Reporter be dispensed with, carried.

Under report of officers, Mrs. Weinhardt reported that the publication of the new Guide Book had been delayed by a strike at the publishers; but the president of the company had assured her that as soon as all was settled the book could be produced in about six weeks time. Since the original bid was for two thousand copies and it had been decided that this was insufficient, a bid for an additional one thousand had been secured and the price for this total of 2,000 copies would not exceed \$1,320.00. The money in the treasury earmarked for the Guide Book totals \$1,018.50

A report regarding the policy for nomination of Judges for the ARBA Convention and American Dutch Rabbit Club was read into the minutes as follows:

This is a report on the findings of David Paul and myself whom you appointed at at the April, 1969 National Dutch Show meeting, to analyze and evaluate the proposed changes in the manner in which our judges are picked for the afore-mentioned show. It is the opinion of myself, as Chairman of the two-man committee, along with the opinion of David Paul, that no changes be made in respect to picking our Judges. This analysis came about after Mr. Paul and myself spoke to several Dutch breeders in regard to this subject in our respective areas. It is the vast majority who felt that the judges should be selected from whatever part of the country they may represent, rather than from a small four or five state area, which is very possibly the only states represented at National Dutch Shows in particular, and even some Conventions.

It was also brought up, while discussing this matter with several Dutch breeders that although there are many people who are unable to attend these conventions and shows each year, that by having their vote to cast they feel that they are having a small say-so in how these shows are judged. As a closing remark, in regard to this report, we feel that the broader the representation of the membership is in being able to select their officers and judges, the more content and less suspicious the membership body will be.

Considerable discussion was held on ways and means of making the Dutch Reporter more acceptable to the membership. There was a motion by Mrs. Weinhardt, seconded by Mike Stinchelfer that Doris be instructed to have front covers printed, but look into possibility of a commercial stencil for the title page. Since the balance on hand would seem sufficient to carry the Reporter for the next six months this motion provided that should an emergency occur, the Treasurer be authorized to advance the Duth Reporter not over \$200.00 for a three month period, carried.

Furthur discussion on possibilities for improvement were held and although it was felt that the present abbreviated forms of show reports were not being well received cost and labor still made any expansion prohibitive. A suggestion was made to raise the dues \$1.00 to provide extra funds, but this was deemed unsatisfactory. Doris told of a suggestion of a Mr. Geitzenhauer of N.J, that the show reports be coded in some manner.

A furthur suggestion that our show rules, page 18, Rule 3 be changed to read, " A fee of \$1.00 must accompany the \$5.00 application (for sanction) fee for which your show will be listed in the Dutch Reporter. This additional \$1.00 to be used as Editor's Fee to compensate the Editor for the additional work of publishing a morecomplete show report. It was moved by Don Lovejoy, seconded by Mike Stinchelfer that this proposal be brought before the general meeting with the intention of holding a special Board meeting following this general meeting to take whatever action is indicated.

There was a discussion about the recent ballot with reports of unhappiness among the membership with regard to the proposed changes in our standard appearing on this ballot without opportunity having been afforded to allow discussion. The meeting was adjourned on a motion by Doris Leibel, seconded by Don Lovejoy.....

Minutes, Regular Meeting

The regular meeting of the American Dutch Rabbit Club was called to order by President, Don Reid at 8:35 a.m. Officers present were, Pres. Reid, Vice-President Stinchelfer, Sec'y-Treas. Weinhardt, Directors, Lovejoy and Leibel.

There was a motion by Doris Leibel, seconded by Walter Cook that the minutes of the previous meeting be dispensed with since they had been published.

Under reports of officers the Secretary-Treasurer passed out copies of an audited financial statement for the past six months.

The minutes of the previous evening's meeting of the Board of Directors were read and approved on a motion by Anna Cook, seconded by Robert Sprague.

There was discussion of the necessity of planning some remuneration for the Editor of the Dutch Reporter and the members were informed that any changes in show rules were under the jurisdiction of the Board so that the plan, as brought out in the Board meeting could be handled by the Board. It was explained that, altho the Board was aware of this authority they did not wish to take such a step without the approval of the membership. There was a motion by Elmer Hand, seconded by Robert Sprague that the membership present voice approval of the Board's proposed change in the show rules to permit payment of the Editor of the Dutch Reporter, carried.

There was a motion by Marvin Cummings, seconded by Walter Cook, that the Treasurer be authorized to transfer funds from the General Fund to the Guide Book Fund to cover the anticipated deficit, carried.

Marvin Cummings asked for the floor to present a message from James Collins of Florida voicing disapproval of the form of the publication of show reports and also the apathy of the membership in voting. It was again explained that the primary reason for the simplification of the show reports was the cost of publication plus the enormous amount of work involved. It was hoped that this would be partially solved by arranging some remuneration for the Editor. It was felt that voting apathy was no different in our organization than in others.

Doris Leibel gave an invitation to all to attend the 1970 National Dutch Show to be held in Mason City, Iowa next April. She named the officials of the show and told us some what of the accommodations available for us and our Dutch.

Doris also gave a report of this show. A motion by Elmer Hand and seconded by Bill Montgomery instructing the Secretary to write a letter of thanks to the officials of this Convention, thanking them for the fine cooperation. Carried.

Elmer Paquette asked for the floor to announce that California is bidding for the 1971 Convention and expressing the hope that everyone would please come to Calif. Doris Leibel thanked the Hands and all others who assisted with the judging. The meeting was adjourned at 9:10 on a motion by Ivan Miller, seconded by Bill Montgomery, carried.

I write this to let all know what fun an ARBA Convention can be. It is worth scheduling your vacations for, especially when a trip as we had to Calgary is in the offing.
