

At the Directors' meeting in Maryland it was decided to put out a booklet with descriptions and pictures taken from the Dutch Standard. Bill Geitzenauer had the booklet printed and I am putting them out.

First, the booklet has all the pictures or drawings from our Dutch Standard. (one picture is worth a thousand words). It shows, in case you haven't looked at your Standard, all the correct markings, plus the incorrect ones. It gives a good comparison of what a Dutch Rabbit should look like as well as what one looks like that is not so good.

We think this is a great improvement over the verbal description given in the A.R.B.A. Standard and will greatly improve some of our judges' applications to his judging as taken from the ARBA Standard.

I was instructed by the Board of Directors to distribute these booklets to all the new judges listed in Domestic Rabbits. I have also hand delivered some to judges with quite a bit of judging behind them and the comments were quite complimentary.

Have Heart - The Best Is Yet To Come

In the past few weeks the question has been asked on how to add a different bloodline to your own without distroying the good characteristics of your own. It seems that every request for stock either asks for a buck or a trio. Really can't understand where this fallacy comes from. Obviously a trio would eliminate their own bloodline or a buck would eliminate 50% of it, and change you so fast, you may The reason I think most people want to add a different lose control. line into theirs is to bring in a dominant gene that their stock has been proven to be recessive. A well bred line, generations old, that has proven to consistently litter young with half stops and high right cheek for example is an inbred bad dominant gene. Now most old time breeders will tell you that it can be bred out but they forgot to tell you that it may take 2-5 years to do it. The next question must be how can I do it in less time without sacrificing the good genes that have been inbred in the line? The way this writer has added dominant genes to a strain that has a weakness is to: 1st. Purchase 3 does that have the dominant genes that you need from a breeder who consistently shows it is a dominant gene on the show table. This means shows throughtout his/her herd this characteristic not just a couple of animals. 2nd - Breed each doe to your own herd buck saving any doe out of this, that has the dominant gene or genes that you need. Make sure these does have exactly perfect points that you are looking for even if they are mis-marked at some place they weren't in your own line. 3rd - Breed these 2nd line does back to the herd buck or the original line. The young from this will be 2/3 your own bloodline & have 1/3 good gene characteristic that you are looking to introduce. Selection after this is up to you --- carry at least a couple of animals with strong points to make up picture Dutch. Example: One Animal with excellent everything but maybe mis-marked at the saddle and low cheeks into the mouth. Keep another with excellent saddle and cheeks but mis-marked stops. The total good points should add up to or as close as possible to 100 points. In this situation do not purchase any other stock - - - you have the dominant genes to make a perfect Dutch. 4th - Sell the original 3 does to some one else so they may help another breeder.

Too many breeders when starting buy too many different bloodlines that they spend 3 years trying to figure out what is the dominant gene in the lines and get frustrated - - can't blame them. If you are starting buy from one breeder who has proven dominant genes although there may be a dominant weakness also present. At this point proceed to step #1. No. matter how you figure it unless you want to buy winners. The preceeding will work for you but it will take about 1 to 12 years and should give you good firm stock for 4 or 5 years. Yes, after 4-5 years the line becomes "tight" and will have surfacing weak genes to dominance where there were none before. Don't think anyone including a genethesis's can explain this process but when your litters start dropping from 8 average to 6 then 5 or less, it's time to act again & an out cross is in order. This is shown in an ARBA book article by a series of circles and lines but like a man said to me. "I'd have to be a college professor to figure it out." Hope this helps you straighten your thinking out. (CONTINUED)

How can you proceed without a plan? Indiscriminate breeding produces a mess that will take years to straighten out. Yes, it may produce one once in awhile but who wants a Cherry when they can have a Cherry Pie? Remove those frustrations - Remember have heart, the best is yet to come!

"Like A Good Wine"

Upon reading the June Dutch Reporter I was impressed with an article that is not only the essence of the Chocolate Dutch but is perhaps also of the Dutch breed itself. The article is by one of the finest Dutch Fanciers the Dutch Club ever had the pleasure of serving. Even though the article is 41 years old there is much food for thought. He quotes, Mr. Mitchell of England, in that heavy cheeks in does can be corrected by mating bucks with correct cheeks, not high cheeks. There are many breeders who have been taught to breed extremities so that in some way the genes will automatically add together and divide equally by two. It has been my personal experience that genes do not do this but rather genes or chromosomes, if you want to get hairy enough, are brought to surface by correct genes brought to light. An example of this is a breeding of high cheeks to low cheeks will produce both high and low but dependent on the gene pool MAY produce a small percentage of correct cheeks if a grandparent or great grandparent had correct cheeks. Conversely a high or low cheeked animal bred to an animal with correct cheeks, particularly if the parent or parents of this animal also had good cheeks, will produce up to 50% good cheeks in the litter. I know this will not set easily with some of my best friend breeders who have bred opposite for years. I ask you breeders who have done this to just think of the proportion you have raised when using the opposites method.

Another well thought out idea by Mr. Mitchell, "is that the young in a litter are prone to have the characteristics of the best conditioned parent." A top notch buck that has been used excessively will have little chance to throw his characteristics to the young which will then have the characteristics of the doe. This has been proven over and again that a purchased top grade buck will not throw his characteristics to the litter. (He probably is bred upon receipt 3 x a day for a few weeks) The purchaser feels cheated but has not really given the buck a chance. Personally the bucks used by this writer are used an average of 5 x per week unless they're molting then they aren't used at all, the bucks over 2 years are used less.

Over the years the standard on Chocolate color must have changed. At the time the color was "a rich dark reddish shade Chocolate and not the dark brown shade." Our standard now calls for a "dark uniform Chocolate brown, very glossy." It would be educational to all if one of our older breeders could produce a standard from the late 30's or early 40's to show the progress or change over the years. There is a lot to learn from this Article by Chas. Lewis, 1935 vintage and all Dutch Fanciers should look in their June Issue of the DR for helpful hints particularly on Chocolate Dutch.

Our Research Department - Georgia

After Digesting Georgia Wireman's article in the June DR, I had time to dig for myself. Georgia found out something very significant. In the A.R.B.A. Standard of Perfection there is nothing said of judging Dutch in their natural position. Although there are pictures of proper posing of a N.Z. White, "with toes just even with haunch, (thigh joint)", on page 14 this is surely not Dutch posing. A Dutch posed with the rear toes even with the thigh joint would surely warant the wrath of many Dutch exhibitors. Perhpas this is where some judges get the idea of the correct posing - guess we can't really blame them anymore. They are working to the Standard they are instructed to work with.

Our own guide has a glaring error in it. Page 58, rewards 15 points on type and nothing on weight and condition! We at one time used to have a Standards committee, but do not know if it is still so. Our guide book has provisions for one and this apparent error found by Georgia should be within the realms of this committee to notify the membership what is the point makeup.

While on the subject there has been much said but little done on the point spread of our marked Dutch. Every instructive article on what is desired has type the most important attribute on our rabbit worth 15 points or 20 if you include the head. But really this is type, weight and condition by A.R.B.A. Standards 1976. This infers that about 7 points are on type 20/3. A most prominent feature? And yet fur=10, Color=13, Cheeks=12, Saddle=10 and Stops=10. It makes this writer wonder what are people to breed for in the next 20 years? Surely with 7 points on type they will not save the good typed litter but the well marked poor type dutch.

After reading Ed Chandler's article on almost disqualified it brought back visions in my mind's eye. Some judges do think out loud and probably shouldn't due to the fact that each person interprets a statement differently. It is quite possible that the judge, who can give the animal anywhere from Zero to the maximum alloted, actually rated the buck zero. The sad part about this is that it is their perogative to do this! And perhaps worse yet is that the animal can be disqualified in one show and do well in the next. As you well know our standard is written to be exacting enough but yet flexible to aid the judge in his decision. All points being equal the benefit of a doubt must go to the animal. Most judges, unless they are overloaded as they are at some shows, will give the animal the benefit. Oh, there are many shows that I disagree with the judge's decision but they are human and really what does it prove to spend \$5.00 and get it back. An enemy for life, a lot of trouble and your fellow exhibitors a little skeptical of you. The judge has a mark on his record that was perhaps one wrong decision out of hundreds or thousands. If this writer only had one wrong decision out of this many well I guess it would make a difference in my life.

Yes some judges, do not know the points distribution, (CONTINUED)

on all recognized breeds. All judges do not open their book of Standards to check before judging a breed. Most arriving at a show have little idea of what they are to be judging so cannot "bone up" on the point spread.

We exhibitors can write a book on the discriminations that we think has taken place. An instance that I can remember was last year while helping a judge with a class of blue bucks. While looking at the last two in the class he remarked quietly almost under his breath, "both these animals are exactly alike but the undercut is a little better on this one even though the saddle is better on this one." You guessed it he picked the best one with the better undercut. As we all know the undercut carries less points than the saddle. Asking the judge why he picked the one over the other he replied, "The undercut has more points than the saddle." I nodded and he proceeded to start the next class. By the way on that particular day the man worked 7 hours, no lunch break, did 6 breeds of rabbits of which two were fancy and a total of 280 rabbits. Why did he not get a lunch break and had so many to do in just 7 hours? Ask the exhibitors who arrive at a show at 10 a.m. and expect to leave at 12! Worse yet they want to pull their stock out if a certain judge does not judge their breed! Well Ed, there are a lot of us that feel like you do and were right but there are sometimes extenuating circumstances and irregardless of what happens on a certain day at a certain show, you know what the rabbit is and next week he will still make you proud of being the breeder who bred him! Hope you continue showing him, so that we can all get a look at him.

How else is a judge going to know what they are doing wrong if not by the exhibitor opening their mouths and telling them, NICELY. (Example: That Judge you were working with, still probably thinks there are more points for an undercut than a Saddle) If you can't get a judge to listen because they know all the answers about every breed - then PROTEST - Someone has got to show him the errors of his ways or else he won't get many shows to judge. I have seen our Judges here in Illinois, read their Standards of a breed that they are not familiar with but have to judge and then when the breed is all done ask the Exhibitors what they did wrong. They listen and learn and to me that makes them one heck of a better judge and man. They at least know they don't know it all, so they go to the source of information that can help them the most the EXHIBITOR who has raised a particular breed for years. Kathy

BLACK DUTCH RABBITS

Black is the most popular variety in Dutch rabbits. Generally, there are nearly as many Blacks entered in the showroom as all other colors combined. Therefore there must be a good reason for this popularity. A sharp contrast in colors usually brings out the beauty. And there is no sharper contrast than black and white as they are the extreme opposites. Black is a beautiful color when we get near the the perfect black color desired.

Many believe that black is an easy color to attain. However, it is quite the opposite. It is a very hard color to master. There are many defects that crop up in this color. One of the worst is white hairs in the color, another is a cast or brownish stain, still another is that bluish tinge. A good black color is made up in these specifications: A very deep, luscious black, free from any tinge or white hairs. There should be life to the color and it should glisten with sheen. You can readily understand why this color is so popular and beautiful by the above description. When we say sheen, this means beautiful brightness, splendor, brillance and luster. All these terms together mean, when applied to black color, that we have what is desired. How could anything more beautiful be described than by the above words?

Many say the judges pay too much attention to color, yet color brings out the contrast and effects and sets off the markings, not just one marking but all of them. Therefore, color is a very important factor and must be carefully considered by both the judge and the breeder.

You who have seen a well-polished stove-pipe hat will have a good idea of the color desired. The old silk hat has seen it's day, as we seldom see them today, but in the minds of the old-time Dutch breeders they are the shining example of the color called for in our Black Dutch rabbits.

Let us again remind both judges and breeders that Black Dutch are about the hardest color to breed to perfection, because of the contrast in the colors of black and white. Not only the fine, sharp markings are brought out and the beauty of the rabbit, but also the defects stand out much more than in the other colors, because of the contrast in the color. Various other colors may have the same defects as a black, yet they will not show up nearly so much because of the weaker In the black we have a solid color and a solid color to me is much more difficult to master than that of shaded or agouti color. This we believe holds true with the weaker colors. The reason is that various colors can blend and it takes an expert to tell if the top color is right, if the blend is right and if the shading is right, or if the shading hits the proper places of the rabbit. Agouti blend generally on the sides, but black must be black and just that. No excuse is offered for the black if all marked parts are not a uniform black. Black color is definitely described and that is our aim: the description in the forepart of this article. One serious fault in Blacks is the grizzling of white keir in the ears. This fault is just about as common in other varieties but does not show up as much, as explained before, due to the color contrast. (CONTINUED)

BLACK DUTCH CONTINUED

The color on the ears of a Black should glisten with color, and when this color and condition are attained, the ears of a Black Dutch are beautiful.

In breeding Black Dutch rabbits, careful consideration should be given to the color, because it in reality is part of the markings and does much to make them effective. Every breeder has his or her own ideas as to working for color and we do not wish to attempt to force our ideas on others unless they are given careful consideration. There are some who use any Dutch to breed from, just so it is Dutch-marked, and pay little or no attention to either type or color. If we are to produce better-colored Black Dutch we must work to that end and not be led off entirely by markings. Master color, then when you get a well-marked one with the good color, you have a flyer that can go out and win. When a well-marked one is produced and shown that does not have color, there is a big chance of its being beaten in the showroom by a specimen that is not so well marked but has a better color which affects the markings and beauty of the rabbit. Such being the case, let us strive for that good black color.

Different breeders take different courses to get the proper black color. Some cross black with blue and swear that this is the only true course to successful color breeding. However, my experience has been the opposite, and another outstanding breeder and myself made experiments along this line years ago. Our definite conclusion was that there is only one true course to follow and that is selective breeding and mating closely related specimens. Color breeding in rabbits we do not believe works out like mixing paints. Nature does not make the reproductive organs so easy to control as the mixing of paint. Even with the system of selective breeding for good black color, it does not bring results overnight; but rather it is a long course to follow and at times one will think he or she is on the wrong track. But by being consistent and staying with it, good black color can be mastered and maintained.

Dear Nancy:

I read your letter about Brandy. I suppose others will give you better advice than I can, but I'm glad to see there are other members who are not breeders, but just have one pet rabbit.

Virginia is a Chocolate Dutch. She does not live in a cage, but has the run of my apartment. Every day when I get home from work I

take her out to run on a vacant hillside below my building.

If your rabbit has to live in a cage, if she squashes her droppings, my first thought is that her cage may be too small. Rabbits have a specific place to do what they have to and should be able to get away from it. Mine uses a place in the corner of the living room on paper that I change twice a day. As for the droppings being soft, I have noticed soft droppings for a few hours after a traumatic experience, such as a trip to the vet's, being chased by a dog, etc. Sometimes the pellets all are in a green congealed mass. But after a few hours it is back to normal. If the droppings stay soft, there must be some other cause.

Virginia is my second pet rabbit since I've been an adult. My first one died last October after I'd had her nearly two years. When I got her as a baby I was told she was a black Dutch, but when she grew to 11 lbs. it appeared she was a cross between a Dutch and probably a New Zealand. She had good Dutch markings, but the black of her rump faded to a gray-brown, and also some places on her cheeks. Now I am experiencing the same kind of fading with Virginia and I know her ancestry, so I wonder if the fading is due to being out in the sun when she has her exercise, or whether it is due to a dietary cause?

Since you live in Brookfield, you may be near some vets who will know how to treat rabbits as they deal with the animals of that famous zoo. I found with my previous pet that dog & cat vets don't know much about rabbits. She got an infection in her uterus and began passing blood. I will never forget those last terrible days, seeing those great quantities of blood (which she took care to pass only on her paper) as I ran with her to vets trying to find a cure. Finally one local vet suggested I take her to a vet in San Antonio who specialized in zoo animals. He took one look at her and said the uterus must come out immediately. The surgery was successful, but she died that night from an embolism. The local vet had given her coagulants in an effort to stop the bleeding, which could have been the cause of her death.

September 3, 1976 Thank you for the letter and quick service. I also want to thank Ted Merickel for taking the time to write and tell me a possible solution to Brandy's problem, although I wasn't able to try it. The reason why I couldn't was because Brandy no longer had just soft droppings, but normal droppings with about a lump or two of diarrhea about every 4th day. I didn't know what was wrong, so I decided to take her to the vet. He checked a sample of her droppings and reported she didn't have parasites or anything like that. He told me to put her on straight pellets for a week (I usually give her treats like lettuce, carrots, peanuts, etc., which he said, "she could not have.") She was on straight pellets, but she still had a lump or two of diarrhea every 3rd or 4th day. I called the vet back as he asked me to, and told him, he told me to put her on some medicine he had given me. After giving her the medicine for a few days now, it seems to be I spoke to the vet today and he said to keep her on the medicine until she doesn't have diarrhea for at least 4 days. If the diarrhea comes back again she'll have to go back on the medicine for longer than before. The vet said, "that if it were to get really serious, he might have to give her antibiotics, which he really didn't want to do." You may think its silly to take a rabbit to the vet, but she's the only rabbit I've got and she means a lot to me. Besides, I couldn't imagine why she kept getting diarrhea every few days. In case the diarrhea does come back, do you or any of the DR readers know what the problem is? She is on straight complete pellets, gets fresh water every day, and the droppings would be normal for about 3 days and also on the 4th but with a lump or 2 of diarrhea. If she gets the same pellets and water everyday, then why would her intestines be upset enough to have diarrhea every few days? Does anyone know whats wrong or has this happened to someone else? I received a few answers to the last letter and they were not only helpful, but nice. hoping to hear from more people about the last problem and also this one. I really appreciate when people take the time out to write and

I also received a wonderful letter from John B. Miller which I especially liked as he has only one pet Dutch like me. I will write to you again later to tell you the final information on how Brandy does as she has 14 days until I know if she's cured for good or not.
