Several years ago, we were called by a veterinarian for whom we did a good deal of work, "to drop everything and meet him at the farm of a multi-millionaire Texan who was intent upon winning the Triple Crown immediately, if not sooner."

Upon arrival, we found the problem was a broken foot, upon which we fit and nailed a shoe that would act as a cast, immobilizing the foot, hopefully letting the break heal.

When we sized this horse up, it was quite evident his legs were too small for his body and his bones were round where they should have been flat for greater strength. This horse had been imported from England at a great expense to this rich Texan, and I asked the Vet, "why they had brought him so far when he had such poor legs." The Vet's answer was, "speed." All else had been sacrificed for speed: The strain had speed, but no legs to carry them. Needless to say this man is still not famous for winning stakes or the Triple Crown.

How many times have we heard rabbit breeders say, "old so and so has great type, color or some other characteristic" which a breeder strives for, but his rabbits are pinched, light boned, or have poor ear carriage or other things.

These conditions are usuallly caused by a breeder becoming preoccupied with one or two phases of the animal, and while concentrating on this part, other characteristics are getting away from him.

I would gamble that this happens to the majority of breeders. The successful breeder is the one who recognizes when his breeding program is getting out of hand. It may be the introduction of an individual from outside the bloodline and it may be from within the bloodline. The successful breeder stops and checks his records.

This can be done by looking at his pedigrees, the date of the introduction of a new blood, or other details. None, no matter how insignificant should be ignored.

Failing to detect a change in the physical makeup of your production will soon have you out of business, or famous for being first off the table.

There are probably more people than you would think, who do not know a good rabbit when they see it. They are just like a blind hog finding an acorn, anything they win is purely accidental.

All of us are ignorant on some subjects, and most of us will remain ignorant on a majority of subjects. If you are going to breed rabbits, find a breeder who will and can help you (CONTINUED)

with your problems. Go to someone who is recognized as an authority on your breed. If you consult a breeder who is comparatively new, he may or may not know what he is doing.

Remember, you are not a failure until you say you are.

DUTCH TOP ENTRIES AT WISCONSIN STATE FAIR

The Wisconsin State Fair had the second largest entry in history in total rabbits with 1.070 entered as compared to 1.094 in 1970. The Dutch entries were tops at 167 with 20 exhibitors from 4 different states. Cook's Rabbitry was the winner with a Black Senior Doe for Best of Breed and his Chocolate Senior Buck was Best Opposite Sex. Cook's Rabbitry also received Best Black, Best Opposite Black, Best Blue, Best Opposite Blue and Best Chocolate. Ron Konczal received Best Opposite Chocolate. Doubeck's Rabbitry received Best Tort. Tom Dibb received Best Opposite Tort. Roger Guetschow received Best and Best Opposite colors in Grays and Steels.

Phil Macy, Brooksville, Ohio did a fine job at judging. The 2 Dutch exhibitors, Roger Guetschow and Cook's Rabbitry received 1st and 3rd Best Display of the show respectively.

The Dutch entries in the Wisconsin shows seem to be on the increase together with more exhibitors showing and I hope I can convince many of the exhibitors that do not belong to the ADRC to join for the many benefits they can receive by becoming a member. It seems as though the youth crusade is in full gear again but as one official of our club has written how can it be done economically? We as adults realize that training of our youth must transpire. While it is true that some youths are breeding dutch and beating the adults, it is also true that some parents are breeding dutch and showing them in their child's name. It is also true that youth and 4-H'ers are purchasing top show rabbits from concerned, reliable, adult breeders for exceptionally low cost. This is because the top breeders are also looking at the psychology of the child, fully realizing that a B.O.B. against adults enhances the ego of the child. This hopefully will increase the incentive for the youth to expand their horizons and perhaps develop a long range program for Dutch development. Being normally moral, the youth winning the top award under any condition, other than personal breeding program, gets immediate positive feed back but depression after the glitter has dimmed. This feeling is against the child's basic nature and they turn to fields that are lastingly rewarding. Some as we know never do find this feeling. It does seem possible that competition with their peers, pointwise would give lasting results. It is also possible to elect or appoint an associate youth chairman who could:

1. Work to develop the youth membership.

2. Solicit specials for a yearly award to the top 10 or 20 youths in the U.S.

3. Collect and compile youth points.

4. Edit youth correspondence for a youth page in the D.R.

5. Act as Liason between the board and the youth stating the youth views at board meetings.

6. Select youth representatives from each section of the country to boost dutch and youth membership.

Their are probably many more avenues to travel that would develop real dutch breeders. Perhaps the greatest recommendation this writer could ensue would be that the President select a special committee of three (3) Directors to investigae all facets of a youth division both positive and negative developing guidelines and recommending to the board their findings.

A time limit should be set for this purpose - perhaps for a life of one year.

The last investigation of the youth left a lot to be desired. We received just 3 responses from the youth. Perhpas things have changed. But in any case we as adult members must never close the door on our now youth members who are striving to yet make our club stronger. If we have 10 youthful members like Mark Bean in this country with his determination we could develop a lasting relationship of youth with the Dutch Rabbit. Your Remarks Invited.

It was this writer's pleasure to visit with some of our Mid-West breeders during a short vacation trip this past August. During these talks it appears that problems concerning our Dutch are in no way different in the East than the Mid-West. There is a shortage of good Dutch throughtout our sections with inquiries coming as far as 1,500 miles. In that the winter and summer have been simpley miserable for breeding, little is available. Most breeders that were visited signified that they produced perhaps 50% less young this year than last. Although our own Eastern Dutch R. F. Club has an increase of 22% in membership we have trouble stocking these new members with breeding Dutch because of this year's climatic conditions. As one club secretary told me, "When we make our catalog up this Fall we will figure on a decrease of 10 to 20% in the number of stock entered."

If you have a surplus of show or breeding stock please advertise in the D.R. and let others know of this fact. In July and August two men came all the way from Florida (1,500 miles) to purchase Dutch and all we could do was tell them to wait until Fall when stock may be available. Frustration, Yes! On both parts.

Another subject which has changed little is the judging of our Dutch. It seems if Dutch have half even stops the judges still call them good stops. It irks more than some of us to breed for 1/3 stops and <u>discard</u> Dutch with ½ stops when either one is called by some judges, "good stops."

Another sore point heard during the visitations of several breeders is the apparent overlooking of the "V" behind the ears called the neck (5 points). By personal observation at two shows this was not even looked at but organs and "hair spots" were highly scrutinized. Well maybe Don Brady has enough guides to start sending them out to some older judges.

I have heard that new prospective judges have a much harder testing examination than previously. Perhaps this will cure most ---- gripes and things - like tight belts that live according to the Standard but look close will be accurately judged.

Maybe we want mechanical or computer judging. This may be the answer in the year 2,000. In any case the visitations insured this writer, common troubles exist in our membership and some are frustrating enough for some breeders to lay down their feeding cups.

Greetings and things like that there. It is a nice, hot, humid day here in Texas. Getting used to it this year. But we do have a breeze and cool nights. Couldn't live if it weren't for that.

Thought I would propose a program to the members. They may or may not be interested, but nothing ventured, nothing gained.

Perhaps some of you remember my mentioning the Dutch Rabbit Futurity we had for three years here in Texas. It created quite an interest and some good prize checks for the winners. Here's how it works. Suppose we chose the National Dutch Show as the date for the judging. Rabbits would have to be born after November 1, and we would start payment on January 1. You can nominate as many as you wish at \$1.00 each. Payments would be the first and fifteenth of January, February and March at \$1.00 each and April First and fifteenth would have a payment of \$2.00 each making a total of \$10.00.

10% of the total amount would be given to the club for book-keeping charges, also judging. The six colors would be judged separately with the finals of all color winners. Let's do some supposing. Suppose we had 5 of each color or 30 entries. That would be \$50.00 for each color less \$5.00 for the club. This would make \$45.00 prize money. We take 80% of the total money for color winners and 20% to the Finals. That would make \$36.00 to the color and \$9.00 to the finals. First place in the color would win \$21.60 and a second place \$14.40. If the winner went on to win the finals, he would win a total of \$75.60 since the pot in the finals would be \$54.00. Clear as mud, eh?

The anticipation is fun. However if you nominate a little fellow and find that he just won't be a winner, you can drop out, but you forfeit what you have paid in already. You can substitute with a penalty prior to April 1.

Think about it and let us know what your ideas are. It might stimulate some more interest and we could have some fun putting it on. Anyway it is a thought.

We are all working hard to wind up our plans for the convention. Thank goodness I have my books, control sheets, judging cards, legs, etc. all ready. Just waiting for some entries. Think we are going to have a fine convention. Lots to see and do and a nice place to do it in.

One nice thing about the tours is that you do not have to commit yourself prior to coming and if you decide to go at the last minute, all you have to do is get to the door of the Hotel in time to catch the bus. There are two tours daily, and a long one to Galveston that must be planned in time for them to get a bus there.

Want to say that some erroneous information has been put out about health certificates. I talked with the Doctors at the Texas Animal Health Commission and they DO NOT require a (CONTINUED)

health certificate, to get in and out of Texas. The Airlines DO require those shipped by Air Freight to have a health certificate, but that is a ruling by the airlines only. So bring them on. We hope the Dutch will be one of the top breeds here.

I know I will be busy back in my "hole", but take time to come by and say hello and make yourself known. I like to fit faces to names I have read. Sure would like to meet all of you, and there names I have read. Sure would like to meet all of you, and there is always time to say "howdy."

THE BRITISH TIMKEN RABBIT SHOW by JOHN MILLER - TEXAS

It was my pleasure to be invited to attend the British Timken rabbit show on the 27th of August in the company of Mr. M. L. Fletcher, who is an honorary secretary of the Greater London Dutch Rabbit Club, his daughter, and a friend of hers, who were also showing rabbits. The Fletchers live in Kings Langley, ancestral home of Pres. Carter, which is 25 minutes from London on a suburban train. The show was held on the outskirts of Northampton, on the grounds of the Timken ball bearing works, sponsors of the show, which also included dogs, horses, pigeons, etc.

There were quite a few differences between this show and what I have seen of American shows, although my knowledge of these so far is confined to shows in Texas. In the first place, virtually all rabbits were transported to the show in wooden boxes. The cages themselves, provided by the show stewards, had wire sides, but wooden floors covered with straw, stacked 2 and 3 deep. The show was held in a large tent, with the cages in a square around the sides and judging tables in the middle. The general public was only permitted to see the rabbits around the outside of the square.

The show was of fur and fancy rabbits, and contained very few New Zealands or Californians compared to shows I have witnessed in Texas. There was a large contingent of Dutch, of which Black were the greatest number. There were also Torts, Chocolates, Blue-Grey, (they spell it with an e), Steel-Grey, Silvers and a color I had never seen in America; Yellow. The judging took place on a number of burlap-covered tables, with separate simultaneous judging of breeds.

They do not use judging-pens. Instead, the owners or showstewards stand on one side of the table, holding their entries, and the judge and secretary stand on the other side. The judge first examines each rabbit individually, and then arranges them in order according to rank. Everything under 4 months is a junior (for Dutch) over that is considered an adult. I saw some rabbits being shown that were not yet weaned! Rabbit shows in Britain are graded was according to their importance. The Timken was a "3-star" show, meaning that the awards would be multiplied by 3 to arrive at the number of points. Little rabbit shows, called "box shows", only carry one or two stars. The awards would be noted on cards, and the officials would put them on the cages. (I did not think this was such a good idea, as if the owners did not remove them promptly, the rabbits would start to eat the cards!) The show stewards did not provide the rabbits with food and water, considering it not necessary for just one day. A few of the owners, however, did so themselves.

Most of the show stewards were the white lab coats we see in our shows, but seldom were these coats embroidered with the names of their "studs", as rabbitries are called in England. Instead, I saw lapel membership pins worn, sometimes a number of them, of the specialty clubs one belonged to. (CONTINUED)

TIMKEN SHOW CONTINUED

A number of the people I visited with asked me about the differences between standards in Britain and America. They looked the same to me, but of course I was not really qualified to judge. When asked how many rabbits I had. I told them "very few - I really only do it as a hobby."

In Britain rabbits do not have ear tattoos. (They do on the continent, Iam told). Rather, each rabbit has a permanent metal ring on it's leg, much as a bird is banded, bearing a registration number. For the show, each cage bears a number, and a small label with that number is stuck in the rabbit's ear for the judging. The show lasted all day, and at check-out each rabbit's metal ring had to be verified against the registration list. Many good rabbits were shown, and it was a fast-moving and interesting show. Mr. Fletcher told me he would be interested in meeting other Dutch fanciers. SOME IDEAS TO ENCOURAGE ARTICLES FOR THE REPORTER by DAN ROHRER JR. - - HAGERSTOWN. MARYLAND

Perhaps we Dutch breeders that don't have a lot of experience can make a contribution to our <u>Dutch Reporter</u> by providing subjects which we'd like to know more about so that some more experienced member would be provided with the inspiration to do an article. Here are a few subjects as a starter and we would encourage others to send in theirs.

Marketing? Where do the large Dutch breeders market their animals other than their breeding stock sales? Small breeders can usually manage to get by with "pet" sales at Easter and the fairs. We can also manage a few breeding stock sale to others in our immediate area. We can cull closely and we can also keep our freezers stocked. However, if we get grand ideas of expanding our Dutch rabbitries where do we look elsewhere for markets? I would suppose that this information would differ in various parts of the country so on this subject we could use regional advice. We believe that quite a few new Dutch people become discouraged by the lack of this knowledge and turn instead to the commercial breeds.

At what point would it pay to handle your Dutch rabbitry as a business? Sometime ago we noticed articles in <u>Dog World</u> magazine on how to do a tax return for a kennel. The thought came to us that there is probably some point a rabbit breeder reaches where it would be beneficial to consider this. It would be nice if someone would provide the pros and cons of this subject, pointing out when this approach should be considered and offering some tips on how to proceed. On this particular subject I would hope that this suggestion would inspire Roger Eich's writing talents because he certainly has the professional background to be helpful in this field.

Proper Ways for Entering Shows? The entering of several people as a rabbitry is apparently being discouraged now so what is the best way for several breeders, especially of the same family, to be able to still show as a single exhibitor and comply with the rules? We'd like to have some suggestions on this subject which has become a problem this year.

Finally, a piece of advice that Iam qualified to give. Every Dutch breeder should have one of those Dutch key fobs that our publicity committee offers for sale. We all like to talk about our Dutch but most of the time we're talking to those who think rabbits are rabbits. They always ask "What's a Dutch look like?" I used to spend a lot of time trying to draw pictures. No more. Now I just whip out my Dutch key fob and provide a better representation than I could ever hope to draw. Everyone should have one.

Here's hoping that the above thought will provide some inspiration for articles by those qualified to write them. I hope others will send in similar thoughts.

The recognized colors are: Black, Blue, Chocolate, Brown Grey, Pale Grey. Tortoiseshell and vellow.

It is also worth mentioning that <u>any</u> Dutch over 5 pounds loses 20 points out of a possible 100. No minimum weight on Seniors. The Stops are to be 1½ inches in length which would on a 4½ pound Dutch be approximately equal to our standards 1/3 up the hock. The Ears must be a work of art. The specifications: Short, though strong and neatly carried free from white hairs on the front flats and free from flesh marks or white hairs inside. It is interesting to note that they call the nose "feeler" and Hair the "smellers."

Well in any case it is up to you to make up your own mind if the state you have a mind to purchase Dutch from our "Mother Country."

OUR CHANGING STANDARD

Much has always been asked and never quite answered what was the Dutch Rabbit like years ago? Through the generosity of Al Meier some standards of years ago ended up in my hands. A comparison of points alloted will describe the Dutch of the times:

In 1932 the stop length was 1½ inches up from the tip of the toes. In 1934 until 1955 the stop length was ½ way up the hock. As you know it is now 1/3 the way up the hock or right after the toes. It's too bad that the rabbit "genes" can't read our standard.

It becomes readily apparent that we have become more selective or "picky" over the years particularly since 1955.

The minimum weight has made tremendous changes over the years. Up until 1960 there was no minimum weight on seniors! Also at this time A.O.C. was eliminated. This means "Any Other Color" which included Blue-Gray, Blue Fawn, Yellow, Red or any other color. This included the Lilac colored Dutch which disappointed many breeders, (according to survey taken in 1972-73 by this writer) Why this was eliminated was never explained. To many breeders including this writer, probably because of my initial enrollment in the Dutch Club. Perhaps this was the correct procedure to use - in that most A.O.C. did not breed true, being recessive in nature. There are some that would even cut our standard down to 5 colors at this time but it is doubtful whether it would ever be adopted.

Yes, our standard has changed at one time there was a 4 inch ear length maximum imposed!

The next question might be why change and how does it come about? In answer to the first query probably is that the "finer" a breed is defined the stronger the standard becomes with more breeders striving for the same thing.

How does it Change? A breeder or a group of breeders lobby for what they would like to see changed. If they can convince the board of directors that the particular thing needs changing or revising a vote by the membership is taken. If the majority of members agree, it is on it's way. The A.R.B.A. Standard Committee will act on this scrutinizing the change to see if it has merit and normally will adopt the change. This is normally a 5 year process due to "book of standard" printing. This should answer most of the questions asked of the Dutch Rabbit years ago and how the point spread has deviated. Perhaps some of our more mature breeders would like to expand on some of these points. Perhaps verifying or aligning the thoughts.

After studying our standard of perfection (1976 Edition) it was found that it differs from the A.R.B.A. standard of perfection (1976 Edition) According to our Dutch Club Standard, Page 58, type is listed deserving of 15 points while Weight & Condition are award no points on the same page. On the other hand the ARBA Standard of Perfection Page 62 awards 15 points on type, weight and condition! After checking some of our clubs older guide books it was found that this apparent glaring error has been carried over through several guide books. I am sure that the Dutch Club needs to have some points alloted to Weight & Condtion. This error should be corrected as the new breeder uses our Dutch Club Standard as a bible and will breed as all of us do toward the perfect pointed Dutch. Perhaps a paste in page on the rest of our stock of guidebooks or mention of the preceeding would suffice.
