

As we approach the end of a summer that has set heat records all over the country and drouth clear into Mexico, where the toll in livestock deaths is unusually high, it is not very comforting to think that perhaps we are due another record breaking winter.

Now is a good time to check your rabbit equipment including nest boxes and watering systems, also heaters if you use them.

The ARBA Convention at Saginaw will be a little early for Texas rabbits conditionwise, however you can't always be right.

Most of the members of the Dutch Club are dedicated fanciers and really to everything in their power to promote our breed. Of course we have the in and outers, and we always will. They come and go. We have to do everything we can to try to keep them in.

A lot of breeders, and not just Dutch breeders, are best described by one of our Dutch Directors as "at six months an authority and at twelve months are gone". Don't you know some like that?

In my opinion, most of the older breeders of any livestock will be quick to dodge the label of "authority". We have many authorities in the rabbit business, however they would probably deny it.

What this is leading up to is the opportunity for all Dutch breeders to participate in financially helping our club. At the ARBA convention and the National Dutch Show, our club sponsors a sellers class and sale. From now on, the breeder entering the sellers class, and of course consigning an animal to the sale, receives half of the money the animal brings. If the animal is in the sellers class, he must sell in the auction. If you don't have an animal to enter, you can help by buying a rabbit at the sale.

If you wish to buy a rabbit, be at the sale and get your bid in. This is usually a good place to buy an animal from good blood lines. Don't be afraid to buy an older rabbit. Lots of times these are the best buys. The breeder may have consigned an old buck because he just has all of that particular blood line he can use, or needs, and you may get just what you want at a bargain. REMEMBER YOU ARE HELPING THE DUTCH CLUB AND YOURSELF, PLUS, YOU SET THE PRICE YOU WANT TO PAY!

Vice-President Roger Guetschow is in charge of the sellers' class at the Saginaw convention. You should contact Roger as soon as possible if you wish to enter a rabbit to allow him time to get his class organized. When you get to the show, you should get in touch with him again to let him look at the animal, and by all means, HAVE THE RABBITS' PEDIGREE WITH YOU.

On August 12, the Southwest Rabbit Breeders of Fort Worth held a night show at Keller, Texas with over a hundred Dutch Rabbits. The judge was Tex Thomas of Missouri, who has raised some good Dutch in his Day.

We are still seeing and hearing of a number of judges mis-handling the rabbits on the table, especially stretching the undercut. Our examining and regulating of judges still leaves a lot to be desired.

I don't believe that many of the members are aware of the fact that the Dutch Club has a booklet which was made available by Bill Geitzenauer, showing the proper way to judge Dutch. The illustrations are the same ones used in our Guide Book which Dick Bernhardt drew up. I have been in charge of distribution of these booklets. One is sent to each new judge as soon as his or her name is announced in the Domestic Rabbits. We also send a letter of explanation telling the new judge we are trying to help them better understand the judging of Dutch. All of this, including postage, hasn't cost the club a thing and we feel that from the comments we have received, that it may help get better results at the shows.

These are the folks that have made new member recommendations to the Dutch Club. I forgot to mention why you were being thanked in the last issue, so now, for last time and this time, THANK YOU for promoting the Dutch Club. You are "TOP DRAWER".

GREETINGS from Lake Village, Indiana:

As I mentioned last issue, several does of mine died and I thought it possibly due to chemical or drug contamination. I'm glad to report that though there was hog and cattle feed present, there was no chemical or drug contamination in the feed. The feed company representative contacted me personally and we talked and cleared the air, but that still didn't answer all my questions about dead stock.

The other day my oldest daughter and I visited a small "rabbitry" and my daughter was really upset with what she saw. Sanitation was non-existent, cats, dogs, and pigs have access to the same area as the rabbits. Also at one time chickens were present. I won't go into detail of what was seen, but a word to the wise is sufficient. SANITATION IS A MUST.

Keep other animals away from rabbits, and clean hutches and equipment regularly. To clean hutches (cages) <u>First</u>; I use a wire brush, <u>Second</u>; a wooden bristle scrub brush with a bio-degradable washing solution is used, <u>Third</u>; a disinfectant is sprayed on and, <u>Fourth</u>; a clean water rinse tops it off. The choice of cleaning solution and disinfectant is yours, of course.

Another recommended solution is the use of a small flame torch, propane type. This is used to kill germs of course, but will also burn clinging rabbit fur. But use great care.

Recently while visiting a "rabbit raiser" as compared to a rabbit breeder, a couple of points were realized by me. All too often in the eagerness of some people wanting to start raising rabbits, they obtain rusted, bent delapitated, brplem. etc cages of varying size and stuff their rabbits in these and SHAZAM — they're a rabbit breeder. Rabbits in these "experienced quarters" are more than likely going to get hurt. I have seen rabbits with pierced ears, parts of ears missing, claws and toes missing, cut and scratched and two animals with the backs of their legs bare to the meat because their feet had gone through the too large a mesh floor and couldn't get back out.

As for cages for rabbits, I built my own. I prefer to use %"X1" welded wire. Don't confuse this with %"X%" woven hardware cloth. I use welded wire for floors of course, but also for sides and tops because of the strength factor. In my cages I place a double wall, one inch apart between sections so one rabbit can't pull hair from another. I do this in my transporters also, to protect the fur and animals from each other.

Does anyone out there in DUTCH COUNTRY have a recipe for canning rabbit? I'd like to try it.

I truly feel the way we help them and treat them makes all the difference in the world in them raising Dutch or not. Some of these High priced rabbits haven't helped either, anyone that raises Dutch knows that what you see "ain't" always what you get. Some of these all mighty dollar breeders sure don't help us poor souls trying to encourage young breeders to raise Dutch.

I would personally like to mention Judge C F Simpkins from Georgia as he has set an example for us in the South. We truly need more breeders like him. We hear good comments from Jim Capps, Pleasant Grove, AL. Jim is a new judge doing a good job. Down South we are proud of him.

BUTTER OR YELLOW ANYONE?

In houston I showed the Golden Dutch buck I brought back from England. I have been trying to find others with the color. What better time than the Golden Anniversary of the ADRC to re-sanction the color! In order to extablish a sanctioned breed, I understand it is necessary to assemble in one place at one time a fair number of animals that meet the proposed standard, and that there must be both jrs and srs, bucks and does. For this purpose, I wonder if you would ask in the DR that anyone having any of this color (also called "butter", and in England called "yellow") to make themselves know to me. Then an effort could be made to get a number of them together at a show simply as an exhibit, with a view toward establishing a sanction.

I wonder when it was that golden was dropped as a sanctioned color? Someone told me they thought it was during the 1930's.

By the way, my yellow Dutch does not have a typical undercut. The whole tummy is white, but there is a faint yellow shading of the upper part. He did take first in his color at a show in England as a jr yellow before I brought him here. Recently I was back in England and talked to the people I got the buck from. They told me one of his litter-mates won "Best in Show" at Nottingham, which was a large rabbit show with many breeds besides Dutch.

If your show listing does not appear, Check the rule to which we adhere. Sixty days is the minimum limit, To insure we get your show date in it.

Did you know that we sanction over 400 shows per year? Some of these reports have returned lately with only a couple of dutch shown. You would be helping the Dutch Club by supporting these shows. Perhaps sometime in the future they will stop sanctioning because of lack of interest.

After receiving three letters this year inquiring of what excellent stops must be by breeders of less than 3 years, this writer did some investigation. It seems that our Guide Book Standard both shows and explains where the placement must be up to the exact measureable length of one third up the hock.

The A. R. B. A. Standard of Perfection also clearly states the one third up the hock. Well, what is the trouble with this? It took me some time to realize that the hock length overall side view versus top view are not the same. By observation of judging this spring in ALL shows, the majority of judges, looking at stop length place the rabbit on their backs, hold the hind legs together and observe the presumably one third length. Well, with the help of a ruler this can be proven wrong! In defense of the Guide Book, they are correct in that the hock length is different, side view and top view. It seems the joint accounts, on a senior rabbit, for about one half inch difference and most judges observed "read" the top length only! I am only guessing, but I would think the length is the overall hock, best observed by a side view. This writer in April observed, a known judge, call stops that began color immediately after the toes as "very good stops", yet, stops about one quarter inch longer ——"Fair stops". Upon questioning the judge said, "They are a hair long".

Perhaps one of our Standard Committee will define this for us. Quite possibly it is an interpretation by each judge or wording ——In any case we should be working toward a standard with LITTLE if any interpretation needed. Maybe one of our esteemed judges will define this?
