

Another listing we may want to consider is grand champions. Dutch grand championships are lost in the numerous listing of other breeds' grand champions in the "Domestic Rabbit". Listing the Dutch champions in the Dutch Reporter would do two things: 1) those Dutch winning grand champion would be properly recognized and 2) more breeders may be encouraged to get the ARBA grand championship certificates on those winning Dutch. You as the breeders will be responsible for getting copies of the grand champion certificates mailed to my office to process them for printing in the Dutch Reporter.

The election results are listed in the reporter. I would like to thank each member who took the time and effort to vote. Voting is a privilege which should be utilized by each eligible member. My congratulations to those succeeding in winning in the election, and my thanks to all other candidates for their interest in the ADRC. I would personally like to thank each one of you for caring enough to participate.

Members will also be able to review the suggested chages or clarifications in the Dutch standard contained in this issue of the Dutch Reporter. I would also like to thank all those committee members and club members who helped guide the committee through the explanations, changes, or clarifications. Balloting will be issued on the items which require membership vote. This will be accomplished in enough time for inclusion in the 1985 Standard of Perfection.

I am very happy with the progressive attitude of the Dutch Club and its members. Let me know how the American Dutch Rabbit Club can better serve YOU.

A TOUCH OF DUTCH By Director Geitzenauer

It is very pleasing to finally feel the ADRC moving forward again to modernality. Was asked just last week by a newer Dutch breeder (Blacks) why we were pushing for the standards change. My answer, of course, was the majority of the members <u>had</u> to be served. As the human body has evolved over the years, crime (what is a) punishment (what is reasonable) standard of living, wages, working hours, economy and most of everything tangible or not, has had to change.

Our Dutch rabbit of 1950 could not even compete at our modern shows. Yet our standard has failed to slowly evolve as the people breeding Dutch have-----. Perhaps this is why the standard needs badly to be updated! Normally, it would be a slow process, but with a logjam of inactivity over the years on this issue, we must now look like the bad guys.

Tracing the history of our Dutch standard since 1932, this 28 year period (present) of no major changes, other than working technology, has already been the longest period of logjam in our history. As one man said, the Gray were the first Dutch and it now <u>appears</u>, after 51 years, to catch up to what has been raised the past 20-25 years.

At this writing, I know that some standard committee people are spending hours trying to catch us up to present day standards and it is a "chore of love" to be in this position of not hurting some members; but satisfying the majority.

Hopefully, after this evolution, the committees of the next 20 years will allow a gradual transition, if necessary, in <u>OUR</u> standard. Notice that it is <u>OUR</u> standard and serving <u>OUR</u> people, not anyone else!

In Michigan, we have had a very hot summer, wet though. Fall is approaching and the rabbits usually enjoy cooler weather. The ARBA Convention is very near; remember to try to attend or send

your "BEST". It only takes one rabbit to win it all and it could be the one in \underline{YOUR} hutch! Always remember to save a young quality animal for the "Sellers Class".

Some helpful tips on raising good Dutch are:

- 1. Save bucks and does from mothers that cross well with any buck. (These are your foundation does and your herd should be built from these.) Does that cross well with just one certain buck usually do not make good foundation does.
- 2. I try to use the best bucks on the best does but personally feel the maternal input is the most important of the two.
- 3. Good Dutch sometimes just happen, but most of the time, they are planned.

FROM DIRECTOR WILLIAMSON

This has been a blistering summer and rather stressing on the rabbits. I hope you all didn't have much bad luck because of this.

The results of the Youth Comment Sheets that were published in the May/June issue of the Dutch Reporter follows. We sent these comment sheets so that every youth could have his/her input into the future programs and contests. I received 6 replys before the deadline and 1 late answer which is not a good percentage for the number of youth members in the ADRC. The rating according to the six that took the time to answer are (high to low); Judging Contest: Showmanship: Achievement: Quality: Family Class: Get Of Sire: Membership:....

Regardless of the small number taking advantage of this chance to give the Committee Director their views, I still feel that there are many youth who will participate in the programs we will try to put together. I believe it will be best if we can start with two contests. The two that I feel will give us the most opportunity to learn about our good youth members and our breed are: the achievement and the Judging contests.

TYPE OR MARKINGS?

When I was a rookie Dutch breeder, I didn't put too much importance on Type. I read the ARBA Stanadard of Perfection and saw that it is necessary to combine the points for type with those for color and fur to equal the points for markings. It took some long talks with some top Texas breeders like Earl Smith, Mickey Farrill and Don and Nelle Brady to educate me on the importance of type.

It is difficult to pick up a publication concerning Dutch and not read an article on Type. I am constantly seeing comments like, "type is the most important consideration..." or "first and foremost, type..." So it is obvious that most Dutch breeders put extreme importance on type.

However, I am still a bit puzzled. If type is so desireable and is "important above all else," why does the schedule of points not reflect it? It's almost like type is being overly stressed. Somebody convince me I'm wrong!



Editor's Note: Jim, There are six markings that are allotted points, totaling 50. Technically, there are six features combined to make up the general type totaling 27 points. (These are not necessarily my views, but, possibly those of the Dutch judge.) Together with the general type, the fur and color totalling 23 points combined, make up 50 points, equalling the allotment for markings. Since the markings are highly emphasized on a Dutch rabbit, it seems that the faults or cuts are more severely applied by most judges. If the judge likes the type on a Dutch, and combines nearly all points for fur and color, that leaves very little room for marking faults. As all rabbits are to be "properly balanced", a Dutch with a body that does not conform to the standards is "out of balance", thus possibly

initiating a major cut. The point allotment in our standards is only to be applied in "rating" certain points of the rabbit. The one having the most points (type) being the most important. Remember, body type carries more points than any other single feature on a Dutch. Our goal, along with the judges', is to get the "best balanced rabbit." [If I may, I, along with many Dutch rabbit breeders, feel that the above specified type makes for the best possible looking Dutch, but, we don't feel that our Dutch standard is placing as much emphasis on this type Dutch as do some breeders and most judges. My own personal opinion is that a well marked Dutch with good color and fur, but not real good body type, should win over a Dutch with excellent body type and some marking faults......what we really need now is to try and get all judges to judge as close to the standard as possible rather than certain features being the deciding factor as to that judges personal preference...) "Norma"

Hello,

My name is Amber Barley Ludwig. I'm 10 years old and have been raising rabbits for 2's years now. The first two years I raised French Lops exclusively with much success in 4-H and ARBA shows. All my French Lop breeding stock is registered and are Grand Champions now. I wanted a smaller breed for showmanship and chose the Dutch after much discussion with my parents and other breeders.

The challenge of type and markings and the advantage of a small breed with a good disposition were the deciding factors in picking the Dutch. Then, the real work started.

I joined the ADRC, received the standard, studied it, went to all the local Dutch breeders, compared rabbits and asked unending questions. This all took about six months before feeling capable of buying good stock. Finally we found, and bought, two blues from different breeders. I have taken them to five shows so far and have won 5 BOB with the doe and 4 BOS with the buck. They are both now registered and Grand Champions.

In one week, the doe is expecting her first litter. To say the least, I'm excited and anxious. My point in writing this is to say that starting out with good animals makes a big difference on wether you stick with it and improve the breeds' future, or settle for mediocre. Taking the time before you buy to learn all you can is worth the lack of frustration and cost in mistakes you will avoid.

Now my job is to keep it going by being very strict in culling, and that pays off too!

I hope this letter will encourage other youth to learn the standard before buying - it could only help!

DISTRICT 5 YOUTH REPORT BY: Steve Walsh

I am writing from Springfield, Illinois from the Illinois State Convention. I believe there were 138 open and 69 youth Dutch shown in both the All Dutch Show and the Convention. On Saturday, Dr. Terry Reed Judged and Billy Dodoge Judged the Dutch in the Convention Show. The overall quality of the Dutch was excellent! They also hold a King and Queen contest for the youth.

Enclosed in an issue of the Dutch Reporter was a Youth Comment Sheet for the youth to send to Wilbur Williamson to give their opinions of the contests available. Well, I talked with Wilbur at one of the local shows and asked how many sheets he received. I believe there is a total of about 300 youth members that could have sent in replies. Wilbur received six. I'm sure that if you still have your Comment Sheet that Wilbur Would be happy to receive them even though they are late. The Youth Committee has worked hard to start new programs for our youth and I think the youth should show more interest.

Fall shows are just around the corner. I hope that everyone took good care of their rabbits during the hot summer. It will pay off at the up-coming shows!

FEED

By Mary Chamberlain, N.J.

I started experimenting with different feed supplements not long after acquiring my first Dutch. He was so upset at having to leave his loving owner that he refused to eat. At shows I often had to assure the people looking at him that I was not abusing him, he simply wouldn't eat. (I still think half of those people believe I beat and starve my rabbits!) I've done alot of asking about and studying on feed since then.

Concerning actual rabbit pellets, the National Research Council recommends a crude protein level of 16%. However, levels of 16, 19, 21 and 22% have been tested. The most rapid growth rate for 3 to 8

weeks was obtained with 18.4% protein level.

When dealing with high protein feed like calf manna as a supplement, one must be wary of too much protein. When this happens, the skin on the rabbit dries out and flakes. One tablespoon of calf manna daily is generally recommended for fast weight gain.

Breakdown of Feed Supplements:

Calf Manna, 25% protein; Creep Feed, 25%; Rolled Oats, 15%; Omolene, 14%; Wheat, 13%; Whole Oats, 8%

Instead of wood, I give my rabbits large dog bisquits to keep their teeth down. These are also convenient to give at shows. I have discovered that most of my rabbits have an absolute passion for strawberry and blueberry yogurt. Perhaps this would be good for orphan bunnies!

Don't shortchange your rabbits nutritionally Just to save a few dollars. That aforememntioned buck still treats food like most 7 year old children treat liver.





The above picture was taken at last years' 1982 All Southern Dutch Show. Lowell and Wilba Jones won seven trophies at this show. The trophy on the right is an All Southern "Best Display". If it is won three years in a row by an All Southern member, he or she keeps it. Lowell, last year, won it for the third straight year.

This man is one of the best Dutch breeders around. So if you want to see a good Dutch Show with good Southern hospitality----a well organized show run by a good Dutch Man, "Bob Griffith", and great judges, you should try to attend!

November 12th: is the date! It is a big money special show, so you Dutch up North, - Here's your chance!!

As American Dutch Rabbit Club Standards' Committee Chairman, I have the responsibility to coordinate the responses and inputs of not only committee members but also concerned members. This, as you may imagine, is not an easy task and has required a great deal of thought and consideration to consolidate and edit the suggestions listed below. I wish to thank all the committee members and a few "off committee" Dutch members for their inputs. Each item will be listed separately so that you may focus your attention on each concept or clarification as it is presented.

ITEM: Show room classes and registration weights

Senior bucks and does: description to remain the same

Junior bucks and does: Under 6 months of age and not over 4 pounds.

ITEM: General type

BODY - Points 17: To be cobby in type, compact in form and limb. Dutch type consists of a nicely rounded back, beginning immediately behind the head progressing over the shoulders, to the highest point of the loin and hips perpendicular to the stifle, and rounding off into a well filled hindquarter. From the top view; the shoulders should be rounded and slightly narrower than the hips, the rib spread should be so that the side lines carry straight through from the shoulders to the hips, and finally, the hips should have a well rounded appearance, full to the base of the hindquarters. The Dutch should maintain the short coupled, well rounded appearance whether it weighs 3½ pounds or 5½ pounds.

Faults: Large protruding hips that lose any smoothness and roundness, also pinched, undercut, chopped or flat hips. Potty specimens are undesirable as well as flat bodied specimens. Avoid narrow, racy animals. Severe cut for a prominent dewlap.

ITEM: Weight and condition

This item will be listed following the body type section and will include the following description:

Weight: Seniors range in weight from 3½ to 5½ pounds with an ideal senior weight of 4½ pounds. Juniors will not exceed 4 pounds in weight.

Condition: Flesh should be firm and solid, skin to be tightly drawn over the flesh, making the pelt tight and hard to grasp. All animals are to have a definite appearance of health and vigor. The fur should possess a finish to compliment and enhance the markings. In addition, the fur should be free from stain and moult.

Furthermore, since only 5 points are allotted to weight and condition, the proper distribution of other points should be kept in the correct prospective. In otherwords, weight and condition is worth a total of 5 points out of 100; no more, no less.

HEAD - Points 5: Same description as written in the standard

EARS - Points 2: Same EYES - Points 1: Same

Since feet and legs as well as the tail are integral parts of body type, the point values from these two sections are utilized to further the development of proper Dutch type.

ITEM: Fur

FUR - Points 10: Fur to be dense and short, it should be coarse enough in guard hair to offer resistance when stroked toward the head. The coat should fly back to its natural position and lie smooth over the entire body. There should be a fine dense undercoat, which is soft, interspersed with decidedly heavier or thicker guard hairs. The coat should carry a very high lustre.

Faults: Long, thin coats. Coarse, harsh or wiry coats. Guard hairs which are too long. Fur too soft.

ITEM: Color

COLOR - Points 10: Same with the following exceptions

Eves - dark brown.

EYE: The iris or colored portion of the eye should be dark brown in Blacks, Tortoise, Steel and Gray. The Chocolate should have a dark brown iris with a ruby cast to the eye. Blues to have a blue-gray iris.

Faults: Hazel or light brown eye color in all varieties except Blue, hazel or light brown eye color in the Blue variety to disqualify.

TORTOISE: same with the following additions: The smokey blue shading to include the underside of the tail.

Added to faults: Underside of tail light in color These additions will be added in place of "under tail to match shadings; light tails are permissible, but very undersirable."

The brown gray is to have an agouti coat, showing distinct BROWN GRAY: bands of color when the fur is parted. The color of the fur at the base of the hairshaft to be slate blue, followed by a medium tan colored band, next a thin band of black, finished by a lighter tan tipping to the undercoat. The entire body, head, ears, topside of tail, and hind feet comprising the agouti color should be interspersed with an even distribution of black guard hairs. The broadest ring should be the base, followed by the intermediate medium tan band, finishing with a balanced width between the black ring and light tan tipping. The agouti color should be carried as uniformly as possible over the colored portion of the body. Narrow black lacing on the ears is desirable. Eye circles should be narrow and medium tan color. The belly should have a white or cream surface color with a slate blue under color extending from inside the rear legs over the belly to the undercut. When the belly surface color is white, the undercut is determined by blowing into the fur. The slate blue under color will then determine the placement and shape of the undercut. Medium tan lap spots are permissible.

Disqualifications: Absence of ring color, absence of slate blue under color on the belly.

The topside of the tail must compliment the body color with the underside of the tail to be the same as the belly color. ITEM: MARKINGS

NECK - Points 5: Same as in the standard plus:

Since the neck marking is a continuation of the blaze and cheeks, the point value will remain at 5. However, to clarify what to do with animals with full or dirty necks the following point structure should be followed:

Full necks Dirty necks

5 point cut
Point cut according to the amount of dirtiness
the neck possesses. (1-5 point cut)

Full neck + drag onto the collar

5 point + cut (no more than 10 points) depending on how much the neck drags onto the collar, disrupting the saddle or collar demarcation.

STOPS - Points 10: Hind feet to have white markings placed one-third the distance from the tip of the toes to the back of the hock joint or heel. This would place the stop approximately one-eighth inch behind the crotch of the toes. They should be equal in length, clean cut on both feet forming perfect circles around the feet where the white of the stop meets the body color of the leg.

ITEM: DISQUALIFICATIONS APPLYING TO ALL VARIETIES

Strike the statement: The absence of definite markings (except hairline between ears).

Note: The detail with which each marking is described should automatically preclude any animal being granted registration or an award at a show.

These clarifications and additions have been suggested in the best interest of the American Dutch Rabbit Club and the Dutch fancy. 

Your membership expiration can be found both on your current ADRC membership card along with the label of your Dutch Reporter. If your membership expired 60 days (sixty days) prior to your renewal, your membership can be backdated to show no lapse, should you so desire. Please be certain to request same when renewing. If your membership has been expired for sixty days, any points accumulated prior to this time, HAVE BEEN FORFEITED! Do not ask that these be credited, as they CANNOT! There are a few in the current sweepstake standings in this issue that you will not see on the next, [unless they again start from the bottom and work their way up]. Officers have thirty days in which to renew! Memberships are: \$7.00 single adult; \$9.00 H/W; \$5.00 for those youth under the age of 18 years. Combination ARBA/ADRC memberships are: \$16.75 single; \$21.75 H/W; \$9.75 for those youth under the age of 18 years.

Sanction fees are \$8.00 open and \$5.00 youth and requests should be made this office as early as possible. It saves delay along with the insurance that your upcoming show will be published in our bi-morthly bulletin. The Dutch Reporter. I receive some requests one week before the scheduled show date. Show secretaries, - please return your report form to this office within 30 days completely filled out. Also, be certain that your ARBA show code number accompanies the request. I receive many that have only a check enclosed. I have no idea when your show date is, your ARBA code number, your show secretary name and address or the location. This is then returned to the sender for additional information and requires undue delay! Many show reports are received that have two bucks or two does listed as winning the BOB and BOS: some arrive without all of the exhibitors names listed. [We know this as we find them placing in a class and their name is not included on the form). There is no way to tell if an exhibitor is omitted in some cases as the placements only go through five. If you are not listed on the exhibitors' list, we have no way of knowing that you showed.

Another item brought to the attention of this office is the fact that sponsoring clubs are not paying the required specials. The ADRC requires that you pay \$1.00 for the best of each variety providing that 10 or more Dutch are shown. This is also per ARBA rule. [There is no variety limit]. The sheet sent out with the sanction form and ribbons states the above clearly and also asks that a tear sheet from the show catalog be mailed with the completed form showing the ADRC heading and the specials paid. This is not being followed!! The American Dutch Rabbit Club currently has one of the easiest specialty club forms to complete. It also has one of the least amount of required specials. Please be sure to follow the instructions found with your sanction to insure proper crediting of points and also to insure any future sanctions.

Should you find that the show you attended did not pay the required specials, [and there were at least 10 (ten) Dutch shown in the breed] first contact the show sponsors regarding the matter. If you then receive no satisfaction, please write this office and send a copy of the specials listed, or a copy of your show report. [Be sure that ten Dutch were shown]. The above does not apply to the youth ADRC sanction. Most clubs provide very good specials for their youth exhibitors considering that at times, very few youth Dutch are shown.

All rules are as simplified as possible and you will find that if followed, there is less confusion for all parties concerned. If you have any questions regarding ADRC rules, please write this office! I'll do my best to explain as clearly as possible!



TO BE COBBY IN TYPE, COMPACT IN FORM AND LIMB. GOOD DUTCH TYPE CONSISTS OF A NICELY ROUNDED BACK, BEGINNING ALMOST IMMEDIATELY BEHIND THE HEAD AND PROGRESSING OVER THE SHOULDERS, LOIN AND RUMP TO TAIL. SHOULDERS SHOULD BE ROUNDED AND SLIGHTLY NARROWER AND LOWER THAN HIPS. RIB SPREAD SHOULD BE SO THAT THE SIDE LINES CARRY STRAIGHT THROUGH FROM THE SHOULDERS TO THE HIPS. A GOOD DUTCH SHOULD HAVE NICELY ROUNDED HIPS, VERY SMOOTH, ROUNDED UNDER VERY GRADUALLY AND SMOOTHLY. THE DUTCH SHOULD RETAIN THE COBBY, STOCKY APPEARANCE WHETHER IT WEIGHS 3½ POUNDS OR 5½ POUNDS.

IDEAL WEIGHT - SENIOR BUCKS AND DOES, $4\frac{1}{2}$ POUNDS. REGISTRATION WEIGHT - SENIOR BUCKS AND DOES, OVER 6 MONTHS OF AGE, $3\frac{1}{2}$ TO $5\frac{1}{2}$ POUNDS. FLESH FIRM AND SOLID, SKIN TO BE TIGHTLY DRAWN OVER THE FLESH, MAKING THE COAT TIGHT AND HARD TO GRASP.
