

Here it is, the end of summer already! Time sure flies, and I don't even know where it went.


There have been quite a few fairs around our area this summer, and the Dutch entries seemed to be pretty good. It is nice to see so many exhibitors promoting their breed year round.

It would be greatly appreciated if those sending for the sanctions would be a bit more careful when filling out the forms. Like I said, it won't take any longer, and it will help get your sanction back in a more expedient manner.

The Columbus convention is upon us. By the time you read this, you should already have made your plans and reservations for the ARBA National in November. I wouldn't doubt that this will be the largest entry of Dutch at a National Convention ever. Kevin Hooper and the Ohio Dutch Rabbit Club will do a bang up job, and I am sure the quality of Dutch will make the job of judging both pleasurable and difficult.

Should anyone have an item or two they would like the Board to discuss, let one of your Directors or Officers know before the meetings so we will have a chance to discuss your concerns.



FROM THE EDITOR

It is unbelievable that another issue is already due out. Once behind, it is rather hard to catch up, but we will manage.

This issue will be extremely small, as it is necessary to get the ballots out in it. This is an area I have a small problem with, and am planning on presenting a resolution to address the same.

Let's take this election for example. We have three Directors running for re-election, and there is no opposition to any of them. Is it really necessary to waste 2 envelopes in each Dutch Reporter, plus the cost of printing the ballot envelopes for an election where the three candidates are a sure thing? I can see going through with the procedure if someone is running with opposition, but honestly, how many of you are going to send in this ballot, when it is unnecessary?

I am proposing to draw up a resolution to the effect that if a candidate is running unopposed for an office, there will be no ballot for that position. EX: If two of the three running in this election were unopposed, and the third had someone running against them, only the names of the people running with opposition would be on the ballot. Those running unopposed would be declared elected by acclamation. I believe this would be progressive for the ADRC to consider this, and I will make an attempt to get a resolution passed regarding this subject.

I will also possibly be presenting some other resolutions that would address areas of the Constitution and By-Laws pertaining to calendar deadlines, such as the election procedure. With the Dutch Reporter going to a quarterly instead of bi-monthly publication beginning the first of the year, there needs to be some changes in order to come into sync with the publication dates.

If you have any concerns or suggestions along these lines, feel free to contact me in regards to them.

Remember that the Dutch Reporter must be put together in multiples of 8 pages. It must contain 8, 16, 24, 32, 40, 48 pages, etc. Should there come a time when I need to add extra pages in order to meet the 8 page specification, I will try to fill in the extra pages with upcoming shows. We have had comments in the past that the readers have missed the upcoming shows, so I will try my best to include some in each issue.

Dave wanted us to let you know how you swept the show here, at least with one rabbit.




Congratulations, Bob and I are happy one of our California breeders won.
