Enclosed in this issue you will find the annual American Dutch Rabbit Club membership listing. This listing was printed on March 1st., and contains all updates received to that date. If your membership is not updated, or you are a new member not listed, your membership dues were received after printing. The date following the name and address is your expiration date. Should you have any questions, please feel free to contact the Secretary's office.

You will also find the ballots for the National Dutch Show and ARBA Convention Judges enclosed in this issue. If you hold a husband/wife membership, you are each entitled to a ballot. A single adult member will use only 'one' of the ballots provided. Youth members will use the 'YOUTH BALLOT ONLY'. Be certain to follow the instructions on the ballot completely to ensure their validity. Please exercise your right to 'VOTE'!

The shows are well underway in our area and it appears that Dutch are definitely on the rise with alot of new exhibitors and some stiff competition! It's nice to see our judges giving equal consideration to what used to be known as your 'pocket rabbits'! I think they finally realize that a junior is just that, a 'junior' and should be judged according to the standard. Now we're going to work on the proper handling of the Dutch. You know that nice marked Dutch you've been waiting to take to a show only to have it picked apart?! You just can't seem to make some understand that you 'roll' the bunny over to check the undercut. They seem to want to grab it so as to totally disfigure the underside of the animal, often holding it in such a manner that it actually pulls and unbalances all of the other head markings. Then they have the nerve to say 'ragged undercut', 'unbalanced or ragged cheeks' and 'too wide a blaze at bottom'! If you know of a judge's conference in your area, you may want to contact the sponsor and request that they get someone who is totally aware of the proper handling procedures of the Dutch. This will assist both the breeder and the judge at the show table and make for a much healthier attitude when showing your bunnies.

It looks like the Northwest Dutch Rabbit Club is full steam ahead with the 1989 National Dutch Show. I know that this group will do their best to make everyone feel at home and I hope that many of you are able to attend!

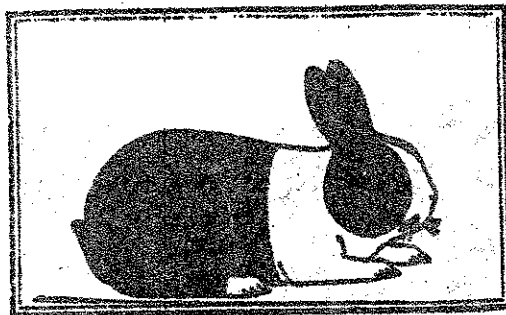

It is again time to get an article out to our Editor. Seems like only yesterday I was doing the same thing! Guess time really flies when you are having fun.

The show season has finally erupted here in the Mid-West after a long and trying winter. I have attended and judged at shows for the past 5 weekends in a row. I am extremely happy to say that there have been more Dutch shown at these shows than there was last year. Not only are the numbers up, but the quality seems to be way above par. Maybe we will get back to the numbers we had a few years ago.

I was informed that the state of New Mexico was trying to get a Bill passed to prohibit the sale of rabbits as pets. The way I understand it, this was included in the Bill which was originally intended to put a clamp on the importing of exotic birds from across the border. Since I first heard of the Bill, I have been informed that it was dropped for the present time in order to evaluate the content a little more. Thanks go out to Mini Lafoya of New Mexico for her correspondence with me regarding this.

A House Bill was also introduced here in Illinois to prevent the sale of rabbits, chicks, and ducklings that have been dyed, colored, or treated in any manner so as to artificially color them, and prevent them from being given as prizes in games of chance. I can support this Bill, with the stipulation that rabbit clubs could still use rabbits on their raffles. I have written to State Representative Mike Weaver to get a clarification regarding this.

The Seattle NDS is fast approaching. At this time, I am uncertain as to whether I will be able to attend or not, but am trying my best to make the arrangements and be able to follow them up. I am sure that the crew out there will put on a dandy show, show everyone some great hospitality, and leave everyone with a good taste in their mouth. Especially if they have that salmon at the banquet like they did in Portland. I like fish, but that was tremendous. In talking with Glen Carr, he is excited about judging the show and looking very forward to it. I am sure he will have some real nice animals to evaluate.

With some additional Dutch Specialty Clubs joining our ranks in the past few months, I expect to see more Dutch shows. I do not believe there is any better way to promote our breed, stay in touch with fellow Dutch breeders, and stiffen the competition. I wish each and every one of those clubs the best of luck, and hope that I get a chance to show with you at some time.

Remember that the Summer will be upon us before we know it. We can never start preparing for the hot weather too soon. If we do not take care of our stock, nobody will. 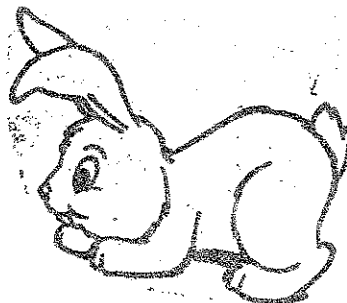

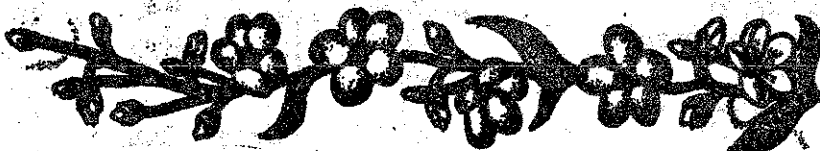

The \$50.00 for the Secretary was eliminated when the travel expense went into effect. The only time the Secretary gets \$50.00 for attending the NDS or National Convention is if the show is held within 125 miles radius of the Secretary's home, and then they do not receive any travel expense. If the show is held in the Secretary's home town, they receive nothing.

The statement was also made that wouldn't it be more fair for each officer and director to receive an equal amount? Upon close inspection of the presented resolution, there is absolutely no mention of any officer or director other than the President and Secretary receiving any reimbursement.

As I said last issue, I would like to see this resolution defeated. It will be totally up to the membership, when the resolution is finally voted on. I would request that we all do a little soul searching though, and realize the importance of the Secretary's job, the minimal amount the Secretary is now paid, and the possibility that the Secretary may not be able to attend the meetings and represent the club to their fullest capacity should this resolution be passed.

Please consider this resolution, and when the time comes vote in the manner that you believe will be best for our organization. Regardless of whom the Secretary is, I believe they deserve this travel expense.
